## **ARTICLE 4 - ENTRIES**

#### 4.1 - Closing date for entries

Saturday April 28, 2012, at 24h00.

#### 4.2 - Entry procedure

Anybody wishing to take part in the 55th Tour de Corse must send the official entry form duly completed to the Permanent Secretariat of the organisation (contact details in Art. 2.3) before the closing of entries (according to postage stamp). If this entry form is sent by fax or e-mail, the original must reach the organiser within seven days following the close of entries.

#### Entries will only be accepted if they include the following :

- the entry fee in full,

- an authorisation issued by the competitor's and Pilots' National Sporting Authority,

- a photocopy of the first page of the homologation book for the car,

- a photocopy of the international entrant's licence,
- photocopies of the international competition licences of the two crew members,
- photocopies of the driving licences of the two crew members,

-a letter of agreement from the owner for the use of his car in the event (if applicable),





- a photocopy of the car's technical passport (for French competitors),
- a photocopy of the car's registration document.

Details concerning the co-driver may be completed until administrative checks.

#### 4.3 Number of entrants accepted and Classes

#### 4.3.1 - Number of entrants

The maximum number of entrants is 70.

An entrant will only be considered as definitively accepted to take part in the rally, once he has received an official confirmation from the organiser by writing.

#### 4.3.2 - Classes of cars

Eligible vehicles are those which are homologated, at the date of scrutineering, according to the prescriptions of Appendix «J» of the International Sporting Code for :

#### 4.4.1 - Entry fees

- the entrant is supported, either financially or with technical assistance, by an IRC registered manufacturer or team, or their official representative,
- the entrant is neither the driver nor the co-driver,
- the driver is on an FIA priority list for rallies in 2012.

#### B - Amateur Entry :

With organiser's optional advertising: € 1 800 TTC (€ 1 505,02 + 19.6% VAT) Without organiser's optional advertising: € 3 800 TTC (€ 3 177,26 + 19.6% VAT)

- the entrant is one of the crew members,
- neither crew members is entered on an FIA priority list for rallies in 2012,
- the entrant receives no support from an IRC registered manufacturer or team or their official representative,
- the vehicle is not the property of an IRC registered manufacturer or team or their official representative.

Transfer fees are charged to the sender.

The proof of settlement should be sent to the Secretariat of the rally before the closing date of entries.

#### 4.6 - Refund

Entry fees will be refunded :

- a) 100% to entrants whose entry has not been accepted,
- b) 100% in case the 55th Tour de Corse does not take place,
- c) 50% in case the competitor where unable to start the rally and has declared it in writing to the organiser before the entries closure time,
- d) in all other cases, entry fees will not be refunded.





## **ARTICLE 5 – INSURANCE**

Entry fees include the insurance premium which guarantees competitors' cover for liability to third parties. The insurance will become effective from the start of the administrative checks and will continue until the end of the rally or at the moment of permanent retirement or exclusion.

In accordance with the general prescriptions governing sporting events and competitions on the public road in France, the organizing committee will take out an accident insurance policy with an approved company.

The general conditions of this policy will notably stipulate that the guarantee will grant up to six millions one hundred thousand euros ( $\leq 6.100.000$ ) per accident involving bodily injury, and up to five hundred thousand Euros ( $\leq 500.000$ ) per accident involving damage to private property.

In case of an accident, the laws of the country where the rally takes place must be respected as follows :

- Material damage in road accident : Interministerial Circular No. 7094 of 17/02/1970.

- Fatal accident : Art. R.235.2 Code of the Road, Decree No. 2003-293 of 31/03/2003.

- Obligation to assist victims of road accident : Ministerial Circular INT.N  $^\circ$  68/390 of 16/08/1968.

- Traffic Accident involving a foreign driver in international traffic : Circular No. 4900 DEF/Gend.of 29/02/1983.

In case of an **accident**, competitors or their representative must report the incident in writing to the Organiser within 3 days at the latest.

In case **a recovery service** is used either in a special stage or on a road section, expenses will be incurred by the competitor.

In case of **the withdraw or exclusion** of a competitor during the rally, the guarantee will cease automatically at the moment of the withdraw or exclusion, unless the withdraw or exclusion occur during a special stage, in which case the guarantee will cease at the end of that stage.

Even though they may display an "Assistance", "Auxiliaire" or any other sticker displayed by the organiser, **service vehicles** can in no circumstances be considered as officially taking part to the rally. They are not covered by the organiser's insurance and remain the sole responsibility of their owners. This also applies to vehicles used by competitors for **reconnaissance** purposes, even if they are registered and numbered or bear identification associating them with the rally.





## **ARTICLE 6 - ADVERTISING AND IDENTIFICATION**

#### 6.1 - Advertising

#### 6.1.1 - Restrictions

Any propaganda or advertising, whether direct or indirect, for tobacco/alcohol or for products related to tobacco/alcohol, as well as any free distribution of samples, is strictly forbidden (Art. 2 Law n° 91-32 of 10/01/1991, relating to the fight against nicotine and alcohol addiction).

#### 6.1.2 - IRC advertising

IRC advertising will be affixed on all cars on the following spaces as described below (See SR Appendix IV) :

#### - a stripe on the front windscreen,

- a stripe on the rear windscreen,

- on the two side mirrors,
- on both rear and front bumpers.

#### 6.1.3 - Organiser's advertising

a) Compulsory advertising : will be communicated by a bulletin before closing date for entries.

b) Optional advertising : will be communicated by a bulletin.

#### 6.2 - Competition numbers

**6.2.1** - The organiser will provide all competitors with the competition numbers and rally plates in conformity with FIA-RRCSR Art. 11. These numbers and plates must be affixed on the car during the whole rally.

Failure to comply with any regulations concerning identification numbers will result in a cash penalty of € 200 for each infringement.

**6.2.2** - Cars must be presented to the scrutineering with the rally plates, competition numbers, compulsory advertising and optional advertising (if applicable) affixed.

Presentation of the car : see RP Appendix IV.

#### **ARTICLE 7 - TYRES**

#### 7.1 - Tyres specified for use during the rally

During the running of the rally, the use of tyres, their replacement and checking will be in accordance with the FIA-RRCSR (Art. 50 and Appendix IV).

**7.2** - It is forbidden to change tyres between service parks unless there are spare tyres on board. This change has to be done by the driver and/or co-driver.

**7.3** - Tyres are free between the start of the leg and the first service park and between the last service park and the arrival of the leg (excepted for the arrival of leg 3).

stations on the rally route and specified in the Road-Book.





**7.4** - The use of an anti puncture (ATS or other type) is prohibited. In these areas any kind of servicing is prohibited except the refueling of the car.

**7.5 - Tyres during reconnaissances** See FIA-RRCSR Art. 20.2

#### ARTICLE 8 - FUEL

#### 8.1 - Ordering procedure

There will be no unique imposed fuel supplier.

#### 8.2 - Refueling during the rally

For environmental and safety reasons NO refueling is permitted by any competitors within the Service Park.

Competitors may only refuel in the refueling zones (RZ) or at commercial filling stations on the rally route and specified in the Road-Book.

In these areas any kind of servicing is prohibited except the refueling of the car.

#### Refueling Zones (RZ) :

The refueling must be made by the crew or by members of the team (2 persons maximum) (see FIA RRCSR Art. 49).

In this last case, it is recommended that these 2 persons are wearing complete fire-resistant approved overalls, if not, it's compulsory for them to wear clothes covering arms and legs (no shorts or T-shirts).

#### Commercial filling station specified in the Road-Book :

The refueling may be done at commercial filling stations on the rally route and specified in the Road-Book for competitors using commercial fuel.

In that case the presence of any member of the team is not allowed.

Only unleaded 95 fuel is available in commercial filling stations in Corsica (no unleaded 98 fuel).

#### **ARTICLE 9 - RECONNAISSANCE**

See also FIA-RRCSR Art. 20

9.1 - Procedure for registration

Reconnaissance documentation will be available on Sunday May 6th from 16:00 to 20:00 at ASA Bastiaise - 38 rue César Campinchi - 20200 Bastia, and on Monday May 7th from 07:00 to 11:30 at the Tourism Office on the Macinaggio Port.

All drivers will receive a specific "Reconnaissance" sticker and a reconnaissance control card.

The sticker must be affixed on the top middle part of the windscreen of the reconnaissance vehicle.

The reconnaissance control card must be presented fo the marshall (identifiable by a tabard) at each stage start in order to gain access to the special stage. <u>On completion of reconnaissance, this reconnaissance control card must</u>





<u>be returned to the Rally HQ at Palais des Congrès of Ajaccio before 20:00,</u> Wednesday May 9th.

#### 9.2 - Programme

Reconnaissance will take place on Monday May 7th and Tuesday 8th in accordance with schedule specified in RP - Appendix II. Competitors will be allowed to run this reconnaissance in the order of their

Competitors will be allowed to run this reconnaissance in the order of their choice while respecting the schedule. Under no circumstance special stages may be run in the opposite direction to rally traffic.

All reconnaissance apart from this period are forbidden.

A maximun of two passages through each stage are authorized.

When a stage is used twice or more it shall be considered as one stage for the purposes of reconnaissance.

'Any Crew offender will not be allowed to take part to the rally.

#### 9.3 - Restrictions

For all crews, reconnaissance is only authorized in cars that conform with FIA-RRCSR Art. 20.

It is emphasized that reconnaissance takes place on roads opened to ordinary traffic. Reconnaissance is not practice :

- all road traffic laws are to be fully respected, at all times,

- the safety and rights of other road users must be respected,

- reconnaissance cars have to be covered by insurance as required by the law, no responsability being impu¬table to the organisers in case of accident, Any infringment of the traffic rules and reconnaissance regulation will be transmitted to the Stewards of the meeting who will take all necessary decision up to exclusion of the competitor.

#### 9.4 - Participation in reconnaissance only

Any driver who would like to take part in reconnaissance only must be registrated with the organiser and pay a fee of  $\notin$  500 ( $\notin$  418,06+ 19.6 % VAT). The regulations regarding reconnaissance must be respected in their entirety.

#### **ARTICLE 10 – ADMINISTRATIVE CHECKS**

#### 10.1 - Documents to be presented

- competitor entrant's licence,

- drivers' and codrivers' driving licences and competition international licences,

- drivers' and codrivers' passport or national identity document,

- competitor, driver and co-driver's ASN authorisation to participate in the rally,
- rally car's registration document,
- rally car's insurance document,
- rally car's homologation form,
- rally car's technical passport (for French competitors)

- a letter of agreement from the owner for the use of his car in the event (if applicable),

All competitors must have completed their administrative checks before their car is brought to scrutineering.

## ARTICLE 11 – SCRUTINEERING, SEALING AND MARKING

**11.1 - Scrutineering** will be held on Tuesday May 8th from 18:15 to 20:15 and Wednesday May 9th from 08:45 to 12:45 at Palais des Congrès parking at Ajaccio, by notification.

#### 11.2 - Markings and sealings

Following FIA-RRCSR Art. 51.3 (transmissions), FIA priority drivers and IRC drivers will have their parts limited and marked, at the discretion of the Clerk of the Course.

Marking and sealings will be done at service park - Napoléon Bonaparte airport - Campo Dell'Oro, on Tuesday May 8th from 18:15 to 20:15 or Wednesday 9th May from 08:45 to 09:45, by appointment.

#### 11.3 - Identification

Cars must be presented to the scrutineers with the rally plates, competition numbers, IRC advertising and optional advertising affixed (see SR Appendix IV). Cars which do not comply with this rule will not be scrutineered.

#### 11.4 - Mud flaps

The use of mud flaps is permitted but not compulsory in conformity with Art. 252.7.7 of Appendix J of the FIA Sporting Code.

#### 11.5 - Windows

The use of silvered or tinted films is permitted in compliance with Art. 253.11 of Appendix J of the FIA Sporting Code.

#### 11.6 - Drivers' safety equipment

All items of clothing including helmets and Hans intended to be used must be produced at scrutineering. Compliance with Appendix L Chapter III will be checked. (see SR Appendix V).

#### 11.7 - Special requirements

Each competing car must be equipped with a reflective triangle and two fluorescent jackets.

Two belt cutters must be carried on board at all times. They must be easily accessible for the driver and co-driver when seated with their harnesses belt fastened (Art. 253.6 Appendix J).





#### 11.8 - Weight

The weight of the car must never be less than the regulation minimum (with or without the on-board camera).

## **ARTICLE 12 - OTHER PROCEDURES**

#### 12.1 - Ceremonial start procedure and start order 12.1.1 - Ceremonial start

The Ceremonial start of the 55th Tour de Corse will take place on Wednesday May 9th at 21:00 at the Place d'Austerlitz (called Place du Casone) at Ajaccio. Procedure will be provided in Rally Guide.

#### 12.1.2 - Start Parc Fermé

After the ceremonial start, competitors are free to enter their car into Parc Fermé - Parking du Palais des Congrès - Ajaccio on Wednesday May 9th from 21:00 to 23:00. Otherwise, they have to enter their car in Parc Fermé on Thursday 10th From 12:00 to 13:00 by notification.

Any car entrance in the Parc Fermé is definitive.

#### 12.1.3 - Start order

For the 1st Leg: the starting order will be in numerical order every one minute, except the first 10 competitors who will leave every two minutes.

**For 2nd and 3rd Legs :** the starting order will be in reverse order of the classification at the finish of the final special stage of the previous leg, every two minutes for the first 10 competitors. All other competitors will start in order of the classification at the finish of the final special stage of the previous leg, every one minute.

However, any change at the discretion of the clerk of the course and in agreement with the IRC promoter will be indicated in a bulletin.

#### 12.2 - Time card change during the rally

Time cards will be issued at the start of each leg (TC 0, TC 3B & TC 8D) and changed at the start of each section (TC 4B, TC 5B, TC 7B, TC 10B, et TC 12B).

#### 12.3 - Early check-in

Early check-in is authorized without incurring any penalty at following TC : TC 3A, TC 8C and TC14A.

#### 12.4 - Official time

Troughout the rally, the official time will be the UTC + local offset.





#### 12.5 - Special Stage start system

Special Stage starts will use an electronic countdown system synchronised with a starting lights system.

This countdown system, counting down by seconds, is clearly visible to the crew from the start position.

The clock of starting system shows the time under analogical form.

The disk is RED between starts and it becomes YELLOW 5 seconds before the ideal starting time.

5 x «BEEPS» for the last 5 seconds with a high pitched "BEEP" for the start.

This system will be coupled to the jump start detection device, which is 40 cm in front of the starting line, this system records any situation in which a car leaves the starting line before the correct signal.

#### 12.6 - Accident and safety procedure

## All competitors must be fully conversant with FIA-RRCSR Art. 33 & 34 & Annexe III § 5.5.4.2.& 5.5.4.3 giving the details of accident and safety procedure.

These procedures are also in the road-book.

#### 12.7 - Service Parks

There will be 4 Service Parks : (see road-book for GPS points) Opening times :

Service will be made into the Service Parks. Servicing outside these zones is forbidden.

According to FIA-RRCSR Art. 40, 41 et 42.

Only two service vehicles and one auxiliary car per competitor will be authorised in the Service Parks. These vehicles must have the «ASSISTANCE» or «AUXILIAIRE» stickers affixed on the windscreen. They must imperatively be parked in the allocated surface of each competitor. Any breach of this rule will be fined with € 500 TTC.

Crews having the same service should indicate it during their inscription.





<u>Allocated surfaces in Service Parks :</u> IRC Registered Manufacturer : 200 m<sup>2</sup>

Manufacturer Supported Entry / Other Legal Entity / FIA Priority Entry :

150 m<sup>2</sup> for one entered car. 50 m<sup>2</sup> for each additional car.

Amateur Entry :

80 m<sup>2</sup> per entered car.

Any competitor wishing to have an additional surface will necessarily make the request before the close of entries. The additional m<sup>2</sup> will be allocated depending on options and IRC terms of reference, and charged at the rate of  $\notin$  12 TTC per m<sup>2</sup> ( $\notin$  10,03 + 19,6% VAT).

#### <u>Cleanliness and safety of your stand</u>

**Each competitor is responsible** for the behavior of its service team members. In the service park, all competitors must :

- keep near to any racing car **a fire extinguisher for A, B and C type fires of a minimum capacity of 5 kg**, having been checked within the last 2 years.

- place under each racing car a waterproof and resistant to hydrocarbons ground sheet of a surface equal to that of the car (3 m x 5 m minimum).

- take care of his waste removal when his team leaves the parks at the latest; failure to comply will result in a cash penalty of € 500 TTC.

The penalty for extinguisher or ground sheet failure in the parks is € 200 TTC.

Waste water emptying, car wash and staking out on the ground are forbidden in the Service Parks.

The Organising Committee thanks you in advance for your understanding of our marshalls who do their best to make sure that the rally takes place in good conditions and to make sure that everyone respects not only the regulation but everybody else as well.

The Officials of the rally will verify the proper compliance with these requirements and any infringement will be submitted to the Stewards who will determine the penalty to apply.

#### Speed in Service Parks

The speed in the service parks may not exceed 30 km/h. Failure to comply with this limit shall result in a penalty applied by the Stewards.





#### 12.8 - Retirement

In case of retirement, the competitor must notify the Clerk of the Course as quickly as possible by using the phone number indicated on the Rally Guide and on the Road-Book.

When the sweeping car reaches them, the crew must specify if they need a tow vehicle.

Any infringement will be submitted to the Stewards of the Meeting who will determine the sanction to be applied.

#### 12.9 - Breakdown services

Breakdown services, towing or taking a car away in a SS will only be authorized, at the discretion of the Clerk of the Course, after the last passage on this SS and only after the sweeping car has gone through.

IMPORTANT : All breakdown services used in a SS or on road section are at the cost of the competitor, even if that breakdown service is done with organisation's material.

#### 12.10 - Finish Procedure

The rally ends at TC 14A.

After the podium procedure, competitors must immediately drive their cars to the final Parc Fermé, excepted those who must go first to the final scrutineering.

A pass to authorize collection of the car when the final Parc Fermé is opened will be handed to each competitor whose car enter Parc Fermé.

Cars will only be authorized to leave final Parc Fermé once the Parc Fermé has been declared open, following publication of the final official classification and upon presentation of the pass handed to the competitor on arrival at Parc Ferme.

One hour after the publication of the final official classification, the Parc Fermé will be opened to the public and the Organiser will no longer be responsible for the cars.

#### 12.11 - Traffic infringments

The following fines will be applied by the Clerk of the Course in case of a speeding offence traffic infringement after the start of the Rally :

- **1st infringement** : € 160 fine.
- **2nd infringement :** 5 minutes penalty
- 3rd infringement : exclusion.

The fine is levied as per the Regulations and the amount of the fine is unaltered by any fine that may or may not be levied by the Police.

Additional penalties may be inflicted by the Stéwards in case of a serious offence.

#### 12.12 - Shakedown

An optional and free of charge shakedown is proposed to competitors Wednesday 9 May from 14:00 to 17:00 for FIA priority drivers, Team supported drivers and drivers from Legal Entities entry, and from 15:00 to 17:00 to all other drivers.

The shakedown il located on D111B / D11B - Capo di Feno - St Antoine. All special stages regulations will be in application during shakedown.

## **ARTICLE 15 - FINAL CHECKS AND PROTESTS**

#### 15.1 - Final scrutineering

The competitors who should present their cars to the final technical scruti-neering will be escorted by organisers from the Place St Nicolas to the Sarl Ginanni Renault - 35 rue César Campinchi - Bastia on Saturday May 12th, at 20:30.





#### 15.2 - Protest fees

Only competitors or their representative duly designated in writing have the right to protest.

All protests must be lodged in writing and handed to the Clerk of the Course, or a Deputy Clerk of the Course or to one of the Stewards of the rally together with a protest fee of  $\notin$  690 (cheque to the Asacc Tour de Corse). The protest fee will not be returned if the protest is judged unfounded.

If the protest requires the dismantling and the re-assembly of different parts of a car, the claimant must pay an additional deposit which will be determined by the Stewards of the meeting.

The expenses incurred by the work and by the transport of the car shall be borne by the claimant if the protest is unfounded, or by the competitor against whom the protest is lodged if the claim is founded. If the protest is unfounded, and the expenses incurred by the protest (scrutineering, transport, etc.) are higher than the amount of the deposit, the difference shall be borne by the claimant. Conversely, if the expenses are less, the difference shall be refunded to the claimant.
