If this entry form is sent by fax or e-mail, the original must reach the organisers within seven days following the close of entries.

Manufacturers and WRC Teams registered for the FIA WRC as well as entrants in the WRC 2 and WRC 3 Championships may make their entry using the standard entry form provided by FIA.

However, due to French legislation, the additional information regarding the place of birth for First Driver and Co-driver is required.

Entries will only be accepted if they include the following:

- the entry fee in full,
- for foreign drivers: an authorisation issued by their ASN
- a photocopy of the first page of the car's homologation form,
- a photocopy of the entrant's license,
- photocopies of the competition licenses of the two crew members,
- photocopies of the driving licenses of the two crew members,
- a photocopy of the car's technical passport,
- a photocopy of the title of ownership of the car.

5 INSURANCE

In accordance with the general prescriptions governing sporting events and competitions on the public roads in France, the Organiser will take out an insurance policy with an approved company.

The general conditions of this policy will notably stipulate the guarantee granted per accident involving bodily injury and per accident involving damage to private property in accordance with the general legal prescriptions and regulations.

Entry fees include the insurance premium which guarantees competitors' cover for liability to third parties (all physical injury and damage to property) to a limit of 15.550.800 € per incident.

The above competitor insurance will become effective from the start of the technical scrutineering to the end of the rally (1) for those competitors finishing the rally. In case of retirement or exclusion, the cover will cease when the car arrives at the Service Park using the rally route (but without exceeding the time of the end of the rally).

(1) "end of the rally" = opening of the Parc Fermé after the publication of the final official classification.

Moreover, in case of an accident, competitors or their representative must report the incident in writing to the Organiser within three days at the latest. In case a recovery service is used either on a special stage or on a road section, expenses will be incurred by the competitor.

Service and/or auxiliary vehicles, « route note cars », « weather » vehicles and vehicles used by competitors for reconnaissance purposes are not considered as officially taking part in the Rally even if they have registered with or bear identification associating them with the Rally. They are not covered by the Organiser's insurance policy and remain the sole responsibility of their owners.







































6 ADVERTISING AND IDENTIFICATION

6/1 Advertising

6/1/1 Restrictions

Competitors are allowed to affix any kind of advertising to their cars, in respect of FIA-WRC Art. 18.7.1.

All publicity or advertising, whether direct or indirect, for tobacco/alcohol, or for products related to tobacco/alcohol, as well as any free distribution of samples is forbidden (Article 2, Law N°91-32 dated January 10, 1991, relating to the fight against nicotine and alcohol addiction).

6/1/2 Organiser's advertising

- a) Mandatory advertising on rally plates and competition numbers: Crédit Mutuel.
- b) Optional advertising: there will be no optional advertising.

6/2 Competition numbers

The Organiser will provide each crew with competition numbers and with rally plates in compliance with FIA-WRC Art. 18. Rally plates and competition numbers must be affixed to the cars for the whole duration of the competition.

Competitors should note that FIA-WRC Art. 19.1 require that the name of both crew members be shown on the rear side windows.

Following the requirement of the French traffic rules regarding the identification of the rally cars (decret n°2012-312 from 5/03/2012 which modifies the article R.411-29 of French traffic rules and the laws of 14 & 28/03/2012) identification of all rally cars will be by two numbers (210mm x 140mm) to be fixed at the front and the rear of the car as supplied by the organizer of the rally.

The identification number is the same as the competitor N° for the rally. It is valid only during the rally and on the rally itinerary.

These two numbers must be used in place of the usual registration plates which must be removed or concealed.

Above rule applies also to foreign registered rally cars

See Appendix IV of these Supplementary Regulations.

Failure to comply with this regulation will result in a penalty of € 160 for the first observation, and € 320 in case of recurrence violation.

Competitors must present their cars to scrutineering with rally plates, competition number and mandatory and optional advertising, where applicable, applied to the car.

It is a condition of supply that payment must be received in full at least Wednesday September 25 before delivery can be made.

The balance for any unused fuel will be cleared after the rally.

8/2 Distribution during the rally

The fuel collection times for all crews using FIA Fuel will be given in Rally Guide 2.

All competitors using FIA fuel and re-starting on Saturday after retirement during Friday are reminded that there is no refuel zone at the exit of Service E.

If needed, such competitors must contact Vital Equipment Ltd before its scheduled closing time.



















































Non-priority drivers may use either:

- FIA fuel following the same conditions and rules as the priority drivers.
- or commercially available pump fuel; this fuel must be dispensed directly into the competing car from pumps at filling stations which are marked in the road-book.

FIA-WRC Art. 14.2 - Non priority drivers using commercially available pump fuel are permitted to deviate from the route in order to access the fuel stations detailed in the roadbook. Details of the fuel quality available at these various fuel stations will be given in Rally Guide 2.

9 RECONNAISSANCE

See also FIA-WRC Art. 25

9/1 Procedure for registration

All crews taking part in reconnaissance must complete the registration form (website) and return it to the Rally Office, following the procedure specified on the form.

They must register at Administrative Checks on Monday, September 30, from 14:00 to 21:00 by appointment (*) in order to obtain the necessary materials.

(*) by arrangement for Manufacturers & WRC Teams.

Each crew will be given 'Reconnaissance' stickers, as well as a specific reconnaissance control card.

The stickers are to be affixed on reconnaissance car on the windscreen, rear side windows and rear window.

The control card must be shown and endorsed by the marshals (identifiable by a tabard) at each stage start (in order to gain access to the special stage or shakedown) and at the Stop point

On completion of reconnaissance, this reconnaissance control card, must be returned to the Rally Office (Zénith) no later than 10:00, Thursday, October 3.

9/2 Restrictions

9/2/1 Reconnaissance will take place on Tuesday, October 1 and Wednesday, October 2, in accordance with the schedule specified in Appendix II.

The "reconnaissance routes" showed on Reconnaissance Maps in the road-book to go back from the finish to the start of the special stages are recommended, not compulsory.

Reconnaissance for SSS 1 will be carried out on Thursday, October 3 from 13:30 to 15:30, with electric cars provided by the organizer. This will be according to individual timing which will be published on Wednesday, October 2 by means of a communication.





































9/2/2 Each crew is limited to two passages on each special stage, including shakedown. Special Stages run twice are considered to be one special stage as far as reconnaissance is concerned.

Clarifications for Shakedown and SSS:

Shakedown: 2 passages of the complete stage.

Distance 3,80 km each passage.

SSS 1: 1 passage only of the complete stage

Distance 4,55 km.

SSS 14: 2 "shortest route" passages

Distance 3.09 km each passage (2.86 + 0.23)

SSS 17/20 2 "shortest route" passages

Distance 3.87 km each passage (3.60 + 0.27)

9/2/3 The speed limit during the reconnaissance of special stages is 90 kph, except where road signs specify a lower speed limit.

The speed limit in built-up areas is 50 kph, except where road signs specify a lower speed limit.

Excessive speed during reconnaissance will incur a fine applied by the Clerk of the Course (FIA-WRC Art. 20.2).

9/2/4 It must be remembered that reconnaissance takes place on roads that are open to normal traffic. Given that reconnaissance is not testing:

- local traffic regulations must be complied with in full at all times,
- the safety and rights of other road users must be respected at all times,
- reconnaissance cars must be covered by an insurance policy in accordance with the law. In no circumstances can the Organiser be held liable in the case of an accident.

9/2/5 Under no circumstances may a crew drive in the special stages in the opposite direction of the rally, unless specific instructions to do so have been given by officials.

Competitors may enter a special stage only via the start and must exit via the finish.

9/2/6 Junior WRC competitors are not permitted to recce SSS 17/20 (Haguenau).

9/3 Chicanes

The chicanes mentioned in the road-book will not be set up during reconnaissance. Their positions will however be marked on the ground and indicated with a triangular red board "! chicane".





































9/4 Location of collection of speed control checking devices

Priority drivers, all competitors entered with cars of WRC class and other crews selected by the FIA must be equipped with a speed control device (GPS tracker system) to their cars during reconnaissance.

9/5 Participation in reconnaissance only

As mentioned in FIA-WRC Art. 25.5, any driver wishing to take part in reconnaissance only will have to pay an entry fee of €1,000.

The organisers must receive the participation request form by Tuesday, September 3 (23:59). Forms will be available on the www.rallyedefrance.com.

- valid competitor entrant's license,
- valid drivers' and co-drivers' competition and driving licenses,
- drivers' and co-drivers' passport or identification,

- title of ownership of the car,
- a letter of the rally car's owner authorising the driver to drive the vehicle during the event, when the driver is not the owner of the car.

Competitors must complete administrative checks before presenting their car at scrutineering.

11 SCRUTINEERING, SEALING AND MARKING

- a) Cars may be presented at scrutineering by a representative of the team.
- b) All competing cars must have their sump guards removed for sealing of gearboxes and differentials, and be kept with the car for the purpose of weighing.
- c) All competing cars (except Manufacturers cars) must have a drilled hole of at least 2 mm diameter at a visible position on the engine block (when the bonnet is opened), for a sealing wire to pass through it.
- d) Crew must show the car's complete certified FIA homologation form for the model of the car presented.
- e) Manufacturers or championship-registered WRC Teams may present a signed Certificate of Technical Conformity
- f) Scrutineers may require the car to be identified. The chassis and cylinder block may be marked.
- g) Non-priority drivers: the transmission (fitted and spares) will not be sealed; however the turbos (1 fitted and 1 spare) will be sealed; for limitation of spare turbochargers see the FIA-WRC (FIA WRC Sporting Regulations). The engine block will be sealed.
 - Non-priority drivers refueling at commercial fuel filling stations (see SR Art. 8.2) and whose cars are equipped solely with FIA specified refuel couplings must transport the adaptator in the car and show it at pre-event scrutineering.
- h) On board camera (see SR Art. 12.13): The fixing of camera and camera recorder must be able to withstand a deceleration of 25 g.
- i) On completion of scrutineering, if a car is found not to comply with the technical and/or safety regulations, the Stewards may set a deadline before which the car must be made to comply, or may refuse the start.

11/2 Mud flaps

The use of transverse mud flaps is permitted but not compulsory in conformity with Art. 252.7.7 of Appendix J of the FIA Sporting Code.

11/3 Drivers' safety equipment

All items of clothing including helmets and FHR (frontal head restraint) intended to be used must be produced at scrutineering. Compliance with Appendix L Chapter III will be checked. (See Appendix V of present Supplementary Regulations).

11/4 Noise level

The maximum noise level is 103 db at 3,500 rpm for petrol engines and at 2,500 rpm for diesel engines.

11/5 Special requirements

Each competing car must be equipped with a reflective triangle and two fluorescent jackets. Two belt cutters must be carried on board at all times. They must be easily accessible for the driver and co-driver when seated with their harnesses belts fastened (Art. 253.6.1 Appendix J).

11/6 Installation of Safety Tracking System

Competitors must have installed the FIA Safety Rally Tracking System in rally cars before the car is brought to scrutineering. The system will be checked during scrutineering. Installation instructions will be provided in Rally Guide 2.

Systems may be collected either by the crew or a representative.

A 1200€ fully refundable credit card deposit will be collected by SIT from each competitor for the tracking-safety boxes. This will be done with a swipe machine and at the end of the rally the slip will be destroyed when competitors return the equipment in good condition. Safety Tracking Systems and transponders have to be removed from the cars during the last service (service I).

12 OTHER PROCEDURES

12/1 Start procedure

There will be no ceremonial start.

The official start of the rally will be at TC0.

Before TC 0 there will be a Start Park under the rules of Parc Fermé.

Cars must enter the Start Park between 13:00 and 15:30.A team representative may deliver the car.

Any crew arriving late at the Start Park will incur a cash penalty of 250 €.

Further information will be provided in Rally Guide 2.









































12/2 Start order

The start order will be established in accordance with FIA-WRC Art. 45, except for Section 1 (see SR Art.12/6/1).

12/3 Permitted early check-in

Crews are authorised to check-in early at TC 1C, 7C, 14C and 20C without incurring any penalty.

12/4 Time Controls

Cars may be driven and checked-in at TC 7B, 7C, 14B and 14C by the crew, a member of the crew or a team member, respecting all the formalities of time card presentation and related penalties.

TC7C - Flexi Service OUT - Parc Fermé IN:

The distance (about 500 m) between TC7C, RZ 5 and Parc Fermé IN will be considered as Parc Fermé and run under Parc Fermé rules.

Nonetheless, refueling of those competitors using only FIA fuel (and Junior WRC) is permitted at RZ5.

12/5 Special Stage start system

The Special Stage starts system will be as FIA-WRC Art. 37.2, 37.3 & App. VII.

12/6 Specific procedure for Super Special Stages (SSS 1, 14, 17 & 20)

SSS 1, 14, 17 & 20 will be run under Super Special Stage regulations (FIA-WRC Art. 41).

12/6/1 SSS 1 (Power Stage)

With reference to FIA-WRC Art. 13.3, SSS 1 "Strasbourg" will be run as the Power Stage.

The start order of SSS 1 will be in reverse order of FIA-WRC Art. 45.3. Nevertheless, the organisers reserve the right to adapt this order on grounds of public interest.

SSS 1 takes the form of a loop to be completed 3 times, as outlined in the road book (3 complete loops). The total distance of SSS 1 is 4,55 km.

The start will be given in heats composed from 2 to 4 cars. The cars will come to the start line as directed by marshals. The start intervals between these cars will be approximately 20 seconds for heats composed of 3 or 4 cars, or 30 seconds for heats composed of 2 cars.









































timekeepers on-site must be respected.

The start procedure for each car will be as follows: the marshal will count down aloud 10" and the last 5" one by one. The cars on the second, third and fourth start rows must move up respectively to the positions vacated by the car in front. The instructions by the marshals /

The Power Stage will be timed to the elapsed millisecond. However, the results will show only tenths of a second.

The actual starting time (hour, minute, second and tenth of second) recorded on the starting line by photocell will be entered on the time card at the SSS Stop Point.

Only the hour and minutes of the start time will be taken in consideration to calculate a competitor's due time at TC1A.

The maximum time allowed to complete SSS 1 will be 7 minutes. Any crew which fails to complete SSS 1 within this maximum time or having checked-in at TC 1 and does not start SSS 1 will incur the penalties laid down in FIA-WRC Art. 46.2.

A competitor who crosses the finish line after completing too few or too many laps will be considered to have not finished the stage and will receive a penalty as FIA-WRC Art. 46.2.2; any such competitor will however be allowed to continue the rally.

If the running of SSS 1 is interrupted, this will be signaled to the drivers by showing yellow flags. When given this signal, the driver must immediately reduce speed and follow instructions of any marshals or other officials. Failure to comply with this rule will entail a penalty at the discretion of the Stewards.

The procedure as in FIA-WRC Art. 39 will apply.

12/6/2 SSS 14, 17 & 20

The start procedure for SSS 14, 17 & 20 will be identical to that of other SS (FIA-WRC Art. 37.2). The start order of SSS 14, 17 & 20 will be identical to that of other SS of the day.

SSS 14 takes the form of a loop to be completed 3 times, as outlined in the road book (2 complete loops + 3/4 of a 3rd loop). The total distance of SSS 14 is 4,65 km.

SSS 17 & 20 takes the form of a loop to be completed 3 times, as outlined in the road book (2 complete loops + 3/4 of a 3rd loop). The total distance of SSS 17/20 is 5.74 km.

A competitor who crosses the finish line after completing too few or too many laps will be considered not to have finished the SSS and will receive the FIA-WRC Art. 46.2.2 penalty; such competitor will however be allowed to continue the rally.

12/7 Official time

Throughout the rally, the official time will be UTC + local offset.

SUPPLEMENTARY REGULATIONS

12/8 Service Park

The emptying of waste water, the washing of cars and the driving of stakes into the ground is not permitted in the Service Park. All infringements will be reported to the Stewards who may apply penalties.

Dismantling:

For safety reasons, dismantling competitors' service structures in the service park is not permitted before 6.30 p.m. on Sunday, 6th October, after the public has cleared the service

Any team which breaks this rule will be fined 500 €.

In case of retirement during the rally, the team concerned must firstly obtain a dismantling authorization from the Service Park Coordinator.

12/9 Car wash

An official car wash facility will be available before TC 1A, 4A, 7A, 14A and 20A.

12/10 Remote Service Zone

The length of service vehicles permitted into this zone is limited to 7 meters maximum.

12/11 Light-fitting zone

A light-fitting zone will be introduced on the liaison between SS13 and TC13A. This zone will be located in the Parc des Expositions of Colmar and will be detailed in the road-book.

One service/auxiliary vehicle per competitor may visit the adjacent parking area, in order to transport the equipment necessary for the installation.

After having reported to the scrutineers present at the area, one mechanic per car may enter the zone to assist the drivers in the installation of the lights. No work other than fitting of auxiliary lights to the car is permitted in this zone. Only tools and equipment directly involved in the installation of these auxiliary lights may be brought in the zone.

12/12 Mulhouse Regroup

FIA-WRC Art. 42.5.2 will not apply at Mulhouse regroup The adjustment of tyre pressures by the crew is permitted.

12/13 On board cameras

As FIA-WRC Art. 65.1 the entrant of any car which carries an on-board camera must have the prior agreement of the Promoter.

Authorised cameras will be identified by an adhesive decal and must be mounted in the car at the time of scrutineering.

Competitors wishing to use a camera must supply the following information to the Promoter (rally@thesportsman.de) at least one week before the start of reconnaissance: entrant name, car number, entrant address and intended use of footage.

Fixing: see SR Art. 11 h).







































12/14 Route Note Cars

Route note cars will be permitted as in FIA-WRC Art. 11.4, except for SSS1 where they are not permitted.

SR Art. 9/2/3 applies also to route opening cars.

Route note cars are allowed to enter the stages up to 75' before the first rally car. However the set-up of chicanes, installations which protect or define road-side or any other safety arrangemenets or warning cannot be guaranteed to be in place before 120' prior to the first rally car.

It is strictly forbidden for route note cars to interfere in any way with installations which protect or define the road-side or any other safety arrangements or warnings. Any contravention will result in confiscation of Route Note car plates.

12/15 Re-start after retirement / Rally 2

FIA-WRC Art. 46 & 47 will apply.

The Time Card for the Section in which the crew retired must be submitted to the sweeper car or to a marshall at an official control.

Junior WRC:

FIA-WRC Art.46.1.4: any crew which has retired from a Section on the Saturday will not be classified.

FIA-WRC Art.46.2.3: the time penalty will be added to the fastest time achieved by a Junior WRC crew.

Shakedown:

Where a crew in its competing car is unable to start Section 1 due to an accident during shakedown, they may start the rally from the Section 2 provided they notify the Clerk of the Course in writing before 15:00 on Thursday 3 October.

In such case, the following FIA-WRC Art. will apply: Art. 46.2.2, 46.2.3, 47.1.2 (*) & 47.2 (*) art .47.1.2 will apply also to all priority crews.

12/16 Finish Procedure & final Parc Ferme

The rally ends at TC 20C (TC 14C for Junior WRC).

The finish procedure planned to be followed will be published in a bulletin.

After driving over the podium, competing cars must go in convoy to the final Parc Ferme, with the exception of those cars nominated to firstly attend scrutineering.

A pass to authorize collection of the car when the final Parc Ferme is opened will be handed to all competitors whose cars enter Parc Ferme.

Further information concerning the podium procedure will be provided in Rally Guide 2.

Cars will only be authorised to leave final Parc Ferme once the Parc Ferme has been declared open, following publication of the final official classification and upon presentation of the pass handed to the competitor on arrival at Parc Ferme.





































One hour after the publication of the final official classification, the Parc Ferme will be opened to the public and the Organiser will no longer be responsible for the cars.

Junior WRC winner's ceremony:

After arrival at TC 14C the winning crew and car is required to proceed to the Junior WRC village in the service park for a winner's ceremony, accompanied by an official. It will be escorted back by the official to the final Parc Ferme or to the final scrutineering, as appropriate. The officials' instructions on-site must be respected.

15/3 Appeal fees
