## DECLARATION OF INDEMNITY

The undersigned competitor declares for himself and for his (1st and 2nd) holders to have full knowledge and to be informed about the International Sports Code, the National Sports Regulations (and its Supplementary Rules), the Special Race Regulation, every information memos and releases issued by the Organizer and / or the Race Director, to accept them unreservedly and to comply with all the requirements contained therein. The undersigned, competitor and holders, declare to possess the preparation and expertise required to attend the special stages of the kind to which the following entry refers, to have administrative, sporting and health documentation, including in relation to doping, legit and valid and that the car is suitable, in proper and perfect safety conditions in order to face the race. The undersigned declare to be informed perfectly about the difficulties the Rally entails and the risks that may arise from the participation; to know perfectly the race course, and to be aware of pitfalls (including holes and stones), and of the inherent difficulties of the route, knowing that the roads used in the challenge haven't race pavements, and which are not mountain and / or hill roads suitable for speed, according to the road traffic rules, they accept this full responsibility, and they exonerate from liability the Organizing Committee and all Race Officers. They also declare that the Organizing Committee, the Organizer Company, FIA, EUROSPORT, ACI, ACI Sport, the owner company of the roads and squares, the Clerk of the Course, Special Stages Preparation Delegate, every Race Officers, all person involved in the organization, and the organizational staff, shall be exonerated from liability for any damage that may arise from the race, caused from the competitor, its holders, its employees or property, or caused to third parties or property by the competitor, its conductors and its employees. Concerning the reports relating to the participation to the race, the undersigned competitor and holders acknowledge that the personal data contained in this application will be processed for the competition purpose only, therefore they authorize the Organizer, under the Law 196/03, to deal, to communicate and to release these data, declaring to be aware of the rights recognized by the articles of this Law. The Competitor also declares that the holders will wear the garments and all the individual protection systems of the approved and valid ACI Sport / FIA type and also use the safety systems provided in the car, integrating them correctly and in the manner prescribed for safety From ASN and ASI. The holders also declare that they have been informed that the roads and the track used are also made of funds not suitable for competitions but suitable for normal road traffic, to have inspect them during the recon of the race course, be perfectly aware that in the streets of the Shake Down and Special Stages they can find holes, stones, sand, dirt and gravel, and that these roads do not have uniform road surface like asphalt and seamless protections like barriers, jerseys and guard-rail. The Competitor undertakes to sign this application, if it is abroad, to send the clean bill of the Federation that has released the licenses and otherwise, will not be admitted to the event and not admitted at the start of the Rally.
