4.2 Entry procedure

Those wishing to take part in ADAC Rallye Deutschland 2018 must register and fill in the electronic entry form available at https://registrations.fia.com/wrcger duly completed before the closing date for entries. For national cars of classes NAT2 and NAT4: See Appendix 9, Art. A9.3 The entry will only be accepted if accompanied by







the total amount of the entry fee. To be accepted, competitors must send a proof of payment of the entry fee by e-mail to the secretary of the event (tanja.geilhausen@rallye-deutschland.de) by the closing date of entries.

Manufacturers, WRC2 and WRC3 competitors who wish to score points shall make their entries by using the standard entry form for their championships available in the FIA application at https://registrations.fia.com.

In compliance with Article 3.9 of the 2018 FIA International Sporting Code, foreign competitors/drivers must be in possession of the approval of their own ASN which must be attached to the entry form or produced at administrative checks at the latest. With the submission of the entry form, each foreign competitor and/or driver/co-driver declares that he/she is in possession of this authorisation.

4.3 Number of competitors accepted and classes

The maximum number of competitors will be 90. If more than 90 entries are received the organiser reserves the right to decide which entries among the non-priority drivers/National cars will be accepted.

4.4.5.4 All competitors

Any competitor requiring more space and/or a different layout than indicated above must submit his/her request together with the entry form or until the entry closing date at the latest.

The organiser will try to satisfy the needs as much as possible and an additional fee of 40€ per m² will become due. After this date requests will not be accepted. The amount under 4.4.5.4 is inclusive of VAT.

4.6 Refunds

Entry fees will be refunded in full only:

- To candidates whose entry has not been accepted.
- In the case of the rally not taking place.







The organisers may refund part of the entry fee to those competitors who, for reason of "force majeure" (duly certified by their ASN), are unable to start in the rally. This must be applied for in writing giving the reason for claim including bank and account details.

5. INSURANCE / LIMITATION OF LIABILITY / COSTS FOR MEDICAL CARE / AMENDEMENTS

Insurance:

The organiser provides a third party liability insurance with the cover of €10 million lump sum for the event for personal injuries, property damage and pecuniary loss.

The insurance will come into effect at the start of the rally and will cease at the end of the rally or at the moment of withdrawal or retirement of the crew. The liability insurance for the road sections between the special stages will nevertheless only be granted subsidiary and exists only for competitors' cars which do not comply with the minimum cover prescribed in the motor vehicle liability insurance regulations for the Federal Republic of Germany.

By submitting their entries, competitors declare that a car owner's liability insurance with a minimum liability insurance cover for the vehicle to be used exists without restriction.

More details are available upon request.

A copy of a corresponding confirmation of the competitors' insurance, the international insurance card ("green card") or the pink border insurance confirmation must be submitted together with the entry form or be produced at administrative checks at latest.

Competitors are reminded that the reconnaissance is **not** covered by the above insurance and competitors must make their own arrangements.

Competitors'/drivers'/co-drivers' statements regarding the limitation of liability / Release from Claims

The participants (competitors/drivers/co-drivers) take part in the event at their own risk. They bear the responsibility under civil and criminal law for any damage caused by them. With their entries, they waive any claims or rights to pursue action for damages in connection with the event (tests/ reconnaissance of the special stages, shakedown, special stages to perform top speeds or shortest driving times, road sections) against:

- the other participants, the drivers and co-drivers of the course cars as well as their assistants, the owner and proprietors of the other cars,
- the own competitor/ the own drivers/ co-drivers (barring any other special agreements between those) and their own assistants,
- the FIA, the DMSB, the DMSB member organisations, the Deutsche Motor Sport Wirtschaftsdienst GmbH as well as their presidents, executive bodies, managing directors, secretaries general, members and full-time employees and volunteers of these organisations,
- the ADAC e.V., the ADAC SE and against the other companies affiliated or associated with the ADAC e.V. and / or ADAC SE, the ADAC Saarland SFW GmbH, the ADAC Saarland e.V. as well as all other ADAC local and regional clubs, the promoter/series organiser as well as the presidents, executive bodies, directors, managing directors, secretaries general, members and full-time employees as well as volunteers of these organisations,
- the Organiser, the Officials and Delegates, the road owners, the government agencies, the racing services and all other persons involved with the organisation of the event,
- the organisation responsible for the construction and maintenance of roads,
- the agents or other persons employed to perform an obligation on behalf of the above persons and entities. The liability waiver does not apply for damages or harm to life, body or health or any other damage resulting from the deliberate or gross negligent breach of duty by the group of persons released from liability, nor for damages resulting from the infringement of a contractual obligation committed by the group of persons released from liability. In the case of damages resulting from a slight negligent breach of duty of a contractual obligation,







the liability for property damage and pecuniary loss is restricted to the typical foreseeable damage as regards the amounts.

The exclusion from liability shall become effective for all parties concerned upon submission of the entry form to the ADAC or to the Organiser.

The waiver of liability applies to claims for any legal reason whatsoever, including but not limited to claims for damages based on contractual and non-contractual liability and to claims from tortuous liability. Implied exclusions from liability shall remain unaffected.

By submitting their entry, the competitors/ registered owner(s)/ drivers/ co-drivers acknowledge that motor vehicle insurance (motor vehicle third-party liability, Casco comprehensive/collision damage coverage) does not cover any damage or claims incurred during special stages or the shakedown. They undertake to pass this information on to the owner of the vehicle used.

If the participants are not themselves owner of the competition car, they must make sure that the limitation of liability which is part of the entry form is signed by the car owner before the event.

In the case that, notwithstanding this obligation, the above mentioned declaration was not signed by the car owner, the participants discharge all the above mentioned persons from any claim by the car owner.

With regard to claims against the other participants (competitor, driver and co-driver), their assistants, the owners and proprietors of the other cars, the own competitor, drivers, co-drivers and own assistants, this release refers to damages arising in connection with the special stage(s) on which the top speeds or the shortest driving time should be achieved and/or the associated test(s)/reconnaissance. With regard to claims against other persons or bodies, this release refers to damages arising in connection with the event as a whole.

Costs for medical care

Competitors/drivers/co-drivers acknowledge, that full costs in connection with medical care (e.g. first aid treatment and transportation) go to the expense of the patient. It is recommended to take out a policy which covers the costs if it is necessary.

Responsibility, amendments of the regulations, cancellation of the event

The organiser reserves the right to modify the present regulations if considered necessary for reasons of force majeure, safety or upon instruction of the authorities or to cancel the event or single special stages in case that extraordinary circumstances should arise, without assuming any obligations for indemnification, intention and gross negligence excluded. Any modifications will be published by official Bulletin.

6. ADVERTISING AND IDENTIFICATION

6.1 Organisers' obligatory advertising "ADAC"

6.2 Optional advertising

Eventual optional advertising will be published in a Bulletin, if applicable.

6.3 Identification Numbers

Rally plates and competition numbers will be provided by the Organisers, in accordance with Article 18 of the 2018 FIA WRC Sporting Regulations and as detailed in the Appendix 4.

Service and support vehicle car plates must be placed on the top right corner on the inside of the windscreen.

6.4 Restrictions on advertising

No political, religious, social or abusive advertising. Advertising for private betting and gambling offerers without permission for Germany is prohibited.

Publicity on tobacco is forbidden. This is a restriction self-imposed by the German tobacco industry.







7. TYRES

7.1 Tyres specified for use during the rally

The FIA nominated tyre companies to supply the single tyres in the FIA World Rally Championship 2018 are Michelin, DMACK and Pirelli. The contacts are given in point 61.1.1 of the 2018 FIA WRC Sporting Regulations. All the requirements around the use of FIA specified tyres supplied by the nominated tyre companies are detailed in the 2018 FIA WRC Sporting Regulations.

In addition to complying with Articles 60, 61 & 62 of the 2018 FIA WRC Sporting Regulations, the following quantities are confirmed for use.

Special attention is also drawn to the Appendix V of the 2018 FIA WRC Sporting Regulations regarding tyre regulations!

7.3 Tyre Fitting Zone

A remote tyre fitting zone pursuant to 52.1 of the 2018 FIA WRC Sporting Regulations will be established on Saturday.

The following applies in addition:

- **7.3.1** The maximum length of the tyre transport vehicle (one for each crew) is 7 m (except as 7.3.5 below).
- **7.3.2** Each transport vehicle must be fitted with a TFZ sticker with start number (windscreen), supplied by the organiser.
- **7.3.3** The transport vehicles may access the zone itself only upon instruction of the marshals on-site. Team personnel may then remain nearby their transport vehicle, provided that all applicable provisions are respected.
- **7.3.4** The transport vehicles must clear the zone immediately and with no hesitation after their rally car has left.
- **7.3.5** The tyres for competitors who are required to use tyres from an FIA nominated tyre company may be transported by the respective tyre company (or their appointed representative) so that the provisions under 7.3.1 to 7.3.4 do not apply for these competitors.

More details will be published in a Bulletin, if applicable.

8. FUEL

All FIA Priority drivers must use the FIA fuel as provided by the FIA appointed supplier which is Panta Distribuzione S.p.A., who will also carry out fuel ordering, supply and refuel services. The cost of the FIA fuel including refuel services is € 5.00 (+ VAT) per litre, dispensed into rally cars. For further information, see Articles 58 and 59 of the 2018 FIA WRC Sporting Regulations.

8.1 Ordering procedure

All competitors using FIA fuel must place their fuel order directly with Panta Distribuzione S.p.A., by e-mail to **fuelorder@panta.it** or by fax to +39 0373 235123. The order form issued by Panta Distribuzione S.p.A. including payment details by bank transfer is available on the event website: www.adac.de/rallye-deutschland. It is a condition of supply that payment must be received in full before delivery can be made. The balance of

non-used fuel will be credited after the rally.









8.2 Closing date for ordering FIA fuel

See point 3 of these Supplementary Regulations.

8.3 Dispensing method for non-priority drivers

Non Priority drivers may use either FIA fuel following the same conditions and rules as the Priority drivers, or commercially available pump fuel, dispensed only from pumps at filling stations marked in the Road Book. Should a particular car not be able to cover the distance between two corresponding filling stations due to the individual fuel consumption and the individual fuel tank capacity, FIA fuel may be ordered and refuelled at the FIA refuel zones (deadlines for ordering must be respected!!).

8.4 Technical requirements

According to article 59.3.2 of the 2018 FIA WRC Sporting Regulations, all competitors are required to fit FIA specified refuel couplings. Cars of priority drivers and RGT drivers specifically must be fitted with FIA fuel sample couplings (Art. 59.3.5). Cars equipped solely with FIA specified refuel couplings and using fuel as per Art. 59.1.2 must transport the adaptor in the car and show it at pre-event scrutineering (Art. 59.3.7).

9. RECONNAISSANCE

9.1 Procedure for registration

Prior to reconnaissance, all crews must complete a registration form and collect a reconnaissance pass and a recce vehicle identification at the Rally Headquarters Bostalsee (see Article 3.2). The material will be given to the drivers personally or to a representative duly certified in writing at the Rally Secretariat.

The recce pass form issued by the organiser must be returned at the Rally Headquarters Bostalsee or at the service park Headquarters Bostalsee until **Thursday**, **16 August 2018**, **10:00hrs**, at the latest. The identification number panels (small format) must be affixed to the upper side of the windscreen and of the rear window, in the centre. The fluorescent orange numbers issued must be placed at the top of both rear side windows. All identifications must be kept visible for the whole duration of the recce period.

9.2 Specific and/or national restrictions – speed limit on special stages

9.2.1 Direction

Each crew may drive the special stages only in **the same direction as the rally**, unless permitted to drive in the opposite direction for very short sections if published in a Communication by the Clerk of the Course. The crews must always enter and leave the special stages through the start and stop controls.

9.2.2 Respect of traffic laws and driving behaviour

All Road Traffic Laws must be strictly observed and the safety and rights of other road users must be respected during reconnaissance. All crews must drive in a manner that does not endanger or inconvenience other traffic or people living near the stages. Competitors must bear in mind that the special stages are not yet closed to public or residential traffic during recce.

9.2.3 Number of persons on board

During each passage through a special stage, a maximum of 2 persons are permitted in the car.

9.2.4 Maximum speed

At all times the maximum speed on special stages will be 90 km/h unless a lower limit is indicated by traffic signs, by signs placed by the organiser or in the Road Books.

9.2.5 Reconnaissance pass

Crews must stop at the start and at the stop of each special stage where a rally official will endorse the crews' reconnaissance pass and at any other location where instructed.







9.2.6 Reconnaissance vehicles

All cars used for reconnaissance must comply with the prescriptions of Article 25.1 of the 2018 FIA WRC Sporting Regulations.

9.2.7 Service during reconnaissance

In compliance with Article 25.4.6 of the 2018 WRC Sporting Regulations.

9.2.8 Participation in reconnaissance only

Any driver wishing to take part in reconnaissance only (see also Art. 25.5 of the 2018 WRC Sporting Regulations) must complete an application form which is available from the organiser and pay a fee of 1.000 € (VAT to be added) for taking part in this reconnaissance. The form has to be returned until the entry closing date.

9.3 Installation of speed control checking devices

In accordance with Article 25.4.4 of the 2018 FIA WRC Sporting Regulations, all cars must carry recce GPS recorders on board during reconnaissance. Location and times for collection and return are specified in Art.3.2. Rental costs:

FIA P1 & P2 300€ + VAT FIA P3 & non-priority drivers:130€ + VAT

9.4 Recce of SS 1 SuperSpecialStage St. Wendel

Recce on SSS 1 will be carried out on Thursday 16 August 2018 after TC 0 and may only be driven once during recce. The recce must be done with the rally car. The recce of SSS 1 will be carried out without recce GPS recorders. The speed limit on this stage during recce is 50 km/h.

All crews are reminded of Art. 20.2 in the 2018 FIA WRC Sporting Regulations.

9.5 Inspection of the Special Stages Panzerplatte and of non-public roads

The special stages "Arena Panzerplatte" and "Panzerplatte" are taking place on a military area and can only be visited with a special access authorisation. Furthermore, also on the other stages there are sections on non-public roads. The competitors get their access authorisation at the recce registration in form of the recce identification number. Beyond that the organiser will not issue any additional access authorisations except for the registered WRC manufacturers and the tyre manufacturers. They will get one access authorisation per WRC registered manufacturer / per tyre manufacturer.

10. ADMINISTRATIVE CHECKS

10.1 Original documents which must be presented:

- Competitor's international licence,
- Driver's and co-driver's international competition licences,
- Driver's and co-driver's valid driving licences,
- Driver's and co-driver's passport or identification,
- ASN authorisation for all foreign competitors, drivers and co-drivers,
- Completion of all details on the entry form,
- Rally car insurance cover certificate (see Article 5 in the present Regulations).
- Rally car registration papers.

After completion of administrative checks, competitors will receive a signed Administrative Clearance Form which must be submitted at scrutineering.

10.2 Timetable

See point 3.2 in these Regulations.







11. SCRUTINEERING, SEALING AND MARKING

11.1 Scrutineering venue and timetable

See point 3.2 of these Regulations. A detailed timetable will be published in a Bulletin. The layout of the scrutineering area will be published in Rally Guide 2.

For scrutineering, all cars must have their sump guards removed for sealing of gearboxes and differentials, and be kept with the car for the purpose of weighing. The homologation form of the rally car and certificates for the roll cage and fuel tank must be brought to scrutineering. Competitors with cars registered in Germany have to present the valid KFP at Scrutineering.

The bodyshell and engine will be marked and to facilitate this, each competitor must prepare their car (engine block) in order to fit a wire, a plate and a seal somewhere on the engine block (on a visible place when the front bonnet is opened).

11.2 Mud Flaps (Appendix J Article 252.7.7)

Mud flaps to prevent splashing towards the front in conformity with Article 252.7.7 of the Appendix J to the 2018 FIA International Sporting Code are authorised.

11.3 Windows/Nets (Appendix J Article 253.11)

The use of silvered or tinted films is not authorized.

11.4 Driver's safety equipment

All items of clothing including helmets and FHR (Front Head Restraint) intended to be used must be produced at scrutineering. Compliance with Appendix L Chapter III will be checked (see Appendix 5 of these regulations).

11.5 Sound level

In accordance with Article 252.3.6 of the Appendix J to the 2018 FIA International Sporting Code.

11.6 Specific requirements

Each competing car must be equipped with a reflective triangle and two fluorescent jackets.

Two belt cutters must be carried on board at all times. They must be easily accessible to the driver and co-driver when seated with their harnesses fastened (Art. 253.6.1.3 Appendix J).

11.7 Installation of FIA Safety Emergency Console

In accordance with article 40.2.1 of 2018 FIA WRC Sporting Regulations all competitors must make provisions in their rally cars for the installation of the FIA Safety Emergency Console System and the emergency button.

Collection times for the FIA Safety Emergency Console are given in point 3.2 of these Regulations. A €1200 fully refundable credit card deposit will be collected by STATUS AWARNESS SYSTEM (SAS) from each competitor for the FIA Safety Emergency Console boxes for the event of loss / damage.

The system must be fitted and connected in all competitors' cars before arrival at scrutineering where they will be checked. Installation instructions are published in Appendix 6 of these regulations.

The FIA Safety Emergency Console System must be removed in the Final Parc Fermé. They must be returned at the same location where they were distributed no later than 18.00hrs on Sunday, 19 August 2018. In the case of retirement, all the tracking equipment must be returned to SAS at the Service Park as soon as possible after retirement.

11.8 Tyre Marking

The tyre marking zone for Section 1 is located after TC 0.







12. OTHER PROCEDURES

12.1 Ceremonial start procedure and order

There will be no ceremonial start. There will, however, be a presentation of the drivers and an autograph session on Thursday, 16th August 2018, from 16:00hrs during the regrouping in St. Wendel.

12.2 Start of the rally

The start of the competitive element of the rally will be given on Thursday, 16 August 2018, from TC 0 SP Bostalsee (see Itinerary). Time cards will be issued at TC0.

12.3 Finish procedure

The competitive element of the rally will conclude at TC 18A.

After the Power Stage, the prizegiving ceremony on the podium in St. Wendel for the top three drivers will be broadcasted live in TV. After the finish of the Power Stage, the rally cars must directly enter the holding area in front of the podium and the marshals' instructions must be respected.

The ceremony for the top three overall will be followed by the ceremony for all other participants.

After the finish ceremony St. Wendel, all rally cars (except the cars selected for final scrutineering) must follow the marshals' instructions to proceed to the final parc fermé St. Wendel next to the podium (see overview map St. Wendel).

The cars selected for final scrutineering will be guided by the organiser in convoys to final scrutineering and may be driven by a duly authorised team representative

Access to the holding area in front of the finish podium will be limited to officials and to media representatives holding the appropriate pass.

Only upon presentation of the parc fermé pass issued with the rally materials may a car be removed from the final parc fermé by the drivers or their representatives, once the stewards have authorised to open the final parc fermé.

12.4 Any special procedures / activities including the organisers' promotional activities

Thursday 16 August 2018 12:00hrs Meet the Crews, Service Park

From 16:00hrs Regrouping with Driver presentation and autograph session in

St. Wendel

Sunday 19 August 2018 From 13:00hrs Ceremonial finish St. Wendel

12.5 Start Order and Starting Intervals

12.5.1 The Start order of the rally will be as follows:

- TC 0 Service Parc Bostalsee: non-priority drivers, P3 drivers and P2 drivers in reversed order of the start numbers, P1 in reversed order of the championship classification;
- TC 0B Regrouping St. Wendel OUT: P1 in reversed order of the championship classification, P2, P3 and non-priority drivers in their respective numerical order.
- Friday, Saturday and Sunday: according to Art. 45.2 of 2018 FIA WRC Sporting Regulations

12.5.2 SS 1 SuperSpecialStage St. Wendel and SS 4/7 Wadern-Weiskirchen

During Section 1, 2 and 3 there will be the **SuperSpecialStage St. Wendel and the SS Wadern-Weiskirchen,** organised in form of a "circuit special stage". The number of laps as detailed in the road book must be completed before the drivers leave the course to the flying finish and to the Stop control.

The competitors are themselves responsible to respect the number of laps which are clearly indicated in the Road Book.







If the number of laps is exceeded, the time set, including all completed laps, will be counted. If the number of laps completed is below the prescribed number, the crew is considered to have failed to complete the section and Article 46 of the 2018 FIA WRC Sporting Regulations will apply.

Start procedure:

- At the start of these stages, a manual start procedure will be used. After handing back the time card to the crew, the timekeeper will count down aloud: 15", 10" and the last 5 seconds one by one. When the last five seconds have elapsed, the starting signal will be given whereupon the crews shall immediately start into the special stage.
- The actual starting time (hour, minute, second and tenth of a second) recorded on the starting line by photocell will be entered on the Time Card at the SS Stop Point. For the start time as per Article 33.3.5 of the 2018 FIA WRC Sporting Regulations, only the hour and minutes shall be taken into consideration.
- All crews which have been allocated a start time interval of 2 minutes at the start of Section 1, 2 and 3 will have at least an interval of 1.40 minutes between their start time and the start time of any other crew. All other crews will have at least an interval of 40 seconds between their start time and the start time of any other crew.

If the running of the SSS 1 and/or SS 4/7 is interrupted, this will be signalled to the drivers by red flags. When given this signal, the driver must immediately reduce speed and leave the SS to the finish, even if the prescribed number of laps is not completed. Failure to comply with this rule will entail a penalty at the discretion of the Stewards.

If a crew cannot finish the SSS 1 within a maximum time of 4 minutes, the car will be removed by the organizer and placed at the Stop Control. Any such car will be penalized as in 2018 FIA WRC Sporting Regulations Art. 46.2 and will be assumed to continue in Rally 2, respecting the requirements of WRC Art. 47, unless the competitor notifies the organizer otherwise.

12.6 Official time used during the rally

The official time used during the rally is the speaking clock of the "Deutsche Telekom": Telephone 0180 4 100 100 (0.20 Euro per call).

12.7 Flexi Service

12.7.1 Flexi Service for P1-drivers

In accordance with FIA WRC Sporting Regulations Art 51.2.

12.7.2 Flexi Service for P2, P3-drivers and drivers without FIA priority

In accordance with FIA WRC Sporting Regulations Art 51.3.

12.8 Permitted early check in

Crews are authorised to check in early without incurring a penalty at TC 0 B (Regrouping IN St. Wendel), TC 1 A (end of section 1), TC 7 C (end of section 3), TC 15 C (end of section 5) and TC 18 A (end of section 8).

12.9 Service Park

12.9.1 Admission

Only cars carrying the appropriate car identification passes will be admitted in the service park.

Any parking of service and/or auxiliary vehicles in the service park outside the designated service area allocated to each team is strictly prohibited.

12.9.2 Environmental prescriptions:

The compliance with the environmental and safety prescriptions will be carefully checked by officials. Please make sure that all team members are aware of these prescriptions.







- The service park is located in a sensible water protection area. Both organiser and participants must undertake all efforts to protect the environment – in particular water and soil.

- Cleaning of vehicle components

- Several facilities (water containers and water connection) will be available in the service park nearby the service park headquarters from Tuesday, 14 August 2018. Please bring your own high-pressure cleaners, if required. The use of high-pressure cleaners or water hoses for cleaning purposes is prohibited at all other locations in the area of the service park.
- The crews are obliged to put a sufficiently large plastic ground sheet under the competition car as long as service works are carried out on the car. The ground sheet must be sufficiently strong and tear-resistant, have no damages and be tight, i.e. impervious to oil, fuel, cooling and brake liquids as well as to battery acid. If several sheets are connected, this connection must be made of adhesive tape which is leak-tight, impervious and tear-resistant to the aforementioned substances or an overlap of the sheets of at least 50 cm must be ensured.

Any residues such as water, oil, fuel, any other liquids, dirt and similar must be collected from the ground sheets, the use of wet vacuum cleaners is recommended, and be disposed environmentally-friendly (e.g. into the containers at the high-pressure cleaners facilities provided by the organiser).

- The crews are required to see that no substances hazardous to water pass over the edge of the ground sheet and into the ground, even in the case of rain.
- The service crews must be in possession of oil absorbing materials and have available a container for used oil and brake fluid at any time during the event.
- Due to official instructions, competitors must avoid any pollution of the environment. Any waste, wrapping
 material, spare parts, empty oil or colour tins, batteries, etc. must be collected and given to a waste
 disposal by the competitors themselves. Used oil must be collected and brought to the containers made
 available in the service park for this purpose.
- Containers with substances hazardous to water such as oil, fuel, cooling and brake liquids, chemical substances or cleaning agents must not contain more than 20 litres per unit. No more than 100 litres of the above substances may be stored inside a vehicle if no safety devices such as collecting tray are provided.
 - Any such empty containers must be disposed at the collection points for hazardous goods inside the service park and/or with Panta Distribuzione S.p.A. for fuel containing devices.
- To enable a smooth operation of the rescue teams in case of an accident, all containers with liquid and non-liquid chemicals (e.g. cleaning agents) must carry labels which clearly identify their contents.
- Smoking is forbidden at a distance of less than 10m from containers with inflammable contents (e.g. fuel for generators), even if the containers have been emptied. A solid barrier must be provided between the storage area of any such containers and eventual spectator areas before, during and after their use.

Any infringement will be reported to the Stewards.

12.9.3 Cash Deposit

Each area in the service park must be left in a clean condition and without any rubbish. Before leaving the service park, each competitor must report to the service park headquarters staff during the service park opening hours to get clearance for the corresponding area. On Sunday, 19 August 2018, the staff will be available until 20:00hrs and on Monday, 20 August 2018, between 08:00 and 12:00hrs (or upon special agreement).

Please note that for this purpose, a <u>cash deposit</u> of 100 € <u>for each competitor</u> will be required <u>at Administrative Checks</u>. Each competitor will get a corresponding receipt and this deposit will be reimbursed by the service park HQ staff upon submission of this receipt and after clearance of the competitor's service park area.

12.9.4 Car wash facility

A rally car wash facility will be available on Thursday (Shakedown), Friday, Saturday and Sunday each time prior to the cars entering the regroup area/service park Bostalsee. See Road Books for exact locations.







12.9.5 Fuel tank calibration zone

For the use until Thursday, 16 August 2018, a fuel tank calibration zone nearby the refuel area at the service park Bostalsee will be provided. Any emptying or refilling of fuel in the area of the service park Bostalsee may only be carried out in this zone and under the competitors' own responsibility.

12.9.6 Dismantling of facilities

Any dismantling of service area facilities before Sunday, 19 August 2018, 13:30hrs, must be made at times when there is no rally traffic inside the service park (see Itinerary) unless any such dismantling is exclusively carried out within the periphery of the corresponding team area itself (without using any kind of traffic lanes or team external areas).

12.10 Route Note Cars

12.10.1 General

As detailed in the 2018 FIA WRC Sporting Regulations, Article 11.5.

12.10.2 Identification

All these cars will be identified by the organiser.

12.10.3 Registration

The registration form for these cars must be submitted to the organiser as detailed under point 3.2 of these Regulations.

12.10.4 Special prescriptions

- A speed limit of 90 km/h is imposed in the special stages. All national traffic rules must be respected on the special stages and on the road sections between the special stages. The route note car crews must proceed with care, at a reduced speed, in the same direction as the rally.
- Any infringement of these provisions will result in the immediate withdrawal of the specific identification issued by the Organisers, without prejudice to any other sanction imposed at the Stewards' discretion.
- No route note cars will be allowed on SS 1 Super Special Stage St. Wendel.

12.10.5 GPS tracker system for route note cars

All route note cars must be equipped with the speed control device as used during reconnaissance. The provider is STATUS AWARNESS SYSTEMS (SAS).

Return: Sunday 19th August 2018, no later than 13.00 hrs - SAS truck - Service Park Bostalsee

12.10.6 Route Note Car exchange points

Will be communicated by a bulletin.

12.11 Regrouping Morbach (Sunday)

Article 42.5.2 of the 2018 FIA WRC Sporting Regulations is not applicable for the Regroup Morbach.

12.12 Power Stage (SS 18 – Bosenberg)

With reference to Art. 13.3 in the 2018 FIA WRC Sporting Regulations special stage 18 Bosenberg will be run as the "Power Stage".

After finishing the Power Stage all cars selected for live TV shall stop at the stage stop control to give interviews to WRC TV, and then drive immediately to TC 18A and the holding area. The last of the selected cars will not be interviewed at the stage stop control but shall drive straight to the TC 18A and the holding area.







13. IDENTIFICATION OF OFFICIALS

Timekeepers: Green tabards, "TIMEKEEPER" in white letters

Competitors' Relations Officers: Red tabards, "RELATIONS OFFICER" in white letters

14. PRIZES

General Classification

The crews first, second and third overall plus the winning manufacturer will receive ADAC Honorary Cups.

Class Classification

30 % of the starters in each class which are not at the same time overall or FIA Support Championship event winners will receive cups, provided that the minimum of 5 cars have been entered in the corresponding class. Should this number not be attained, the competitors in the class concerned are admitted in the next class up.

FIA WRC 2, FIA WRC 3 Championships for Drivers

The winning crew in each of these classifications will receive cups.

Other awards:

The organiser reserves the right to award additional prizes.

15. FINAL CHECKS AND PROTESTS

15.1 Final Checks

Location: Schmidt GmbH, Trittschlerstraße 7, 66606 St. Wendel Time: Sunday, 19 August 2018, after the podium ceremony.

The cars selected for final scrutineering will be informed in writing. They are requested to provide proper equipment (including all sealed spare parts) and technicians at the final scrutineering venue.

15.2 Protest fees

Sum of the protest fee: € 1,000 (see Article 55.2 of the 2018 FIA WRC Sporting Regulations).

If the protest requires the dismantling and the reassembly of different parts of a car, the claimant must pay an additional deposit which will be determined by the Stewards.

15.3 Appeal deposit







Appendix 5: REMINDERS FIA APPENDIX L

All the competitors and drivers are reminded of the Appendix L to the 2018 FIA International Sporting Code, in particular regarding Chapter III – Drivers' Equipment (Helmets, flame-resistant clothing, frontal head restraint (FHR) and safety belts).

These regulations apply to Shakedown as well (helmet specifications, clothing comprising overalls, gloves (optional for co-drivers), long underwear, a balaclava, socks and shoes homologated to the FIA 8856-2000 standard).

HELMETS:

P1 drivers must wear crash helmets which meet the FIA Standard 8860-2004 or 8860-2010 – Advanced Helmet Test Specification (FIA Technical List n°33).

All others drivers must wear crash helmets homologated to one of the standards listed in FIA Technical List n°25, but are also compatible with FHR system, so are approved in accordance with FIA standard 8858 (Technical List n°41), 8860 (Technical List n°33) or 8859 (Technical List n°49). However, it is strongly recommended that they wear helmets meeting the FIA 8860 standard.

FRONTAL HEAD RESTRAINT (FHR):

The use of FIA approved FHR system is mandatory for all crews.

The wearing of any device intended to protect the head or neck and attached to the helmet is prohibited, unless the device has been homologated according to the FIA Technical List n°29.

1. Tracking Unit Kit Components

The WRC Tracking System Kit includes:

- WRC Tracking Installation and Fitting Kit Instruction Sheet;
- 3-in-1 antenna with leads;
- > Internal radio antenna with lead;
- ➤ 6 24v wiring loom with plug;
- Mount, to be bolted to tunnel;
- Adjustable mount connector/knuckle.

2. Power Supply

WRC tracking system requires a reliable power supply from 9 to 28 volts DC. We recommend a 5 amp (Max) blade type or similar quality fuse is used at the battery supply end of the WRC tracking system power lead.

Zero volts or battery negative can be picked up at any suitable earthing point providing the isolation switch does not switch the negative side of the battery.

The WRC tracking system unit has an internal battery that is kept charged via the car's power supply. It acts as a reserve supply to power the unit in the case of an accident where a car's power supply is interrupted (e.g. car battery smashed or dislodged).

3. Connection Diagram

The 6-24v wiring loom, includes five wires. The white blue and grey wires must be stagger cut and heat shrinked or taped back so they cannot short to ground or to each other. Red and black are used as follows:












During installation, the wiring loom should be routed away from the engine compartment, Ignition or Alternator wiring.

300 mm of Power Supply Wiring Loom is required to be available for connection to the WRC Tracker Unit at the mounted position.

5. Tracking Unit Mounting

The preferred location and mounting for the WRC tracking system unit is a RAM style 50mm x 75mm flat base with ball, bolted through the tunnel with four **M6** Bolts.

It should be in a central, protected location on the central tunnel in front of the seats and both easily visible and accessible by both the driver and co-driver/nav.

Care should be taken when considering the location of the Mounting Point with regard to electrical cabling and fire suppression systems installed in the vehicle.

Photographs of mounting and positioning can be seen in Fig.1 and Fig.2 respectively.

Alternatively, the WRC tracking system unit can be mounted in a central protected location on the vehicle dashboard that is easily visible and accessible by both the driver and co-driver.

Mounting is a Ram style 50mm x 75mm flat base with ball, bolted with four **M6** bolts through the dashboard and a compulsory 3mm backing plate measuring no less than 145mm x 120mm

6. Antenna Installation

All leads on both external and internal antennas must run on the inside of all roll cage bars. This is to stop cable crushing on impact.

Antenna must not be mounted within 200 mm of any high frequency antenna's or cabling

The preferred route is to go down from the antenna, underneath the closest part of the roll cage (roof cross or main hoop), follow that along to the roof hoop, then go down the inside A pillar to the unit. Please allow 200mm clearance of high frequency antenna or cabling

Any excess cable must be run so that the cable is not bent any tighter than a 100mm radius. We recommend running it across the underside of the dash and back (do not coil in tight loops).

Cables must be tied neatly along the whole installation all the way to the unit so they can't be accidently caught or dislodged.

All this will be checked at scrutineering and you may be required to fix it before your car can pass.

6.1. External Antenna

The antenna is mounted through a 12mm hole in a central location on the ROOF of the vehicle, rear of the main roll bar hoop, allowing the cabling to pass through the roof and follow the cage bars back to the unit location. The antenna is a fully watertight unit, which seals against the roof surface.



Antenna leads are connected as follows (There may be variations with the type and number of leads).

- 1. The 2 UHF leads, colour-coded **Blue**, is connected to the terminal labelled "UHF" on the WRC unit (Right Hand Thread). Terminals are located of the rear of the unit and/or colour-coded Blue.
- The Satellite Communication antenna lead is connected to the center or rear terminal labelled "IRI" (Left Hand Thread). It may also be colour-coded Yellow (this may be not marked on the 2-in-1 antenna).
- The GPS antenna lead labelled "GPS", is connected to the terminal labelled "GPS" on the WRC unit (Right Hand Thread). Terminals may be on the side or rear of the unit and/or colour-coded Green.
- 4. GSM, has a small stick antenna supplied with the WRC unit, and is connected to corresponding terminal labelled "GSM" on the WRC unit (Left Hand Thread). The terminal is located on the rear of the unit and/or colour-coded Red.

6.2. Internal Antenna

The Internal Antenna should be placed on the inside of the ROOF in a clear uncluttered area, with a 200mm radius clear of any bar work or solid metal object. The internal antenna has a magnetic base with double-sided tape for adhesion. The cable is then run to the WRC unit. Please keep cable on the inner side of the roll cage pipework so as not to be crushed in the event of an accident.




Figure 3. The internal antenna must be at least 200mm away from any roll cage components

Welcome

For your and other competitor's safety, it is important that you are familiar with the use of the WRC tracking unit, herein referred to as "the unit" or "the WRC tracking unit".

The SAS System is designed to increase competition safety by providing safety notifications to inform event management, improve response times and provide accurate and reliable event times.

The following document outlines the basic features and functions of the WRC tracking unit. Please note that the WRC Tracking unit must be fitted and connected in all competitor's car, in accordance with the SAS Fitting Kit Manual – RALLY CAR.

1. Powering The Unit On

The unit is pre-loaded with all of the stage coordinates and is activated when powered on. Please power the unit on early before the event to give it time to run checks.

When powered on the unit will display the transport mode, the details of which are specified in the Art. 2.1 of this document.

The unit does not need to be powered off at any stage during the event as it will go to sleep within a few minutes of inactivity but can be re-woken by either moving the vehicle or pressing any of the four buttons.

It is recommended that the unit is not powered off during the event, to ensure the internal battery stays fully charged for emergencies.

2. Unit Modes

The unit has two modes:

- When not in a competitive stage, the unit will be in transport mode, as described in 2.1.
- When in a competitive stage, the unit will go into stage mode, as described in 2.2.

2.1. Transport Mode

SCREEN 1 – The transport mode displays from the top down the following information: the name of the next point you are travelling to, the time in transit, current time, accumulative and intermediate distances and speed, average speed.

The unit has four white physical buttons. Their functions is reported on the screen right above the button's location.

Starting from the far left button to the right, you have the following options:

- OPTIONS: Operation described in 5.Transport Menu.
- BRIGHT: Increase the screen brightness (Note that the screen must always be clearly readable so full brightness is recommended for daytime).
- · DIM: Decrease the screen brightness,
- RESET: Intermediate trip meter.














3. Hazard Alerts

The unit's primary function is to help alert race control of incidents on the course. The incident is notified to race control with different levels of hazard depending on the severity.

SCREEN 6 – If a car stops during a stage, the unit will automatically transmit a HAZARD notification; this can either upgraded to OK or downgraded to SOS by pressing the corresponding button to the text. A timer counts up to 60 seconds as an indication to press the "OK".






















5 seconds to GO - 1 (short) Beep every sec + yellow zone and yellow light flashing "GO" Signal: Green light - Start Beep

After "GO" Signal: 20 seconds free start + green zone and green light

Competitors in classes NAT4 and NAT2 must follow all prescriptions of the 2018 FIA WRC Sporting Regulations and these Supplementary Regulations (SR), unless stated otherwise in this appendix 9.

National cars may participate in ADAC Rallye Deutschland under the prescriptions of 2018 FIA WRC Sporting Regulations, Art. 4.4, on the following conditions:

- The cars must conform with DMSB technical regulations listed below in Art. A9.2 and comply with the FIA safety requirements of Appendix J, Art. 253.
- The cars must be fitted with a FIA-approved safety fuel tank.

Entry Fee: according to Art. 4.4.2 of these regulations.

Entry Package for NAT2 and NAT4 will be the same as for a private competitor, see 4.4.3 in SR.

A9.4 Tyres

The make and model of tyres for cars in classes NAT2 and NAT4 are free, as long as they comply with Art. 60.1 of 2018 FIA WRC Sporting regulations.

The maximum number of tyres used during the rally is 22.

A9.5 Scrutineering

All prescriptions of SR, Art. 11 apply, except for sealing and marking, where only turbos and their spareparts will be sealed.

Study carefully the requirements of FIA Safety Emergency Console Device installation.

National extentions for time limits of any safety equipment (car or driver) do not apply. Extinguishing systems must be installed (Appendix J, Art. 253-7.2).

Anti-torpedo tabs for both mounted systems and manual extinguishers are required.
