#### 4/1 Closing date for entries

Monday, 25 February 2019, at 23:59 CET

#### 4/2 Entry procedure

Anyone wishing to take part in the CORSICA linea - Tour de Corse 2019 must use the **FIA Online Registration Platform**.

WRC Manufacturers, WRC2 Pro, WRC2, Junior WRC and RGT entrants who wish to score points must make their entries by using the standard entry form for their championship available in the FIA application at : <u>https://registrations.fia.com/rally</u>

Any Competitors entered in the FIA WRC 2 Pro and WRC 2 championships wishing to enter CORSICA linea - Tour de Corse, but not wishing to collect points for their respective championships, must use the non priority entry form as detailed hereafter.

Any non-priority drivers must register and fill-in the electronic entry form available at <u>https://registrations.fia.com/wrcfra</u> duly completed before the closing date of entries.

Please note that the FIA registration platform requires a user ID and a password to access the entry system. The FIA will need time to register you in the system and open your user account. Please do not wait until the last moment to make your entry in order not to miss the entry closing date.

The user account application is available via a link on the registration page stated above.

When sending your online registration entry form to FIA, please remember also to send the following documents to <a href="mailto:mbaheux@ffsa.org">mbaheux@ffsa.org</a>

The entry application will be only accepted if accompanied by:

- Copies of the Compétitor and Driver/Codriver Competition licences
- Copies of the Diver/Codriver passport or Identity cards
- Copies of the Driver/Codriver driving licences
- One passport photo for Driver/Codriver
- Copy of the page of the homologation form for the entered car indicating number, group and cylinder capacity
- ASN authorization

By sending this electronic form, the competitor and the crew undertake to abide by the rules and regulations of the competition, as well as the prescriptions of FIA-WRC Art. 21.5 and the present Supplementary Regulations.

Competitors will sign the entry form at the Administrative checks.

If a competitor cannot make the entry on the internet, they must contact <u>mbaheux@ffsa.org</u> before close of entries for further instructions.

Only complete applications accompanied by the full entry fee will be taken into consideration.

Foreign competitors, drivers and codrivers who wish to take part in the CORSICA linea - Tour de Corse can only do so with the approval of their own ASN.







#### 4/3 Accepted Cars & Classes

#### 4/3/1 Number of competitors

The maximum number of competitors is set at 140 cars.

Competitors who submit an entry form may only consider that their entry has been accepted once they have received official written confirmation from the Organiser.

#### 4/6 Refunds

Entry fees will only be refunded:

- a) to competitors whose entry has not been accepted,
- b) if the CORSICA linea Tour de Corse does not take place.

### **5 INSURANCE**

In accordance with the general prescriptions governing sporting events and competitions on the public roads in France, the Organiser will take out an insurance policy with an approved company.

The general conditions of this policy will notably stipulate the guarantee granted per accident involving bodily injury and per accident involving damage to private property in accordance with the general legal prescriptions and regulations.

Entry fees include the insurance premium which guarantees competitors' cover for liability to third parties (all physical injury and damage to property) to a limit of €25.000.000 per incident.

The above competitor insurance will become effective from the start of the technical scrutineering untill the end of the rally <sup>(1)</sup> for those competitors finishing the rally.

<sup>(1)</sup> "end of the rally" = opening of the Parc Fermé after the publication of the final classification.

In the case of retirement for the day only (Friday or Saturday), the cover will remain effective until the car arrives at the Service Park using the rally route from the place of the run off the road to the service park, driven by one of the two crew members or by the designated optional driver according SR Art.12/16. The cover will cease 4 hours before the start of the next section after the overnight regroup if the car concerned has not be returned to Parc Fermé before that deadline.





In the case of final retirement, exclusion or disqualification, the cover will cease at the time of the final retirement, exclusion or disqualification unless the final retirement occurs during a special stage in which case cover shall cease when the car arrives at the Service Park (using the rally route from the place of the run off the road to the Service Park and driven by one of the two crew members or by the designated optional driver according SR Art.12/16) but without exceeding the time of the end of the rally.

Moreover, in case of an accident, competitors or their representative must report the incident in writing to the Organiser within three days at the latest. In case a recovery service is used either on a special stage or on a road section, expenses will be incurred by the competitor.

« Service », « auxiliary », « route note cars » or « weather » identified vehicles and vehicles used by competitors for reconnaissance purposes are not considered as officially taking part in the Rally even if they have registered with or bear identification associating them with the Rally. They are not covered by the Organiser's insurance policy and remain the sole responsibility of their owners.

### **6 ADVERTISING AND IDENTIFICATION**

#### 6/1 Advertising

#### 6/1/1 Restrictions

Competitors are allowed to affix any kind of advertising to their cars, in respect of FIA-WRC Art. 18.7.1.

All publicity or advertising, whether direct or indirect, for tobacco/alcohol, or for products related to tobacco/alcohol, as well as any free distribution of samples is forbidden (Article 2, Law N°91-32 dated 10/01/1991, relating to the fight against nicotine and alcohol addiction).

#### 6/1/2 Organiser's advertising

- a) Mandatory advertising on rally plates and competition numbers: Igol
- b) Optional advertising: Collectivité de Corse / CORSICA linea

#### 6/2 Competition numbers

The Organiser will provide each crew with competition numbers and with rally plates in compliance with FIA-WRC Art. 18. Rally plates and competition numbers must be affixed to the cars for the whole duration of the competition.

Following the requirement of the <u>French traffic rules</u> regarding the identification of the rally cars (decree n°2012-312 of 5/03/2012 which modifies the article R.411-29 of French traffic rules and the laws of 14/03/2012 & 28/03/2012) identification of all rally cars will be by two numbers (210mm x 140mm) to be fixed at the front and the rear of the car as supplied by the organiser of the rally.

The identification number is the same as the competitor  $N^{\circ}$  for the rally. It is valid only during the rally and on the rally itinerary.

These two numbers must be used in place of the usual registration plates which must be removed or concealed. The above rule applies also to foreign registered rally cars.

See Appendix IV of these Supplementary Regulations.

Failure to comply with this regulation will result in a penalty of €160 for the first observation, and €320 in case of recurring violation.

Competitors must present their cars to scrutineering with rally plates, competition number and mandatory and optional advertising, where applicable, applied to the car.

### 7/4 Tyre Fitting Zone (TFZ)

The length of the tyre transport vehicle permitted in the adjacent parking is limited to 7 meters. Each transport vehicle must be fitted with a specific TFZ car pass supplied by the organizer.









### 8 FUEL

<u>All priority P1, P2P, P2 & P3 drivers</u> must use FIA fuel as provided by the FIA appointed supplier. The supplier appointed by the FIA is TOTAL Additives and Special Fuels which is authorized to carry out fuel ordering, supply and refuel services.

All Non-priority drivers & RGT priority drivers must use either:

- FIA WRC 2019 TOTAL Excellium Rally fuel following the same conditions and rules as the priority drivers,
- or **FFSA SP98 fuel** (commercial Super Unleaded 98 fuel) as provided by the FFSA appointed supplier. The supplier appointed by the FFSA is TOTAL Additives and Special Fuels which is authorized to carry out fuel ordering, supply and refuel services.

<u>All competitors</u> must ensure their cars carry sufficient fuel between refuel points (SR Appendix 1) to complete the distance shown in the itineray plus have at least 3 liters for any fuel sample checks (FIA-WRC Art. 59.3.4).

Any addition of any product to the authorized fuels (FIA fuel & FFSA fuel) is strictly forbidden.

#### 8/1 Ordering procedure

The cost of the FIA WRC 2019 TOTAL Excellium Rally fuel including refuelling services is € 5,60 (VAT excl.) per liter.

The cost of the FFSA SP 98 fuel including refuelling services is € 2, 60 (VAT excl.) per liter.

### **9 RECONNAISSANCE**

See also FIA-WRC Art. 25.

#### 9/1 Procedure for registration

All crews taking part in reconnaissance must complete the registration form (website) and return it to the Permanent Rally Office, following the procedure specified on the form.

All crews taking part in reconnaissance must register at Administrative Checks on Sunday, 24 March between 14:00 to 19:00 by appointment <sup>(7)</sup> or Monday, 25 March betwenn 07:00 to 13:00 by appointment in order to obtain the necessary materials.

(\*) by arrangement for Manufacturers.

Each crew will be given 'Reconnaissance' stickers, as well as a specific reconnaissance control card. The <u>stickers</u> are to be affixed at the top right of the windscreen, rear side windows and rear window of the reconnaissance car.

The <u>control card</u> must be shown and endorsed by the marshals (identifiable by a tabard) at each stage start (in order to gain access to the special stage or shakedown) and at the Stop point. On completion of reconnaissance, this reconnaissance control card must be returned to the Rally Office no later than 21:00, Wednesday, 27 March.

#### 9/2 Restrictions

<u>9/2/1</u> Reconnaissance will take place on Monday 25, Tuesday 26 and Wednesday 27 March in accordance with the schedule specified in Appendix II.

In the "Reconnaissance Road-Book" the route between the Special Stages is recommended but not compulsory.

9/2/2 Each crew is limited to two passages on each special stage, including shakedown.

Special Stages run twice are considered to be one special stage as far as reconnaissance is concerned.

<u>9/2/3</u> The speed limit during the reconnaissance of special stages is **80 kph**, except where road signs specify a lower speed limit.

The speed limit in built-up areas is **30 kph**, except where road signs specify a lower speed limit.

Excessive speed during reconnaissance will incur a fine applied by the Clerk of the Course (FIA-WRC Art. 20.2).

<u>9/2/4</u> It must be remembered that reconnaissance takes place on roads that are open to normal traffic. Given that reconnaissance is not testing:

- local traffic regulations must be complied with in full at all times,
- the safety and rights of other road users must be respected at all times,
- reconnaissance cars must be covered by an insurance policy in accordance with the law. In no circumstances can the Organiser be held liable in the case of an accident.

<u>9/2/5</u> Under no circumstances may a crew drive in the special stages in the opposite direction of the rally, unless specific instructions to do so have been given by officials.

Competitors may enter a special stage only via the start and must exit via the finish.

Only for the SS 8 /11 - Desert des Agriates, it is allowed to return in the opposite direction.

#### 9/3 Location of collection of speed control checking devices

All drivers must be equipped with a speed control device (GPS recorder system) in their cars during reconnaissance. (FIA-WRC Art. 25.4.4)

#### 9/4 Participation in reconnaissance only

As mentioned in FIA-WRC Art. 25.5, any driver wishing to take part in reconnaissance only will have to pay an entry fee of €1,000. He must complete the "recce only" registration form (website) and return it to the permanent Rally Office, following the procedure specified on the form and no later than Monday, 25 February (23:59).

### **10 ADMINISTRATIVE CHECKS**

Competitors must complete administrative checks before presenting their car at scrutineering.

#### 10/1 Documents to be presented

Following documents will be checked:

- valid drivers' and codrivers' driving licenses,
- drivers' and codrivers' passport or identification,
- valid competitor's license,
- valid drivers' and codrivers' international competition licenses,
- ASN authorization for all foreign competitors,
- rally car's homologation form,
- rally car's technical passport,
- a letter of the rally car's owner authorising the driver(s) to drive the vehicle during the event, when the driver(s) is not the owner of the car,
- valid named additional driver driving license, if any (see SR Art. 12/16).

Correctness of all information given in the entry form.

Signatures of entry forms for competitor, driver and codriver.

#### 10/2 Timetable

All competitors except WRC Manufacturers

<u>WRC Manufacturers</u> Tuesday, 26 March 14:00 / 18:30 (\*\*) Rally Office - Rally HQ (\*\*) by arrangement with Rally Office.

### **11 SCRUTINEERING, SEALING AND MARKING**

See also FIA-WRC Art. 26.

a) Cars may be presented at scrutineering by a representative of the team.

b) All cars must have their sump guards removed for sealing of gearboxes and differentials, and be kept with the car for the purpose of weighing.





c) All competing cars (except Manufacturers' cars) must have a drilled hole of at least 2 mm diameter at a visible position on the engine block (when the bonnet is opened), for a sealing wire to pass through it.

d) Crew must show the car's complete certified FIA homologation form.

e) Manufacturers registered in the Championship may present a signed Certificate of Technical Conformity

f) Scrutineers may require the car to be identified. The chassis and engine block may be marked.

g) Non-priority drivers: the transmission (fitted and spares) will not be sealed; however the turbos (1 fitted and 1 spare) will be sealed; for limitation of spare turbochargers see the FIA-WRC (FIA WRC Sporting Regulations).

The engine block will be sealed.

h) On board camera (see FIA-WRC Art. 65.1):

The mountings of any cameras and recorders must be able to withstand a deceleration of 25 g.

i) On completion of scrutineering, if a car is found not to comply with the technical and/or safety regulations, the Stewards, upon the proposal of the FIA Technical Delegate, may set a deadline before which the car must be made to comply, or may refuse the start.

#### 11/2 Mud flaps

The use of transverse mud flaps, in conformity with Art. 252.7.7 of Appendix J of the FIA Sporting Code, is permitted but not compulsory.

#### 11/3 Windows silvered or tinted films

The use of silvered or tinted films is authorized on rear windows only in compliance with Art. 253.11.1.1 of Appendix J of the FIA Sporting Code.

#### 11/4 Drivers' safety equipment

All items of clothing including helmets and head retaining device intended to be used must be produced at scrutineering. Compliance with Appendix L Chapter III will be checked. (See Appendix V of these Regulations).







#### 11/5 Noise level

The noise level on the road sections must not exceed 103 dB for an engine rotation speed of 3500 rpm for petrol engines.

#### 11/6 Special requirements

Each competing car must be equipped with a reflective triangle and two fluorescent jackets. Two belt cutters must be carried on board at all times. They must be easily accessible to the driver and co-driver when seated with their harnesses fastened (Art. 253.6.1.3 Appendix J).

#### 11/7 Installation of Safety Tracking System

Competitors must have installed the FIA Safety Tracking System in their rally cars before the car is brought to scrutineering. The system will be checked during scrutineering. Installation instructions are indicated in Appendix VI..

Systems may be collected either by the crew or a representative.

A €1,200 fully refundable credit card deposit will be collected by SAS from each competitor for the safety tracking boxes. This will be done with a swipe machine and at the end of the rally the slip will be destroyed when competitors return the equipment in good condition.

Safety Tracking Systems devices may be removed in the final Holding area by a team member only with the agreement of the FIA Technical delegate and under the control of the marshalls (FIA-WRC Art. 42.7).

They must be returned to SAS' truck - Holding area - Calvi - no later than Sunday, 31 March 17:30.

### **12 OTHER PROCEDURES**

#### 12/1 Ceremonial start procedure

The ceremonial start will take place on Thursday, 28 March at Porto Vecchio, Parking de la Capitainerie, starting from 19:00.

The ceremonial start will be given in reverse numerical order except for RGT, P3, P2, P2 P & P1 drivers for whom the order will be given in the reverse order of their respective Championships classification. Time cards will not be issued.

Crew members must wear their approved overalls at the ceremonial start.

Any crew arriving late at the Ceremonial Start Park will incur a cash penalty of €250. Further information will be provided in Rally Guide 2.

After the ceremonial start, cars must be entered directly into the Parc Fermé. The competitive element of the rally will start on Friday, 29 March from TC0.

#### 12/2 Start order

As per FIA-WRC Art. 45.

#### 12/3 Permitted early check-in

Crews are authorised to check-in early at TC6C, TC12E and TC14A without incurring any penalty.

#### 12/4 Time card change during the rally

Time cards will be issued at the following time controls : TC0 / TC3A / TC6A / TC6D / TC9A / TC12A / TC12F / TC 13A .





#### 12/5 Special Stage start system

The Special Stage start system will be as FIA-WRC Art. 37.2, 37.3 & App. VII.

#### 12/6 SS14 (Power Stage)

With reference to FIA-WRC Art. 13.3, SS14 "Calvi" will be run as the Power Stage.

Crews will contest SS14 with a different start interval than the interval given at the start of Section 6 and/or in a different order than the order at TC13A and will be determined by the Organiser in conjunction with the Promoter.

The Power Stage will be timed to the elapsed millisecond. However, the results will show only tenths of a second.

For the purpose of Live TV there will be interviews after the Stop Point of the stage; the Organisers, in conjunction with the WRC Promoter, may stop any car and its crew on the road section so that they can take part in media interviews and the ceremony for television.

Any car held will be allocated a delay time which will be noted on the time card and added to the target time for the road section to TC14A.

#### 12/7 Use of helmet prohibited on the road sections

French traffic law prohibits the use of helmets during the road sections.

A tolerance of a few hundred meters before the TC preceding the start of a special stage and after the Stop Point is granted for the fitment and removal of helmets. These tolerance zones will be indicated on the road by « helmet zone » signs (entry and end) and will be indicated in the road book.

#### 12/8 Official time

Throughout the rally, the official time will be UTC + 2.

#### 12/9 Service Park

An inventory of each competitor's service area will be drawn upon his arrival in the Service Park and when leaving. Detailed procedure in the Rally Guide.

The emptying of waste water, the washing of cars and the driving of stakes into the ground are not permitted in the Service Park. All infringements will be reported to the Stewards who may apply penalties.

Dismantling:

For safety reasons, dismantling competitors' service structures in the service park is not permitted before **10:00 on Sunday, 31 March**, after the public has cleared the service park.

Any team which breaks this rule will be fined €500.

In case of retirement during the rally, the team concerned must firstly obtain a dismantling authorization from the Service Park Manager.

#### 12/10 Car wash

An official car wash facility will be available at the Service Park entrance during the shakedown and before TC6A, TC9A and TC12A.

#### 12/11 Calvi Regroup

All crews must be at organiser's disposal at this regroup, in order to be able to receive information about their starting time from TC13B, should this information deviate from that available at their time of arrival to TC13A.





#### 12/12 On board cameras

As per FIA-WRC Art. 65.1.

#### 12/13 Route Note Cars

Route note cars will be permitted as in FIA-WRC Art. 11.5.

All crews wishing to use a route note car must complete the registration form (website) and return it to the Permanent Rally Office, in accordance with the instructions on it.

SR Art. 9/2/3 applies also to route note cars during the rally.

All route note cars must be equipped with a speed control device (GPS recorder system). The provider is SAS.

<u>Collection</u>: the route note cars will use the speed control device gave for reconnaissance.

Return: no later than 17:30, Sunday, 31 March at SAS' truck - Holding area - Calvi.

Route note cars are allowed to enter the stages up to 90' before the first rally car. However the setup of any safety arrangements or warnings cannot be guaranteed to be in place before 120' prior to the first rally car.

It is strictly forbidden for route note cars to interfere in any way with safety arrangements or warnings. Any contravention will result in confiscation of route note car plates.

<u>In case of retirement of a competitor</u>, its route note car is not allowed to pass through the remaining stages not contested by the crew and the GPS Tracker must be returned to SAS' truck (Service Park) as soon as possible.

#### 12/14 Re-start after retirement / Rally 2

FIA-WRC Art. 46 will apply.

The Time Card for the Section in which the crew retired must be submitted to the sweeper car or to a marshall at an official control.

#### 12/15 Finish Procedure & final Parc Ferme

The rally ends at TC14A (early check-in allowed).

After check-in at TC14A each crew must remain in the holding area for a minimum of 15 minutes, and be available for media interviews.

In the holding area there will be a Technical Zone in which:

a) all competitors are alowed to remove the FIA Safety Tracking system devices and the Promoter on-board cameras according to the following procedure:

• the work may only be performed with the agreement of the FIA Technical Delegate and under the control of the marshalls,

• the work may only be performed by the crew or by one team member,

• only the action directly involved in the Safety equipment removing and the Promoter on-board camera removing are permitted.

b) WRC car teams are allowed to change the wheels of their car (list 2 tyres) according to the following procedure:

- the work may only be performed by the crew or by two team members,
- only equipment carried on board the competing car may be used,
- an extra car jack may be brought by the team members,
- only the action directly involved in the change of wheels is permitted.





All classified crews will pass over the podium, Parking Christophe Colomb - Calvi starting from 15:00, in respect of Annexe IV - Article 2 of 2019 FIA-WRC regulation.

Further information concerning the podium procedure will be provided in Rally Guide 2.

After driving over the podium, competing cars must go to the final Parc Fermé (Parking du Port - Calvi), with the exception of those cars nominated to firstly attend scrutineering.

A pass to authorize collection of the car when the final Parc Fermé is opened will be handed to all crews whose cars enter Parc Fermé.

Cars will only be authorised to leave final Parc Fermé once the Parc Fermé has been declared open, following publication of the final classification and upon presentation of the pass handed to the crew on arrival at Parc Fermé.

One hour after the publication of the final classification, the Parc Fermé will be opened to the public and the Organiser will no longer be responsible for the cars.

#### 12/16 Named additional driver

Due to the requirements of French traffic laws, each entered crew will have the opportunity to appoint a team member who will be officially named to drive the rally car according to the itineraries listed below which will be limited to the routes mentioned in the Road-Book:

a) before the rally start (TC0) or after Podium Ceremony:

- from service park to the technical scrutineering, and return,
- from service park to Porto Vecchio ceremonial start,
- from podium to the final technical checks, and return to the final Parc Fermé.

b) in the case of Rally 2:

• from the location of the retirement to the service park.

All crews wishing to use a named additional driver must complete the registration form no later than Thursday, 14 March 2019. The registration form is on the rally website / Competitorrs / Official documents / Forms.

#### 12/17 Shakedown

For insurance reasons, only the driver and co-driver entered in the CORSICA linea - Tour de Corse are authorised to drive or co-drive during shakedown.

After agreement of the organization, codriver may be remplaced by a person holding a FIA license. In this case, his contact details (name, surname, license number) must be communicate to the organization - Margot BAHEUX <u>mbaheux@ffsa.org</u> no later than the closing date of entries(February, 25). This person should wear all mandatory FIA homologated security equipment.

#### 12/18 Testing

#### FIA-WRC 2019 Regulation / Article 66.5.2

P2 drivers are prohibited from testing in a country of a Championship round during the three weeks preceding the rally except when participating in an official testing session organised before the rally week by the rally organiser or one of its approved test organiser, on a single venue and on a single day.

The organiser has designated the Society Sarl D.C.S to organize this official testing for P2 drivers. Registration form for this test P2 is on the rally website / Competitorrs / Official documents / Forms and must sending to Margot BAHEUX <u>mbaheux@ffsa.org</u> before **Monday 25, February**.



#### COMPETITION NUMBERS AND MANDATORY ADVERTISING (IGOL):

A - TWO FRONT DOOR PANELS (67 cm x 17 cm)

Each panel shall be placed horizontally at the leading edge of each front door, with the number at the front (on both side). The top of the plate shall be between 7 cm and 10 cm below the bottom window line. No signage, other than the colour scheme of the car or the championship identification A' shall be placed within 10 cm of this panel.

A'- TWO FRONT DOORS PANELS (67 cm x 6 cm)

(only for competitors eligible to score points in the Manufacturers, WRC 2, WRC 3 or Junior WRC Championships). Must be affixed immediately below the front door panel A.

B – ONE REAR WINDOW PANEL (30 cm x 10 cm)

Shall be positioned at the bottom in the centre of the rear window.

C – ONE REAR WINDOW NUMBER (15 cm x 15 cm) Shall be positioned at the right of the rear window and must be visible from the rear at eye level.

D – TWO SIDE WINDOWS NUMBERS (20 cm high) Shall be positioned on the rear side windows, adjacent to the crew's name.

E – TWO DRIVER'S & CO-DRIVER'S NAMES (see FIA-WRC 19.1) These stikers are not provided by organizer.

 ${\sf F}-{\sf ONE}$  ROOF PANEL (50 cm x 52 cm) Placed with the top towards the front of the car.

G - ONE FRONT PLATE (43 cm x 21.5 cm)

H – ONE WINDSCREEN NUMBER (21 cm x 14 cm)(in substitution of front vehicle registration plate) Shall be positioned 10 cm below the right top corner of the windscreen (mandatory).

<u>All others drivers</u> must wear crash helmets homologated to one of the standards listed in FIA Technical List n°25, but are also compatible with FHR system, so are approved in accordance with FIA standard 8858 (Technical List n°41), 8860 (Technical List n°33) or 8859 (Technical List n°49). However, it is strongly recommended that they wear helmets meeting the FIA 8860 standard.

#### FRONTAL HEAD RESTRAINT (FHR) REMINDER:

The use of FIA approved FHR system is mandatory for all crews.

The wearing of any device intended to protect the head or neck and attached to the helmet is prohibited, unless the device has been homologated according to the FIA Technical List n°29.

#### FLAME RESISTANT CLOTHING REMINDER:

All crews must wear overalls, gloves (optional for co-drivers), long underwear, a balaclava, socks and shoes homologated to the FIA 8856-2000 standard (FIA Technical List n°27) or FIA 8856-2018 standard (Technical list N° TBA).


# Welcome

# 1. Tracking Unit Kit Components & Steps

The WRC Tracking System Kit includes:

- WRC Tracking Installation and Fitting Kit Instruction Sheet;
- 3-in-1 antenna with leads;
- Internal radio antenna with lead;
- $\rightarrow$  6 24v wiring loom with plug;
- Mount, to be bolted to tunnel;
- > Adjustable mount connector/knuckle.



(Contents may differ slightly to image shown)

WRC tracking system fitment steps:

- 1. Mount WRC tracker;
- 2. Fit external & internal antennas, running leads to the WRC tracker;
- 3. Fit wiring loom, ensuring that a solid 9 to 28 volts is supplied;
- 4. Connect all antenna connections, make sure they are tight using an 8mm spanner;
- 5. Apply power.

# 2. Power Supply

WRC tracking system requires a reliable power supply from 9 to 28 volts DC. We recommend a 5 amp (Max) blade type or similar quality fuse is used at the battery supply end of the WRC tracking system power lead.

Zero volts or battery negative can be picked up at any suitable earthing point providing the isolation switch does not switch the negative side of the battery.

The WRC tracking system unit has an internal battery that is kept charged via the car's power supply. It acts as a reserve supply to power the unit in the case of an accident where a car's power supply is interrupted (e.g. car battery smashed or dislodged).

Note: The tracking device should only be powered once it is placed in its final position in the vehicle; this ensures accelerometers are calibrated correctly.








# 3. Connection Diagram

The 6-24v wiring loom, includes five wires. The white blue and grey wires must be stagger cut and heat shrinked or taped back so they cannot short to ground or to each other. Red and black are used as follows:

During installation, the wiring loom should be routed away from the engine compartment, Ignition or Alternator wiring.


300 mm of Power Supply Wiring Loom is required to be available for connection to the WRC Tracker Unit at the mounted position.

# 5. Tracking Unit Mounting

The preferred location and mounting for the WRC tracking system unit is a RAM style 50mm x 75mm flat base with ball, bolted through the tunnel with four **M6** Bolts.

It should be in a central, protected location on the central tunnel in front of the seats and both easily visible and accessible by both the driver and co-driver/nav.

Care should be taken when considering the location of the Mounting Point with regard to electrical cabling and fire suppression systems installed in the vehicle.

Photographs of mounting and positioning can be seen in Fig.1 and Fig.2 respectively.

Alternatively, the WRC tracking system unit can be mounted in a central protected location on the vehicle dashboard that is easily visible and accessible by both the driver and co-driver.

Mounting is a Ram style 50mm x 75mm flat base with ball, bolted with four **M6** bolts through the dashboard and a compulsory 3mm backing plate measuring no less than 145mm x 120mm

# 6. Antenna Installation

All leads on both external and internal antennas must run on the inside of all roll cage bars. This is to stop cable crushing on impact.

Antenna must not be mounted within 200 mm of any high frequency antenna's or cabling

The preferred route is to go down from the antenna, underneath the closest part of the roll cage (roof cross or main hoop), follow that along to the roof hoop, then go down the inside A pillar to the unit. Please allow 200mm clearance of high frequency antenna or cabling

Any excess cable must be run so that the cable is not bent any tighter than a 100mm radius. We recommend running it across the underside of the dash and back (do not coil in tight loops).

Cables must be tied neatly along the whole installation all the way to the unit so they can't be accidently caught or dislodged.

All this will be checked at scrutineering and you may be required to fix it before your car can pass.

Note: All antenna connections need to be firmly tightened with an 8mm spanner.

# 6.1. External Antenna

The antenna is mounted through a 12mm hole in a central location on the ROOF of the vehicle, rear of the main roll bar hoop, allowing the cabling to pass through the roof and follow the cage bars back to the unit location. The antenna is a fully watertight unit, which seals against the roof surface.



Antenna leads are connected as follows (There may be variations with the type and number of leads).

- 1. The 2 UHF leads, colour-coded **Blue**, is connected to the terminal labelled "WiFi" on the WRC unit (Right Hand Thread). Terminals are located of the rear of the unit and/or colour-coded Blue.
- 2. The Satellite Communication antenna lead is connected to the center or rear terminal labelled "IRI" (Left Hand Thread). It may also be colour-coded Yellow (this may be not marked on the 2-in-1 antenna).
- 3. The GPS antenna lead labelled "GPS", is connected to the terminal labelled "GPS" on the WRC unit (Right Hand Thread). Terminals may be on the side or rear of the unit and/or colour-coded **Green**.
- 4. GSM, has a small stick antenna supplied with the WRC unit, and is connected to corresponding terminal labelled "GSM" on the WRC unit (Left Hand Thread). The terminal is located on the rear of the unit and/or colour-coded **Red**.

# 6.2. Internal Antenna

The Internal Antenna should be placed on the inside of the ROOF in a clear uncluttered area, with a 200mm radius clear of any bar work or solid metal object. The internal antenna has a magnetic base with double-sided tape for adhesion. The cable is then run to the WRC unit. Please keep cable on the inner side of the roll cage pipework so as not to be crushed in the event of an accident.




Figure 3. The internal antenna must be at least 200mm away from any roll cage components
