









# 1. WELCOME AND INTRODUCTION

It is our honour to welcome you to Sweden and the 70th edition of Rally Sweden!

The rally will take place 9th - 12th of February in the region of Västerbotten in the north of Sweden.

Our second time in Umeå and we are looking forward to some proper snow stages.

#### **Locations**

The HQ, Media Centre and Service Park will be located at the Nolia Exhibition and Sports arena, in central Umeå.

Umeå's distinctive strengths, in addition to a stable winter climate, are good hotel capacity in combination with Service Park and HQ at the Nolia exhibition and sports area, strongly growing business community and an attractive catchment area in terms of audience.

#### **Route**

The total length of the route is 1175,96 km and the special stage length is 302,52 km. The rally has 43% new stages in the itinerary.

After the shakedown stage on Thursday morning 9th February, the start of the rally will be in the evening at the Red Barn Arena podium in Umeå followed by the first stage, Umeå sprint.

#### FIA Environment accreditation

Rally Sweden was the one of the first motor sport event in the world to achieve the accreditation "Achievement of Excellence" from the FIA Institute's environment programme. During 2022 Rally Sweden achieved Three stars, the highest level, in the FIA's environmental accreditation framework. Rally Sweden has thus received an important quality receipt for its environmental and climate work.

The move to Umeå meant that Rally Sweden could take several important steps towards the vision of zero emissions, Rally Towards Zero. Extensive use of fixed electricity from renewable and locally produced sources improved opportunities for visitors to get to the arenas by public transport and cooperation with several environmentally certified key suppliers were some of the environmental advances.

One factor is the number of print-outs made from various documents. Rally Guide 1 og 2 as well as the Supplementary Regulations will only be published on the event website.

We would appreciate all competitors joining us for this management by informing us early the number of Road Books needed (should be less than the regulatory package), so we do not end up throwing a lot of unused documents to recycling.

Those wishing to take part in Rally Sweden 2023 must register and fill in the electronic entry form published at <a href="https://registrations.fia.com/wrcswe">https://registrations.fia.com/wrcswe</a> (available from 7 December 2022) duly completed before the closing date for entries. The entry will only be accepted if accompanied by the total amount of the Entry fee. To be accepted, competitors must send a proof of payment of the entry fee by e-mail to the assistent secretary of the rally (<a href="mailto:vera@rallysweden.com">vera@rallysweden.com</a>) by the closing date of entries. Foreign drivers must submit an approval from their ASN.

Entrants who wish to score points in FIA Championships, must make their entries by using the electronic standard rally entry form for their championship, available in the FIA application at https://registrations.fia.com.

#### **4.3 ENTRY FEES**

#### 4.3.1 Manufacturer and other Championship entrants

# 5. SERVICE PARK 5.1 LOCATION

The service park will be established at Nolia Exhibition area in Umeå (see city map in Appendix 2).

Manufacturers and other championship entrants will be allocated a designated space in accordance with 2023 FIA WRC Sporting Regulations.

Legal and private entrants are allocated an area of  $10 \, \text{m} \times 10 \, \text{m}$ .

A provisional drawing of the service park is enclosed in Appendix 2 (Maps and drawings).

From this year we are proud to be able to replace the electricity that is produced by diesel generators at the service park, with 100% sustainable electricity from renewable energy sources. Distributed from the power grid with high availability.

### 9. HELICOPTERS

#### 9.1 HELICOPTERS

The Swedish Transport Agency, Civil Aviation Department, has declared the airspace above the rally area as "Restricted Area". Only helicopters registered with the organiser and following the instructions of the Swedish Transport Agency and the organiser, are allowed to operate in this area.

Note! All foreign Aerial Work operators must obtain permission for flying in Sweden from the Swedish Transport Agency. For further information please contact:

For safety reasons, the number of helicopters operating in the area will be limited to 30. In addition, briefing for all pilots is mandatory and at the briefing you will receive an information manual containing timetables, maps and information about the Service Park, the special stages, GPS coordinates, refuel information, radio frequencies to be used etc. An administrative fee of 10 000 SEK (excl. VAT) will be charged for this service.

Operators must send the registration form in Rally Guide 2, Appendix 5 Forms together with necessary permissions no later than 6th of February. The form will also be published on Rally Sweden website.

#### 19. MEDICAL AND SAFETY SERVICE

Medical information for Sweden

Citizens from the EU/EEA - countries will receive emergency medical care paying the same patient charge as Swedish citizens. Competitors from these countries must provide a European Health Insurance Card verifying that the person is covered by health insurance, when medical care is required, and should obtain this form before leaving their home country. Citizens from the Nordic countries are not required to provide the European Health Insurance Card.

Besides the EU/EEA-countries Sweden has an agreement with the following countries which guarantees the citizens emergency medical care at the same patient charge as Swedish citizens: Algeria and Australia. Competitors from these countries must also provide a European Health Insurance Card, EU card or corresponding document verifying that the person is covered by health insurance. Citizens in other countries than mentioned above must pay the total cost of treatment plus the patient charge.
