4. ENTRIES

4.1 Closing date: “ see Article 3 - Program”

4.2. Entry procedure

Entries will only be accepted if they are fully completed and the entry fee has been paid in full. Only online entries are accepted. Entry fees are only accepted via bank transfer. Foreign entrants, drivers, and co-drivers must obtain approval from their ASN (Agency of Sport) if it is not already indicated on their license and present it at the administrative scrutineering. **The organizing team requests that all participants submit their entries by the entry deadline.** This is the only way to ensure that the entry is included in the participant list in the program booklet. Entries received after the entry deadline cannot be included in the program booklet.

4.3 Maximum number of entries: 90

If the maximum number of entries is exceeded, those teams whose entries and entry fees were paid last will not be included in the entry list and will be placed on a waiting list. Priority drivers will generally be accepted. The organizer reserves the right to decide which teams are accepted, taking into account the current AMF regulations.

4.7 Entry Fee Refund

The entry fee will be refunded in full:

- to teams whose entries were rejected;
- if the event does not take place.

The organizer may refund 50% of the entry fee paid to applicants who are unable to start due to force majeure (properly certified by their ASN and submitted before technical inspection).

5. INSURANCE

AMF license holders are covered by accident insurance through their driver's license. Current coverage levels for disability, death, medical expenses, and repatriation can be viewed online at austria-motorsport.at.

The organizer takes out the following insurance policies, which are mandatory according to the licensing authorities:

5.1 Group accident insurance:

This applies to all persons involved in the execution of the event (especially officials and functionaries) and to co-drivers, as well as accredited journalists and photographers and holders of foreign driving licenses, unless they already have valid accident insurance with another domestic or foreign insurer.

The current AMF regulations for event organizer insurance are available online at www.austria-motorsport.at.

5.2 Event organizer liability insurance:

Event organizer liability insurance: Mandatory insurance with a minimum coverage of €10 million. The applicable AMF regulations and possible insurance options (liability coverage levels) for event organizer insurance can be viewed online at www.austria-motorsport.at.

Legal liability insurance is mandatory for all competition vehicles and must be taken out by the vehicle owner. This insurance must cover all damages on public roads, excluding special stages and shakedown. Proof of legal liability insurance must be provided during document checks.

Service, sighting and support vehicles with rally signs are not covered by the organizer's liability insurance.

In the event of an accident resulting in property damage, the participant is obligated to report it at the next time control and submit a detailed written report to the rally management at the end of the section. Failure to submit this report will result in a fine of €500, imposed by the rally director. Furthermore, in the event of personal injury, the driver must immediately inform the rally management via the emergency number as per Article 12.7.

6. VEHICLE IDENTIFICATION & ADVERTISING

Vehicle marking and advertising are governed by the provisions of AMF-RSR 2025 and Annex IV of these regulations. The materials will be provided by the organizer and must be put on the vehicles before technical inspection and remain in place throughout the event. Any event advertising or optional organizer advertising not yet defined in these regulations will be announced in an official bulletin.

Violations of this article will be punished by the rally director as follows:

7. TIRES "See AMF-RSR 2025, Article 13 and Annex "5"

7.1 Approved tires

Studded tires may be used provided the rim dimensions homologated for the vehicle are observed. Winter tires and studded tires may be used on 15" rims on all historic vehicles (Class 6).

The number of spikes must not exceed 12 per 1 dm² of tire circumference at any point. When using 17" or 18" rims, the tires must have a central, 47mm wide strip that is completely free of spikes. When using 14", 15", or 16" rims, it is not necessary for the tires to have a 47mm wide central spike-free strip, but the number of spikes is limited to 12 per 1 dm² of tire tread.

The spike check can be carried out at any time as part of the tire check and as follows: tread print, spike removal for carrying out control measurements.

For rally winter tires or tires with ECE homologation that do not have the inscription "M+S" engraved on the sidewall of the tire (equivalent, alternative designations are: "MS", "MS", "M/S", "M&S" or "MS"), the following spike regulation applies:

The maximum diameter of the spike plate is 6.5 mm, the maximum weight is 2 grams, the maximum protrusion beyond the new tire is 2 mm, and the maximum spike length is 15 mm with a tolerance of +/- 0.5 mm. Only spikes that are inserted into the tread from the outside are permitted. Spikes that pass through the tire are not permitted.

For all other road-approved winter tires with ECE homologation and which bear an engraving with the inscription "M+S" on the sidewall of the tire (equivalent, alternative designations are: "MS", "MS", "M/S", "M&S" or "MS"), both the spikes mentioned above and the spikes originally used by the tire manufacturer may be used, provided they comply with the latest version of the KFG (German Road Traffic Act).

The use of intermediate tires, rain tires, and gravel tires is prohibited. FIA tire homologations or the price lists of the respective tire manufacturers serve as the basis for determining which tires are prohibited. Historic vehicles (Class 6) and vehicles with a smaller homologated rim diameter are exempt from this regulation.

Manual cutting of the tread pattern of FIA-homologated asphalt tires is permitted, provided the manufacturer's current cutting pattern is followed. See FIA website "List of Cut Wet Patterns for Asphalt Tyres" (Art. 13.1.2 of the AMF RSR 2025).

7.2 Stage 14/17 WIMBERGER SuperSpecial : SPIKE BAN

This stage runs partly through company premises, including a passage through a building. Therefore, **the use of studded tires is prohibited on this stage (14/17)!** Participants who arrive at the start of stage 14/17 with studded tires mounted on their vehicles will not be allowed to start and will be considered to have retired.

7.3 Number of tires

The number of tires a participant may use in the competition is limited to **a maximum of 18**. Within this maximum of 18 tires, **a maximum of 12 studded tires** on 14", 15", or 16" rims in accordance with the respective vehicle homologation, **a maximum of 12 winter tires** (with or without studs) on 17" or 18" rims in accordance with the respective vehicle homologation, and **a maximum of 12 FIA-homologated tarmac tires** in accordance with the respective vehicle homologation may be used. Historic vehicles (Class 6), vehicles with a smaller homologated rim diameter, as well as Rallye4you, are exempt from this regulation.

Road-legal winter tires (with or without studs) are exempt from this regulation and can be used without restriction. There is no tire limit during the shakedown, free practice, and qualifying stages. Exceeding the maximum permitted number of tires will result in a penalty from rally control, amounting to **one minute per tire over the limit**.

8. FUEL AND REFUELATION

8.1 Catering during the event:

- x Fueling area in the service park area
- x all public petrol stations along the rally route

8.2 Additional Refueling

8.3 Fuel

Fuels must comply with the current specifications according to FIA Annex J, Article 266. Bioethanol E85 according to ÖNORM C 1114 is no longer permitted as a "commercially available fuel" in Austrian rallying. Vehicles powered by alternative fuels (i.e., fuels other than gasoline or diesel) must comply with the "AMF Regulations for Alternative Fuel Vehicles" and will be classified in the designated class.

9. RECCE

9.1 Registration and marking of recce vehicles

Registration and marking of the recce vehicles is required. The license plate number, make, and color of the inspection vehicle must be indicated when the roadbook is issued. Additionally, stickers for the inspection vehicles will be issued with the roadbook; these must be affixed to the front (e.g. , windshield) and rear (e.g. , rear window) of the vehicle.

9.2 Inspection regulations

9.2.1 Tracking System

The organizer will provide a tracking system for the route inspection. These devices will be distributed to participants along with the roadbook. The system must remain active throughout the inspection. The same device will be used for both the inspection and the competition.

A system that is switched off will result in a time penalty of 20 seconds for the first offense and 40 seconds for the second offense, issued by the Clerk of the Course and additionally reported to the Stewards. (Article 34.2.7 of the AMF-RSR 2025)

9.3 Recce schedule: see Appendix II

Participants are not obligated to recce.

The registration confirmation will contain a link to book a time slot. 11.3 Windows

The use of tinted or mirrored rear side windows and the rear window is permitted under the provisions of ISC Annex J Art. 253.11.

11.4 Driver safety equipment

During technical inspection, the helmets and FHR systems (e.g., HANS®) to be used during the event, as well as a list of flame-resistant clothing conforming to FIA Standard 8856-2000 or 8856-2018, must be presented. All equipment must comply with Annex L, Chapter III of the ISG.

11.5 AMF noise level regulation (according to AMF General Technical Regulations, point 3)

The noise limits apply to national, zonal, and international events. The stated limits apply in all cases (i.e., also to FIA-sanctioned rallies). The maximum permissible noise levels must be maintained throughout the entire competition. Measurement is carried out according to the near-field measurement method as per the "General Technical Regulations of the AMF Art. 3.4.1". The maximum limit of 98+2 dB (dBA limit) applies to all vehicles.

11.6 Safety Tracking System

All vehicles must be equipped with a safety tracking system. The equipment will be provided by the organizer and distributed at the roadbook distribution. Each team is responsible for installing the equipment according to the installation instructions. A deposit of €200 in cash will be collected from each team at the roadbook distribution point. This deposit, minus a €40 system usage fee, will be refunded upon return of the undamaged equipment. Returns must be made to the rally control office during official opening hours. Dismantling is permitted from the queuing point at the Freistadt finish line at the exhibition grounds or in front of TC 18a Parc Fermé IN.

The same device is used for both the recce and the competition.

A USB port (standard 5V) is required in the vehicle to power the devices; this must be provided by the participants.

A 1-inch Ram Mount ball is required to mount the equipment in the rally car and must be permanently installed. Teams can either purchase and install this 1-inch ball themselves, or they can buy it on-site at the event.

12. FURTHER PROCEDURES AND REGULATIONS

12.1. Shakedown, Qualifying Stage and Free Practice

12.1.1 Eligibility to participate

Only teams that have passed the administrative and technical inspection are permitted. Participation is only possible if all rules of a special stage are followed (markings and advertising complete, clothing as in the competition, etc.). The shakedown can be run an unlimited number of times within the time frame specified in the schedule. At the administrative inspection, participation in the shakedown must be registered and the shakedown fee of €75 must be paid (except for class RC2, for which the shakedown fee is included in the entry fee).

Any passenger on board the vehicle during the shakedown who is not registered for the rally in question must sign a waiver from the organizer and must wear safety clothing. This will be checked at the start of the shakedown.

12.1.2 Location and schedule of the shakedown

Location: Oberrachenödt - Mitterbach

Date: Friday, January 2, 2026

Time: 13:00 – 16:15

12.2 Qualifying Stage (including prior Free Practice)

To determine the starting order for the first leg, a qualifying stage, including prior free practice, will be held on the shakedown track in accordance with AMF RSR Article 37 before the start of the shakedown. During the free practice period, nominated participants may complete a maximum of two runs. The starting order and start times for qualifying will be determined by the qualifying start list.

12.2.1 Eligibility for the Qualifying Stage

Generally, only priority drivers in Rally2 cars are permitted to participate in qualifying, with a maximum of 15 participants. If fewer than 15 priority drivers take part in the rally, the rally director, in consultation with the stewards, may nominate additional participants for qualifying. If more than 15 priority drivers take part in the rally, the selection of those nominated for qualifying will be made by the rally director in consultation with the stewards.

12.2.2 Selection of starting positions for the 1st stage

The nominated participants may choose their starting position for the first stage in order of the qualifying results. The selection of starting positions will take place on Friday, January 2nd, 2026 at 6:30 PM on the stage in the Freistadt Exhibition Hall. Should a participant not be present for the selection, they will be skipped in the order and assigned the remaining position.

12.3 Special Stages

12.3.1 Power Stage

For the participants in the Austrian Rally Championship 2026 (ORM, ORM2, ORM3 and ORM-Junior) the special stage 18 (LEITNER Forst- und Erdbau 2) is defined as a "Power Stage" according to AMF-RSR Art.50 (see Annex I - Schedule).

12.3.2 Start of the special tests

The start of the special stage is indicated by a digital countdown system, which clearly displays the elapsed seconds for the participants at the starting line. The timing system includes a light barrier 50 cm behind the starting line at a height of 50 cm (+/- 5 cm), which is used to detect false starts. The vehicle must be positioned at the starting line so that its front end is aligned with the line.

The following light signals are displayed:

-30 sec: the starter points to the countdown system

-5 seconds: the symbol on the countdown changes from red to yellow

0sec: Start – the symbol on the countdown changes from yellow to green

+20 seconds: the symbol on the countdown changes back to red , according to Article 48.4.3 of the AMF RSR 2025

Should the digital countdown system fail, the start will be initiated by the timekeeper.

12.3.3 Rules for the start of circuit races

The race starts when the light turns green or after a hand signal from the starter, and the start time is determined by the light barrier 50cm after the starting line.

If the start occurs at the usual intervals (approximately 1 minute), the timekeeper will display a card marked "5sec" approximately 5 seconds before the green light appears. If the start interval is different than usual, the timekeeper will display a card with a STOP symbol. The "5sec" card will be shown 5 seconds before the green light appears. Starting on a red light is strictly prohibited!

12.4 Early entry

12.5.2 Allocation and equipment of service stations

Each team will be provided with a service area. A service area deposit of **€50 per team** will be collected during the administrative check-in. This deposit will be refunded if the service area is left clean. Refunds **are possible until Sunday, January 4, 2026, 20:00** (after which the deposit expires!).

12.5.3 Behavior in the service park

Only competition vehicles and service vehicles displaying the official organizer's "Service" sign are permitted to enter the designated service areas in the service park. Vehicles with a Recce sticker must be parked in the designated parking areas. The surface of the service park must not be damaged. No nails, screws, or similar objects may be driven into the surface. The team is liable for any damage that may occur in its assigned service area. Austrian environmental regulations apply. In particular, and additionally, the following applies:

1. A liquid-tight tarpaulin (e.g., environmental mat) measuring at least 5 x 2 meters must be placed under each competition vehicle on the service area to protect the ground while work is being carried out.
2. The service work must not cause any lasting, avoidable, environmental damage.
3. Vehicles may only be refuelled in the designated refuelling zone (s) and in accordance with Article 61 of the AMF-RSR 2025.
4. To ensure the proper return of the service area, each team must pay a €50 deposit upon document check-in. The deposit will be refunded to the team after the assigned service area has been returned in good order. The deposit does not replace any potential compensation payment by the team for damage caused by the team.
5. Unreasonable or willful behavior by a team that contradicts environmental protection goals fundamentally damages the reputation of motorsport and should therefore be sanctioned – even if detailed regulations are lacking. The service area must be left in a tidy condition after the event. Any waste and liquids generated must be disposed of properly by the team itself.

12.5.4 Catering in the service park

Catering in the service park is only permitted with the organizer's written consent (to be obtained by the entry deadline). In this case, the organizer reserves the right to charge a fee for electricity and waste disposal. This does not apply to the self-catering needs of the teams, particularly drivers and mechanics. The sale of food and beverages in the service park is strictly prohibited.

The use of liquid gas for cooking and heating purposes is prohibited throughout the entire service park!

12.5.5 Advertising activities in the service park

All advertising activities (e.g. distributing flyers, sampling, sales stands, etc.) in the service park must be agreed upon with the organizer before implementation.

12.5.6 Removing vehicles from the park Fermé after the end of the rally

All rally cars must be removed after the Parc Fermé opens **by 20:00 the latest**. Should participants fail to remove their vehicles from the Parc Fermé in time, the organizer needs to remove the vehicles from the Parc Fermé. Any costs incurred will be billed to the affected participants.

12.5.7 Early entry to the service area

The service park will generally open on Thursday, January 1, 2026, from 12:00. Earlier access to the service area is possible if the following conditions are met:

- Please send your written request to office@jaennerrallye.at by 18:00 on December 28, 2025, specifying your desired time slot for entry into the service park.
- Advance payment of the fee of EUR 250,- for early occupancy of the service area to the organizer's bank account (account details see 4.6)
- written confirmation from the organizing team

An unannounced early entry into the service park is not permitted (except with a normal car for roadbook distribution). Should any participant or their service team enter the service park early without prior notice and block the spaces of other participants, a penalty fee of EUR 1,000 will be charged! If this penalty fee is not paid before the start of the event, the affected participants will not be allowed to start!

12.5.8 Entrance and exit to Service G and Service H

Since studded tires are not permitted on Stages 14 and 17, but are allowed on Stages 15 and 16, there is an opportunity to change tires at Service G and H. For organizational reasons, entry to and exit from Service G and H will be controlled by a pass control rather than a time control. This pass control will be monitored via the GPS tracking system – therefore, stopping at the entrance or exit is not necessary. Six minutes are allotted for each Service G and H, which is already included in the road section time between TCs 14 to 15, and 16 to 17 respectively.

12.5.9 Entry into the Overnight Park Fermé ZK 10b also possible by team members

To ensure that drivers and co-drivers do not have to wait until the end of the service time after Leg 1, it is permitted for the applicant's authorized representatives, e.g., team members, to drive the vehicle from Service D to TC 10b Parc Fermé IN

12.7 Participant safety

12.8 Starting order and starting intervals

The starting order is determined by the starting times in the starting lists.

Stage 1 on Saturday, January 3, 2026

The participants nominated for qualifying will start at the front of the field in 2-minute intervals, in the order of their selection. All remaining participants will start at 1-minute intervals in order of their starting numbers, although the rally organizers may make changes to the starting order for valid reasons.

Stage 2, Section 5-6, on Sunday, January 4, 2026

Starting order based on the results of Leg 1, with the first 10 participants being reversed. Restart participants will be seeded at the discretion of the Clerk of the Course. Starting interval for the first 10 participants: 2 minutes, all others: 1 minute.

Stage 2, Section 7 (Powerstage) on Sunday, January 4, 2026

Starting order based on the results after SS16, with the first 7 participants being reversed. Should this not be possible due to the preceding events, the Clerk of the Course, in consultation with the chief timekeeper and the live TV production team, will decide on the starting order. The starting interval for the first 7 participants is 2 minutes, all subsequent participants 1 minute.

12.9 Ice Spies “Ice Crew”

Each participant has the option of using “ice or gravel spies.” These vehicles are permitted to drive on the special stages during the restricted time and between the first and second runs, according to the Ice Crew schedule. A special sticker is required on the vehicle for this purpose. In winter road conditions, Ice Crew vehicles must either be equipped with all-wheel drive or, in case of front- or rear-wheel drive, with studded tires – with the exception of Stage 14/17 SuperSpecial Freistadt: the studded tire ban on this stage also applies to Ice Crew vehicles. Ice Crew stickers, including a separate roadbook for the Ice-Crew, can be purchased for €100 at the roadbook distribution point or during administrative scrutineering.

12.10 Drivers' briefing

A drivers' briefing will be held before the rally (see Article 3, Program). Drivers and/or co-drivers of a team are required to attend. Failure to attend will result in a fine of EUR 100 imposed by the Clerk of the Course; repeated failure to attend will be reported to the stewards, who will issue a time penalty.

12.11 Accessibility of participants

Participants who leave their vehicle in the Parc Fermé after crossing the finish line must be reachable at all times until the official final result is posted, using the "team mobile phone number" indicated on the entry form.

12.12 Lead Cars (Safety Caravan)

The Safety Caravan consists of the safety vehicles (spectator safety, overall safety, 000, 00, 0, 0A, and the sweeper car) and the officials' vehicles. VIP or sponsor vehicles are not part of the lead vehicles. All vehicles are assigned specific safety tasks as outlined in the FIA Safety Guidelines. All vehicles and their crews must be clearly marked. They must be in communication with Rally Control. The 000 and 00 cars should be standard road cars, while the 0 and 0A cars should be rally cars. All safety vehicles (except the 0 and 0A cars) must have flashing lights and sirens and should be equipped with public address systems. The 0 and 0A cars may have warning lights but must use a siren. The 000, 00, and 0 safety vehicles must use time cards, the roadbook, the safety plan, and other event documents. Pacenotes are not permitted in safety vehicles 000 and 00. All safety vehicles must complete the entire course and pass through all time controls. Safety Caravan vehicles must be driven at a speed that allows them to identify, stop, and resolve any issues. Vehicles 0 and 0A should be driven at 70%–80% of the competition speed. Violations will be penalized by the stewards.

12.13 Onboard cameras for live streaming

The organizer intends to offer a live streaming service during the event and broadcast selected stages live on Austrian national television ORF Sport+, ORF on, and other online platforms. For this purpose, onboard cameras, provided by the organizer, will be installed in selected vehicles. By submitting their entry, participants agree that the organizer or persons authorized by them may install these onboard cameras in the competition vehicles. Affected participants will be contacted by the organizer no later than December 29, 2025, to arrange a date for the installation of the onboard camera system in their vehicle.

12.14 Restart option during a Leg

After a retirement, participants can choose between a standard restart (see AMF-RSR 2025, Art. 54) at the next stage or a restart in the same Leg via Rallye4you (AMF regulations for Rallye4you, section 2, procedure). Resumption via Rallye4you is possible at any time from the next special stage. This must be announced in advance by calling the emergency hotline (+43 676 532 5158) at Rally Control. In the event of an accident, a check from the Chief Scrutineer is required. This also applies to Sprint classification participants. Once switching to Rallye4you, it is not possible to return to the main field, not even for the next leg.

12.15 Sprint classification

The Jännerrallye Sprint classification is a separate classification for participants who only wish to take part in the first leg on Saturday, January 3, 2026. This classification is the most economical option for participating in the Jännerrallye. Sprint classification participants will be included in the main field of participants during the driver presentation and the start list for the first stage. However, the Sprint classification will only be held and prizes awarded on Saturday evening if at least 5 participants start it (TC 0). Should fewer than 5 participants start, these max. 4 Sprint participants will automatically be included in the regular Jännerrallye classification and can participate in both legs without any additional entry fee.

NON-LIABILITY CLAUSE

The participants are aware of, understand and fully accept the risks and dangers involved in motor racing. Should a participant be injured during an event, he explicitly declares through his entry for the event that he approves all medical treatment, rescue and transportation to hospital or other emergency facilities. Such measures will be adopted by personnel appointed specifically for this purpose by the promoter, to the best of the personnel's knowledge and following their assessment of the participant's condition. The participants undertake to assume all related costs, provided such costs are not covered by the license accident insurance or other insurance policies.

The participants hereby waive all direct and indirect claims for compensation from AMF, its officials, the promoter and/or organizer or the racing circuit owners, from any other person or association linked with the event (including all officials and authorities or bodies who have granted licenses for the event), and from other entrants and drivers/riders, hereinafter referred to as "the parties". The participants do so for themselves and their legal successors, and consequently for any insurance company with whom they may have concluded additional policies.

In submitting their entries for this event the participants hereby declare that they irrevocably and unconditionally waive all rights, appeals, claims, demands, acts and/or proceedings which they themselves might institute or which might be instituted by third parties acting on their behalf against "the parties". The participants do so in connection with injury, loss, damage, costs and/or expenses (including lawyers' fees) which they may incur due to an incident or accident as part of the event. In submitting their entries for this event the participants irrevocably declare that they discharge, release and relieve "the parties" for all time from any liability for such losses, and that they shall guard them against such losses and keep them harmless.

- Any dispute arising between the participants and the AMF or its officials, and the promoter and/or organizer, and between the AMF or its officials and the promoter and/or organizer, as a result of claims (personal injury, damage to property or financial damage) in connection with the motor-racing event, training sessions or races shall be settled definitely by an arbitration tribunal to the exclusion of the courts of general jurisdiction.
- The arbitration tribunal shall consist of three arbitrators, namely the umpire and two assessors. The umpire shall be a lawyer or former judge and have experience of liability matters in connection with motor racing.
- Each party shall appoint an assessor within two weeks of notification of the intent to initiate arbitral proceedings. Should the dispute be referred by several claimants or be leveled at several defendants, the arbitrator shall be appointed by agreement between the joined parties. The assessors shall elect the umpire. Should the assessors be unable to agree on the person of the umpire within two weeks, the umpire shall be appointed by the President of the Vienna Chamber of Lawyers upon application by an assessor, with due regard to clause b). The assessors shall however be free at any time to replace the umpire appointed in this way by another umpire by mutual agreement.
- Should a party fail to appoint its assessor within two weeks of receiving the written request from the opposite side, or should several joined parties be unable to agree on an assessor within that period, the assessor shall be appointed by the President of the Vienna Chamber of Lawyers on the motion of the other party. The same shall apply should an assessor withdraw from office and the party concerned not appoint a successor within two weeks.
- Should an arbitrator not assume office, refuse to discharge his duties, cause improper delay or become unfit to act, the aforementioned provisions shall apply accordingly for the appointment of a replacement. The arbitrator concerned shall be dismissed at the same time.
- The arbitration tribunal shall in principle be free to conduct its proceedings as it sees fit, with due regard for the subsidiary legal commissions. The tribunal shall sit in Vienna. The arbitration tribunal may also investigate without petition any circumstances which it deems necessary to clarify the facts of the case, and take evidence.
- The arbitration tribunal shall decide by simple majority. The tribunal shall state the full reasons for its award. It shall also decide on cost apportionment for the costs of both the arbitration proceedings and the legal representation. The arbitrators shall be remunerated in accordance with the commissions of the Austrian lawyers' scale of charges.
- The arbitration tribunal shall also be entitled to the exclusion of the courts of general jurisdiction to issue injunctions, provided the opposing party is first given an opportunity to express its views. An injunction may also be lifted upon petition in the event of a significant change in circumstances.
- Sports jurisdiction shall remain unaffected by the present Arbitration Agreement.

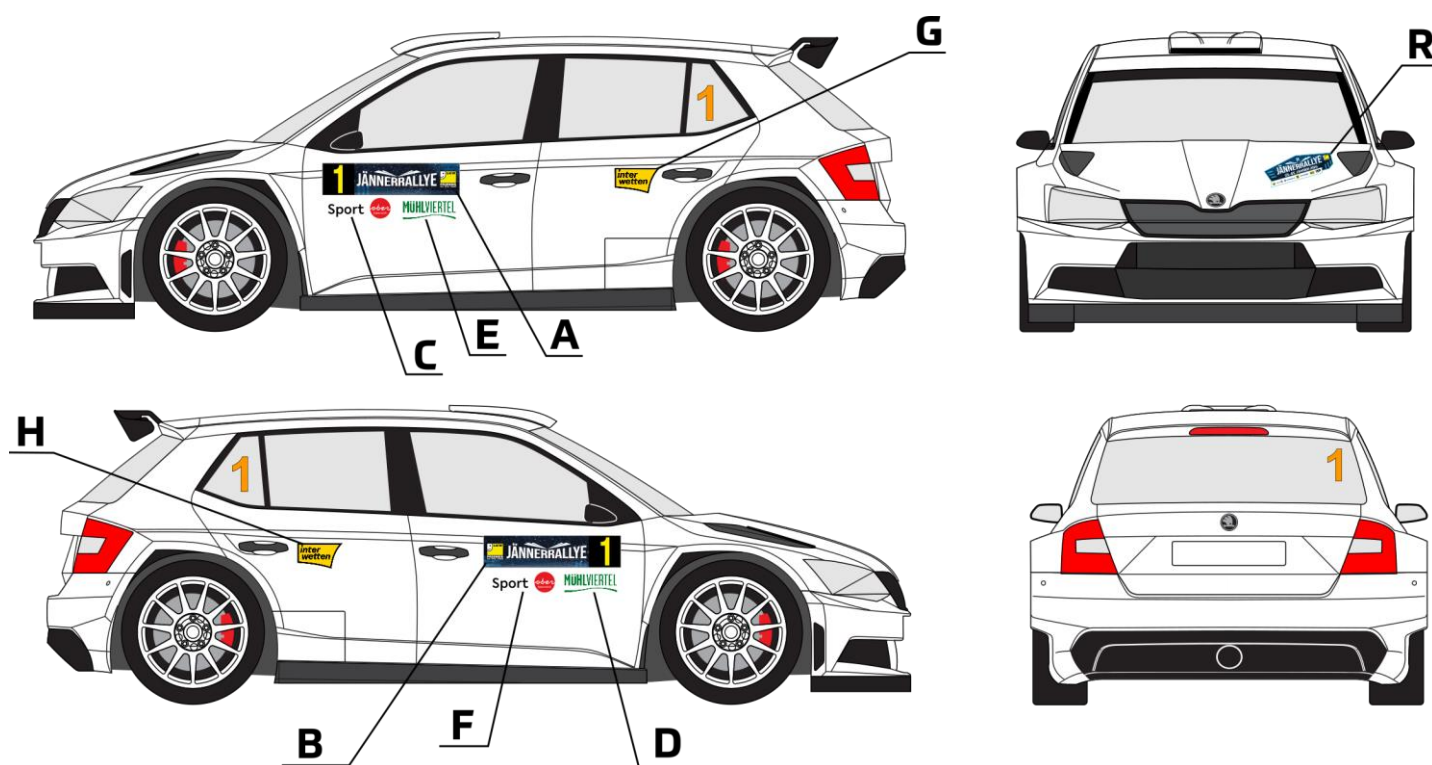
