## 2.9 Communication and the Official Notice Board

During the event, individual and general communication between all Rally Officials (Rally Control/COC, Rally Secretariat, CRO, Stewards, Technical Staff etc.) and the competitors/crew members will primarily and as far as possible be conducted via Sportity App.

For this purpose, each competitor is required to nominate ONE official representative authorized for the purpose of receiving any official notifications. As some of these notifications can be issued while rally cars are on stages, this person can neither be the driver nor the co-driver. This person should be a team representative who is based in the Service Park during the event.

This contact (name, title, cellphone, email) must be nominated no later than **Tuesday 14 April 2026** and sent by email to the Secretary of the Rally: [entry@rallyislascanarias.com](mailto:entry@rallyislascanarias.com) and will be used both for general and individual communications.

As provided for in 2026 FIA International Sporting Code, Art. 11.9.4, the Official Notice Board will be the Digital Notice Board (DNB), available in the Sportity App and published also on the rally website at [www.rallyislascanarias.com](http://www.rallyislascanarias.com). There will be no physical official notice board. All competitors will be informed only by Sportity notifications about the publication of any documents on the Digital Notice Board. Sportity app is downloadable for iOS devices on Appstore and for Android devices on Google Play. Channel password is **WRCESP2026**.

## 4. ENTRIES

### 4.1 Closing date for entries

Monday 23 March at 23:59 hrs (CET).

### 4.2 Entry procedure

Competitors in the FIA Manufacturers/Teams, WRC2, WRC3, Junior WRC Championships and Masters Cup, wishing to participate in Rally Islas Canarias - Rally of Spain, must register on the FIA's on-line platform before the entries closing date and fill in the electronic entry form published at <https://registrations.fia.com/rally> before the closing date for entries.

Any driver in the WRC2 Championship wishing to participate in Rally Islas Canarias – Rally of Spain, but not wishing to collect points for their championship, must also use the standard FIA entry form as for all point collecting events (see FIA WRC, Art. 6.2.3).

Any driver in the WRC3 Championship wishing to participate in Rally Islas Canarias - Rally of Spain, but not wishing to collect points for their championship, must use the non-priority entry form as detailed below.

Any non-priority driver wishing to participate in Rally Islas Canarias - Rally of Spain in Classes RC1 - RC5, must register and fill in the electronic entry form available at <https://registrations.fia.com/wrcesp> duly completed before the closing date for entries.

Please note that as the FIA system requires a user ID and a password to access the entry system, so the entry procedure cannot be left to the last minute but must allow time for the FIA to open the necessary user account.

By sending an electronic form, the competitor undertakes to abide by the rules and regulations of the competition, as well as the prescriptions of the 2026 FIA WRC Sporting Regulations, Article 22.5. Each competitor is required to submit a scanned copy of their signed FIA entry form.

The entry will only be accepted if accompanied by:

- The total amount of the entry fee. To be accepted, competitors must send a proof of payment of the entry fee by e-mail with the VAT-number of the company (if paid by such) to: [entry@rallyislascanarias.com](mailto:entry@rallyislascanarias.com) by the closing date of entries. Foreign drivers must submit an approval from their ASN in the same e-mail.
- After online registration, competitors must send simultaneously by e-mail to [entry@rallyislascanarias.com](mailto:entry@rallyislascanarias.com), the following scanned documents in PDF format:
  - Competitor's international license
  - Drivers' and Co-drivers' international competition licenses
  - Drivers' and Co-drivers' valid driving licenses
  - Drivers' and Co-drivers' passports or identification
  - ASN authorisation, for all foreign drivers and co-drivers
  - Completion of all details on the entry form
  - Car insurance cover certificate
  - Car registration papers
  - Car's owner authorisation to participate in the rally
  - First page of car homologation papers (NOT for Rally1 cars)
  - **Copies of the insurance cover for repatriation (non-Spanish crews)**
  - **Driver Declaration and undertaking duly signed by the driver and co-driver**
  - **Copy of the entry form duly signed**

In case of lack of documents requested above, the Organiser may reject the application.

Confirmation of registration will be sent by mail and with the publication of the Entry List.

Without Payment and proof of it received by the Organiser before entries close, the Competitor will not be included on the Entry List.

By sending an electronic form, the competitor undertakes to abide the rules and regulations of the competition, as well as the prescriptions of the 2026 FIA WRC Sporting Regulations. Competitors' representatives are required to bring the signed entry form to the Administrative Checks. Competitors must present in the administrative checks the originals of the documents requested above.

By making their registration, the Competitor / Driver / Co-Driver agree that their data will be processed within the scope of the rally organisation, publication of photos and media on the site: [www.rallyislascanarias.com](http://www.rallyislascanarias.com).

### 4.3 Number of entries accepted and classes

The maximum number of entries is **100**. If more than 100 entries are received, the Organisation, in agreement with FIA, WRC Promoter and RFEDA, reserves the right to decide which entries among the non-priority crews will be accepted. Such decision will be at their absolute discretion and may be made based on any criteria they decide.

Eligible cars: classes in accordance with Art. 12.4 of the 2026 FIA WRC Sporting Regulations.

### 4.4 Entry fees / entry packages

Entry fees for Manufacturers, WRC Teams, WRC2 and WRC3 competitors registered in the World Rally Championship as stipulated in the 2026 FIA WRC Sporting Regulations, Appendix VI, with local VAT (IGIC) to be added (7%).

Entry fees for non-priority competitors:

- Legal entity as competitor 6.900 € + 7 % IGIC
- Private competitor 4.560 € + 7 % IGIC
- Private competitor from Spain 4.250 € + 7 % IGIC
- Private competitor from Canary Islands 3.400 € + 7 % IGIC (entries in class RC2)
- Private competitor from Canary Islands 2.650 € + 7 % IGIC (entries in classes RC3, RC4 or RC5)

Fee for reconnaissance only 2.500 € + 7 % IGIC

**Legal entity as competitor** the Competitor is a company or other legal entity

**Private competitor** the Competitor is the driver or the co-driver

**Private competitor from Spain** the Competitor is the driver or the co-driver with Spanish passport

**Private competitor from Canary Islands** the Competitor is the driver or the co-driver with Spanish passport and resident on Canary Islands

The Competitor, whether priority or non-priority, whether a legal entity or the driver/co-driver, must have a valid FIA International Competitor's Licence.

The participation in Shakedown is included in the entry fee.

#### 4.4.3 Additional space in the Service Park

Service requirements forms are available on the rally website. Any competitor requiring more space and/or a different layout than included in the entry fee must submit his/her request together with the entry form before the entry closing date at the latest. Requests received after **Thursday 26 March 2026** will be charged with a doubled price and are subject to the availability and organiser agreement.

##### Manufacturers

- a. Space strictly as the figures given in Appendix VI of the 2026 FIA WRC Sporting Regulations.
- b. Additional car(s) as per Appendix VI: Depending on available space after allocation pursuant to a) above, on a first-come-first-serve basis.

##### Support Championships (WRC2 & WRC3)

Space strictly in compliance with the figures given in the Appendix VI of the 2026 FIA WRC Sporting Regulations. Additional m<sup>2</sup> of service space can only be booked for an additional fee of 50 € plus 7% IGIC per m<sup>2</sup> and are subject to availability and organiser agreement.

##### Other competitors

Space according to the size booked with the entry (14x10 or 10x10). There are no intermediate sizes to the above-mentioned areas. Additional m<sup>2</sup> of service space can only be booked for an additional fee of 50 € per m<sup>2</sup> + 7% IGIC to be added and are subject to availability and organiser agreement.

#### 4.5 Payment details

The entry fees must be paid by swift bank transfer or deposit to the organiser's bank account as follows:

When paying by Swift Bank Transfer, it is essential that you provide details of this payment by mail ([secretaria@rallyislascanarias.com](mailto:secretaria@rallyislascanarias.com)) to ensure that payment is duly receipted prior to the close of entries.

##### Cheques are not accepted.

The competitor who wishes to receive an invoice for the registration fee, must send an-email to [secretaria@rallyislascanarias.com](mailto:secretaria@rallyislascanarias.com) with billing details. Only under these conditions you will receive the respective invoice.

#### 4.6 Refunds

Entry fees will be refunded:

- To candidates whose entries have not been accepted – 100% refund
- In the case of the rally not taking place – 100% refund
- In the case of the rally not taking place in case of an event outside the control of the Organiser and accepted by FIA as 'force majeure' – 75% refund

The Organiser may partially refund the entry fee to those competitors who, for reasons of "force majeure" (duly certified by their ASN), were unable to start in the rally and excused themselves before the start of the Administrative Check. The crews who do not excuse themselves will be reported to their respective ASN and the entry fee will not be reimbursed.

## 5. INSURANCE

### 5.1 Description of the insurance cover:

According to the existing Regulations in Spain the insurance policy arranged by the Organisers covers the guarantees required by the RFEDA (ASN):

- Liability to third parties, in accordance with Spanish Legislation
- For personal injury up to a limit of 70 million euros per occurrence
- For property damage up to a limit of 15 million euros per occurrence

The insurance cover will come into effect at the start of the rally and will cease at the end of the rally or, at the moment of retirement or disqualification of the crew. Vehicles taking part at the Shakedown will be also covered by this policy.

By submitting their entries, competitors declare that a car owner's liability insurance with a minimum liability insurance cover for the vehicle to be used exists without restriction.

Competitors are reminded that the reconnaissance is **not** covered by the above insurance and competitors must make their own arrangements.

In the event of an accident, the competitor or their representative must notify the Clerk of the Course in writing as soon as possible and within a maximum of 24 hours. The notification must include an explanation of the circumstances under which the accident occurred, as well as the names and addresses of any witnesses.

Competitors are reminded that only the damage caused by the Organisers and the entered drivers are covered by the insurance policy taken on by the Organisation. Injury to the drivers themselves or damage to participating cars are not covered by this insurance.

Competitors are free to take on at their own convenience any individual insurance policy that they deem fit, independently from the liability insurance above-mentioned.

In case of an accident, competitors and drivers agree to hold harmless and keep indemnified the event's promoters and Organisers against all claims.

The service vehicles, even those bearing special plates issued by the Organisers, may never be considered as official participants in the rally. They are therefore not covered by the insurance policy of the rally and remain the sole responsibility of their owner.

### 5.2 Costs for medical care

Competitors/drivers/co-drivers acknowledge, that full costs in connection with medical care (except first aid treatment and transportation) go to the expense of the patient. It is recommended to take out a policy which covers the costs if it is necessary.

## 6. ADVERTISING AND IDENTIFICATION

The organiser will provide each crew with competition numbers and rally plates according to the 2026 FIA WRC Sporting Regulations Art. 27, which must be affixed to the car in the stated positions prior to scrutineering as shown in Appendix 4 of these regulations and must be visible through the entire duration of the rally.

All advertising or sponsorship of tobacco products on clothing, complements, instruments, equipment, prototypes and / or vehicles of teams participating in motor sports competitions or events are banned by law.

## 7. TYRES

### 7.1 Tyres specified for use during the rally

In addition to complying with Articles 13,14 and 15 of the 2026 WRC Sporting Regulations, the following quantities and type of tyre are confirmed for use.

All 4WD cars must use tyres from the FIA nominated tyre company HANKOOK. If tyres are purchased before the rally, such tyres must be presented to the supplier before pre-rally scrutineering for barcode and RFID checking (2026 FIA WRC Sporting Regulations, Article 13.2.1).

For all 2WD cars the make and type of tyre is free. However, competitors are reminded to comply with:

- 2026 FIA WRC Sporting Regulations, Article 13.1.4;
  - Each tyre must have barcode numbers supplied by the 2026 FIA-approved barcode supplier.
- 2026 FIA WRC Sporting Regulations, Article 13.3.1;
  - At pre-rally scrutineering, the tyre manufacturer will be recorded by the FIA.
  - During the whole rally, all tyres must come from the same tyre supplier.
- 2026 FIA WRC Sporting Regulations, Article 13.3.2;
  - Tarmac tyres must comply with Appendix V and be homologated by the FIA (see list published on FIA Website).

For RGT cars, see Article 13.4.2 of 2026 FIA WRC Sporting Regulations.

### 7.3 Tyre orders

Tyre orders must be placed no later than on **Thursday 26 March 2026** using the HANKOOK Order Form (available on the rally website).

### 7.4 Tyres for use on Reconnaissance

Only E- or DOT- approved homologated road legal tyres are allowed.

### 7.5 Tyre marking zones

Tyre marking zone are located between the TC Shakedown "TCSD" and Start Shakedown, TC 0, TC 1C, TC4C, TC7E, TC10C and TC14E.

## 8. FUEL

All Priority drivers must use FIA fuel as provided by the FIA appointed supplier.

See also Articles 61 and 62 of the 2026 FIA WRC Sporting Regulations.

The supplier appointed by the FIA is TotalEnergies. Supply, refuelling services and fuel orders will be handled by Sodifuel.

For environmental and safety reasons, all competitors must refuel in the designated refuel zones. Refuelling is not allowed in the Service Park (no refuel from cans, drums or similar except as detailed in Article 58 of the 2026 FIA WRC Sporting Regulations).

### 8.1 Ordering procedure and price per litre

The fuel order form, available on the rally website competitor's area, must be sent by email to [totalenergies-wrc@sodifuel.com](mailto:totalenergies-wrc@sodifuel.com)

The cost of the FIA fuel is € 9,95 + VAT per litre. Only credit card payment or pre-payment by bank transfer is accepted. A copy of the transfer must be sent to Sodifuel before the deadline of the orders.

### 8.2 Closing date for ordering FIA fuel

Fuel orders must be placed no later than on **Thursday 26 March 2026**.

### 8.3 Distribution for non-priority drivers

Non-priority drivers may use either FIA fuel following the same conditions and rules as the Priority drivers or at commercial filling stations marked in the Road Book.

### 8.4 Refuelling procedure

Crews are required to remain outside their cars during the refuelling. A member of the crew will open the vehicle to allow an operative to attach the pipework. The crew will be responsible for indicating to the refueller the amount of fuel required. The crew only shall close the vehicle and secure the opening once the requested amount of fuel has been added. The use of mobile phones and radio communications is forbidden at the Refuel Zone.

## 9. RECONNAISSANCE

### 9.1 Procedure for registration

Prior to reconnaissance, all crews must complete a registration form and collect a recce vehicle identification at the Rally Headquarters (see Article 3.2). The material will be given to the drivers personally or to the nominated representative.

The identification number panels (small format) must be affixed to the upper side of the windscreen and of the rear window, in the center. The fluorescent orange numbers issued must be placed at the top of both rear side windows. All identifications must be kept visible for the whole duration of the recce period.

Should a crew's reconnaissance car be replaced for any reason, the Rally Office must be informed of the details of the replacement car.

### 9.2 Tracking system for reconnaissance

With reference to Article 35.4.4 of the 2026 FIA WRC Sporting Regulations, all competitors must make one iOS or Android smartphone available and equip their reconnaissance cars with a smartphone-based application RSLite developed by the FIA official supplier STATUS AWARENESS SYSTEM (SAS).

SAS will distribute individual event access codes during the reconnaissance registration.

RSLite app must be kept active at all times when the reconnaissance car is driven (also in road sections) and the smartphone must be kept charged. Any misuse will be reported to the Stewards.

Rental of smartphones are also available from SAS, to be requested when completing the access code purchase on the SAS website and collected on **Monday 20 April 2026** (See Art. 3.2).

### **Access Code Costs:**

All competitors: €40 + Optional Smartphone Device Rental €100

Payment must be done online and in advance on the SAS website: <https://wrc.statusas.com/shop/recce/>

The smartphones shall be returned as soon as possible after the recce has finished at the SAS truck in the Service Park. If used for a route note crew, then latest on Sunday 26 April 2026 (See Art. 3.2).

## **9.3 Timetable**

Reconnaissance will take place according to the time schedule in Appendix 2.

## **9.4 Running of reconnaissance**

Each crew is limited to two (2) passages on each special stage. Every special stage run twice is considered to be one (1) stage. A maximum of two (2) reconnaissance runs are permitted also over the Shakedown stage.

A reconnaissance Road Book will be issued. Following the Reconnaissance Road Book itinerary is recommended according to the time schedule in Appendix 2.

However individual route may be followed within the foreseen date and time scheduled.

### **9.4.1 Direction**

Each crew may drive the special stages only in **the same direction as the rally**. The crews must always enter and leave the special stages through the start and stop controls.

### **9.4.2 Respect of traffic laws and driving behaviour**

All Road Traffic Laws must be strictly observed and the safety and rights of other road users must be respected during reconnaissance. All crews must drive in a manner that does not endanger or inconvenience other traffic or people living near the stages. Competitors must bear in mind that the special stages are not yet closed to public or residential traffic during recce.

### **9.4.3 Number of persons on board**

During each passage through a special stage, a maximum of two (2) persons are permitted in the car.

### **9.4.4 Maximum speed**

At all times the maximum speed on special stages will be 80 km/h (40 Km/h on SSS1 and SSS 14. See Art. 12.12) unless a lower limit is indicated by traffic signs, by signs placed by the organiser, in the Road Books, Recce Roadbooks or in a Bulletin.

All crews are reminded of Article 34.2 in the 2026 FIA WRC Sporting Regulations. The fitting or carrying of radar detection equipment is not permitted.

### **9.4.5 Reconnaissance card**

There will be no signing of a recce timecard. In accordance with Art. 35.4.3 of the 2026 FIA WRC Sporting Regulations there will be Control Marshals at the start and stop point of each special stage to record the number of passages. All passages through the Special Stages will be recorded by the reconnaissance trackers and monitored by the Organiser.

### **9.4.6 Reconnaissance vehicles**

All cars used for reconnaissance must comply with the prescriptions of Article 35.1 of the 2026 FIA WRC Sporting Regulations.

### **9.4.7 Service during reconnaissance**

In compliance with Article 35.4.7 of the 2026 FIA WRC Sporting Regulations.

### **9.4.8 Tyres**

For reconnaissance tyre regulations see Article 7.4 of these Supplementary Regulations.

## 9.5 Participation in reconnaissance only

Any driver holding the appropriate international competition license and not entered in the rally may apply to take part in reconnaissance of the special stages. The regulations must be respected in their entirety. The Organiser must approve the application.

Closing date for entries in reconnaissance only is **Monday 30 March 2026**.

Participation in reconnaissance is not allowed for drivers entering as Route Note Crews for the rally.

A Reconnaissance Registration Form is available on [www.rallyislascanarias.com](http://www.rallyislascanarias.com) under the section 'Forms'.

The fee for reconnaissance only is € 2.500 + 7% IGIC.

## 10. ADMINISTRATIVE CHECKS

### 10.1 Procedure

Administrative checks will take place at the secretariat of the Rally at the Stadium Gran Canaria.

Notwithstanding of the 2026 WRC Sporting Regulations, Article 30.1, drivers and co-drivers are not required to report personally to the administrative checks. Each Competitor shall nominate in advance to the Organiser one authorised representative to complete administrative checks and collect the recce and rally materials and documents (see Art. 3.1, closing date for representative nomination is **Tuesday 14 April 2026**).

#### Documents to be presented

- Competitor's international license
- Drivers' and Co-drivers' international competition license
- Drivers' and Co-drivers' valid driving licence
- Drivers' and Co-drivers' passports or identification
- ASN authorisation, for all foreign drivers and co-drivers
- Completion of all details on the entry form
- Car insurance cover certificate
- Car registration papers
- Car's owner authorisation to participate in the rally
- Copies of the insurance cover for repatriation (non-Spanish crews)
- Driver Declaration and undertaking duly signed by the driver and co-driver
- Copy of the entry form duly signed by all parties

### 10.2 Timetable

The Competition numbers and rally plates will be delivered during documentation control to all the competitors.

## 11. SCRUTINEERING, SEALING AND MARKING

### 11.1 Scrutineering venue and timetable

## 11.2 Mud flaps

Optional - According to Appendix J Article 252.7.7.

## 11.3 Windows

According to Appendix J Art. 253.11, the use of silvered or tinted films is authorised, on the rear side windows, on the rear window and the sunroof. Silvered or tinted films fitted on rear side windows must have an opening equivalent to the surface of a circle of 70 mm in diameter.

## 11.4 Driver's Safety Equipment

Competitors must present all the items of protective clothing, which will be used including underwear, helmets and FIA approved head restraint (FHR system, formerly called HANS) and filled safety equipment documents. Compliance with 2026 FIA International Sporting Code, Appendix L, Chapter III and with technical regulations will be checked. **See also Appendix 5 of these Supplementary Regulations.**

Competitors are reminded that two (2) belt cutters must be carried on board at all times. They must be easily accessible to driver and co-driver when seated with their safety belts fastened (Article 253-6.1.3, FIA International Sporting Code, Appendix J).

Each competing car must carry a red "SOS" sign and on the reverse a green "OK" sign measuring at least 42 cm x 29.7 cm (A3), in conformity with the 2026 FIA WRC Sporting Regulations, Article 53.2.2.

Drivers and co-drivers who wear full-face helmets must contact the FIA Medical Delegate or the Chief Medical Officer in order to carry out a test before the start of the event. This test is described in 2026 FIA International Sporting Code Appendix L, Chapter III, Article 1.3.

## 11.5 Noise level

The maximum noise level permitted is 103 dBA. Cars not complying with this rule will be reported to the Stewards that could not allow to start. The noise will be measured with a sound meter regulated at "A" and "SLOW", placed at an angle of 45 degrees to and a distance of 50 cm from the exhaust outlet, with the car's engine running at 3.500 rpm.

## 11.6 Special National Requirements

Competing cars must be equipped with:

- Two reflective triangles
- Two fluorescent vest (one per person)

## 11.7 FIA Safety Tracking Device

All competitors must make provisions in their rally cars for the installation of the FIA Safety Tracking Device, and the system must be installed before the car is brought to scrutineering.

Tracking Devices may be collected either by the crew or a representative. No deposit will be collected for the rally safety tracking equipment, but all the damage caused will be invoiced afterwards. For installation and operating instructions see Appendix 6 of these Supplementary Regulations.

All priority competitors are required to purchase a SAS RallySafe WRC-spec fitting kit, which will be permanently installed in the vehicle for all World Rally Championship events. Non-Priority competitors, as an alternative to purchasing a RallySafe WRC-spec fitting kit, have an option to rent a kit for the single event, paid and collected at the FIA Safety Tracking Device collection window on the event, and to be returned with the tracker at the completion of the event. For instructions **see Appendix 6** of these Supplementary Regulations.

The FIA Safety Safety Tracking Device may be removed in the final parc fermé by a team member under the supervision of a scrutineer. In any case, the device must be returned to STATUS AWARENESS SYSTEM (SAS) truck in Service Park no later than 30 minutes after the Stewards have authorised the opening of the parc fermé on Sunday 26 April 2026.

Should a competitor retire, the tracking unit and associated cables must be returned to SAS office in the Service Park as soon as possible.

## 11.8 LED Repeater

An LED Repeater will be mandatory in all competing cars. The device will be provided by SAS as part of the usual kit (including wiring and mounting plate) and must be installed before scrutineering in the driver's direct line of sight, in accordance with the user guides supplied by SAS.

The LED Repeater repeats key safety messages from the tracking system (e.g. Red Flag, SOS/Hazard/Road Blocked, Push-to-Pass, Flying Finish), allowing the driver to keep eyes on the road while still receiving critical information. It is also intended to attract the crew's attention to consult the tracking screen for more detailed information. It does not replace flags, boards or marshals, but is an additional visual aid to help crews react quickly and consistently for their own safety and the safety of others.

### 11.9 On-board cameras

The competitor of any car which carries an on-board camera must have the prior agreement of the Promoter.

The fixings of camera and camera recorder must comply with the 2026 FIA International Sporting Code, Appendix J, Art. 253.2.

Competitors wishing to use an on-board camera must apply via the WRC Accreditation Portal at the latest by **Tuesday 14 April 2026**. Any requests presented after this date will not be considered and the competitor will not be authorized to install an OBC on their car.

Those registering for an OBC for the first time should first use this link: <https://qrco.de/WRCOBCRegistration>.

Those who have already applied for an OBC in the last 12 months should use their e-mail address to register via this link (no password required): <https://qrco.de/OBCForm2026>.

### 11.10 Change of sealed components (2026 FIA WRC Sporting Regulations, Art. 16)

After pre-rally scrutineering, any change of sealed component must be notified by the competitor to the following email: [wrc-technical@fia.com](mailto:wrc-technical@fia.com).

This notification must be received prior to the change of part.

## 12. OTHER PROCEDURES

### 12.1 FIA eLearning course and Driver's Safety Briefing

All drivers and co-drivers who have not yet participated in any WRC event in 2026 must complete the FIA eLearning course and pass the assessment for FIA Safety Tracking Device by **Tuesday 21 April 2026 at 23:00 h** and are required to attend the Drivers' Safety Briefing on **Wednesday 22 April 2026 at 19:00 h** at the Rally HQ.

Instructions for the eLearning course will be sent to the competitors by email once the Entry List is published.

### 12.2 Shakedown

See Article 36 of the 2026 FIA WRC Sporting Regulations.

All P1 and other requested drivers will be required to complete their first passage of Shakedown according to the Start List that will be published on Wednesday 22 April at 18:00 hrs. At the conclusion of these fixed passages, P1 and invited drivers will be able to continue their Shakedown runs with one (1) minute intervals.

- FIA P1 drivers shall complete a minimum of two (2) passages
- FIA P2 and P3 drivers must complete at least one (1) passage and are allowed a maximum of two (2) passages
- Participation is optional for non-priority drivers, and they are permitted a maximum of two (2) passages in total of the Shakedown stage.

Any person on board the car during SD, who is not entered for the rally must have signed the disclaimer (available from the organiser upon request) accompanied by photocopy of Passport or Identity Card, waving the Organisers, FIA and Promoter as well the driver and/or a competitor of any consequence that may result from an accident.

A remote Service Area will be created close to the Shakedown. GPS Location: [28°02'05.1"N 15°29'53.9"W](#)  
Access to the remote Service Area is limited to one vehicle per entered crew, maximum of 3.5 tonnes and with "SERVICE" plates.

Due to limited space in the remote Service Area, the space available to each Team is limited to a 5 x 8 meters and is marked on the ground.

The entry of service vehicles is not authorized until 30 minutes before the scheduled start time of their respective competing cars and the placement on any Team will be on a first-come, first served basis.

Ground sheets must be used and refuelling is **not** permitted.

Shakedown Road Book is available on the rally website, under Competitors / Private Documentation Area.

The participation in Shakedown is included in the entry fee.

Reconnaissance of the Shakedown stage is included in the Reconnaissance Schedule.

## 12.3 Service Park

### 12.3.1 Admission

Only cars carrying the appropriate car identification passes will be admitted in the service park.

Any parking of service and/or auxiliary vehicles in the service park outside the designated service area allocated to each team is strictly prohibited.

### 12.3.2 Service Park condition

Each area in the service park must be left in a clean condition and without any rubbish. Before leaving the service park, each competitor must report to the service park headquarters staff during the service park opening hours to get clearance for the corresponding area. On Sunday 26 April 2026 the staff will be available until 23:00 h and on Monday 27 April 2026, between 08:00 and 12:00 h (or upon special agreement).

### 12.3.3 Dismantling of facilities

Any dismantling of service area facilities before 08:30 h on Sunday 26 April 2026, must be made at times when there is no rally traffic inside the service park (see Itinerary) unless any such dismantling is exclusively carried out within the periphery of the corresponding team area itself (without using any kind of traffic lanes or team external areas).

### 12.3.4 Speed limit at the Service Park

The speed limit is 30 km/h.

## 12.4 Official time used during the rally

Official time throughout the entire rally will be that of GPS (UTC time + offset to local time).

## 12.5 Ceremonial start

There will be no Ceremonial start organized.

## 12.6 Control procedure and time cards

The complete set of Time Cards for the whole rally (including the Shakedown) will be delivered with the rally materials at the administrative checks. It is imperative for all crews to carry at least all the Time Card sets for a whole day inside the car (for example for the procedures at regrouping controls).

Time control procedures will be as described in the 2026 FIA WRC Sporting Regulations, Articles 43, 44, 46, 48, 49 and 55. Any writing on the time cards can only be done by the rally officials, except filling in the car number and markings on the boxes reserved for competitor's use.

## 12.7 Start order and intervals

The start orders are as stipulated in Art. 41.2 of the 2026 FIA WRC Sporting Regulations.

Start intervals are 2 minutes for P1 crews, 2 minutes for ten first P2 crews and 1 minute for all other crews. The Clerk of the Course may, for safety reasons and with the knowledge of the Stewards, reposition drivers or change the time interval between them.

The start intervals for the Power Stage will be defined as per Art. 50.3 of the 2026 FIA WRC Sporting Regulations.

## 12.8 Starting system of Special Stages

The standard light sequence mentioned in Article 48.2 and Appendix VII, of the 2026 FIA WRC Sporting Regulations will be used.

Should this start system fail the start will be given as specified in Article 48.3 of the 2026 FIA WRC Sporting Regulations.

## 12.9 Tyre warming zones

Tyre Warming Zones as detailed in Article 44.4 of the FIA WRC Sporting Regulations will be established before all stages. The distances for these zones are not shown in the itinerary but in the Road Books.

## 12.10 Chicanes

On SS 10/13 “MOYA – GALDAR” and SS 8/11 “MASPALOMAS” chicanes will be used to reduce speed for safety reasons. During reconnaissance, the position of chicanes will be at least marked on the ground.

Judges of Fact will monitor the correct passing of the chicanes according to Art. 53.6.3 of the 2026 FIA WRC Sporting Regulations.

## 12.11 Regroup (TC 13A/TC 13B)

Installation of extra lights is allowed inside the Regroup TC 13A/TC 13B. The extra lights may be brought to the regroup by a team member. Installation of the lights must be done by the crew using only tools carried in the rally car. Also, adjusting of tyre pressures is allowed in this regroup. No other work is allowed in the regroup.

## 12.12 Super Special Stages

With reference to Article 51.2 of the 2026 FIA WRC Sporting Regulations, SSS 1 and SSS 14 will be run as Super Special Stages. The roundabouts must be negotiated as shown in the Road Book. Any report of infringements for not following the itinerary will be reported to the Stewards.

Reconnaissance on the Super Special Stages is possible in accordance with the Reconnaissance Schedule in Appendix 2.

## 12.13 Re-start after retirement

According to Article 54 of the 2026 FIA WRC Sporting Regulations, a crew which has failed to complete a section may be assumed to re-start the rally from the start of the next section following the overnight regroup unless they confirm otherwise to the Clerk of the Course by completing of the form located in the rear of the road book and lodging it with the CRO on WhatsApp as soon as possible and if feasible not later than 1 hour before the publication of the start list for the following section.

Any restarting rally car must be returned to the parc fermé at least four (4) hours before the start of the next section following the overnight regroup.

## 12.14 Running of FLEXI-SERVICES

The flexi-service parc fermé at the end of Sections 3 and 6 will include a 10-minute Technical Zone. The procedures described in Article 59 of 2026 FIA WRC Sporting Regulations apply to all crews.

### 12.15 Power Stage

SS18 "SANTA LUCIA – AGÜIMES 2" will be run as the «Wolf Power Stage».

### 12.16 Permitted early check-in

Crews are authorised to check-in early without time penalty at TC 0A, 1A, TC 7C, TC 14A, TC 14C, TC 18A and TC 18C.

Early check – in is also allowed at TC 13A (Regroup IN – La Base Naval) after the crews have fulfilled their media obligation.

### 12.17 Media Zones

All priority drivers (and co-drivers upon request) must be available for media interviews for a minimum of 15 minutes or until they are given permission to leave by the FIA Media Delegate.

The Media Zone will be operational before the yellow time control sign at: TC 4A, TC 7A, TC 10A, TC 14A and TC 18C.

Additionally, media will be allowed to conduct interviews with the crews in the pre-podium holding area at TC 18A. Access to the Media Zone is restricted to the following:

- Accredited media or team media personnel holding a green pass
- Team principals or team representatives, who are, in view of the FIA Media Delegate, performing media duties. Those representatives must request the FIA Media Delegate the delivery and activation of the NFC sticker on their pass for this event.
- Holders of a red "All Access" pass

No other personnel will be allowed in the Media Zone unless authorised by the FIA Media Delegate and holding the correct pass and approved access.

Requests for the delivery and activation of the NFC sticker (excluding red all-access and green media passes) should be sent by email to: FIA Media Delegate, [Sven Good, sgood@fia.com](mailto:sgood@fia.com) no later than **15:00 h on Tuesday 21 April 2026**.

### 12.18 FIA WRC Media Pen

An FIA WRC Media Pen will be organised on **Thursday 23 April 2026 from 13:15 to 14:45 h** next to G.C. Stadium. The FIA WRC Media Pen is mandatory for all P1 drivers and P2 drivers, as well as P1 manufacturer team representatives. Attending competitors are required to be present for a duration of 30 min. minimum, or until dismissed by the FIA Media Delegate. P2 drivers are recommended to come from 12:45 onwards but welcome earlier if they wish to.

### 12.19 Route Note Cars

In accordance with Art. 9.5 of the 2026 FIA WRC Sporting Regulations.

The Route Note Cars shall start in the special stages no later than 70 minutes before the first competitor.

All Route Note Cars are required to carry identification stickers provided by the organizer. A RNC registration form (available on the rally website) must be submitted to the organiser at the latest on **Monday 30 March**.

The registration fee for a Route Note Car (P2 only) is 1.500 € (+7% IGIC).

#### 12.19.1 Special prescriptions

A speed limit of 80 km/h is imposed in the special stages. All national traffic rules must be respected on the special stages and on the road sections between the special stages. The route note car crews must proceed with care, at a reduced speed, in the same direction as the rally.

Any infringement of these provisions will result in the immediate withdrawal of the specific identification issued by the Organisers, without prejudice to any other sanction imposed at the Stewards' discretion.

Route Note Crews are not allowed to participate in reconnaissance (Art. 9.5.3 of the 2026 FIA WRC Sporting Regulations).

#### 12.19.2 Tracking system for Route Note Cars

Competitors who have registered a Route Note Car must equip this vehicle with the same tracking system that was used for the reconnaissance (RS Lite). RSLite must be kept active and phone charged at all times when the RNC is being driven, also in road sections.

Return of the rental mobile phone (if opted): SAS compound in Service Park from 14:00 - 17:00 hrs on Sunday 26 April 2026.

### 12.19.3 Route Note Exchange Points

Will be published in a COC Communication. Route Note Crews are allowed at the regroup before the Power Stage, TC 17A/TC 17B.

### 12.20 Finish procedure

The finish podium is located in the proximity of the finish line of SS 18 “Santa Lucia - Agüimes 2 – WOLF Power Stage” and is explained in the Road Book.

Access to the holding area in front of the finish podium will be limited to officials and to media representatives holding the appropriate pass.

After the completion of SS 18 the last car selected for Live TV it is required to be driven straight to the podium, without stopping at TC 18A.

All P1 crews, all Spanish crews as well as all crews that are awarded prizes must drive through the podium.

All other crews may proceed directly to final parc fermé.

They have on Service Park a special place for a photo opportunity.

The competitive element of the rally will conclude at TC 18C (Rally Finish Gran Canaria Stadium).

#### 12.20.1 Removal of cars from final parc fermé

All cars must be removed from the final parc fermé within 60 minutes after the Stewards have authorised the opening of the parc fermé. After this time the Organiser will not be responsible for the surveillance of the cars.

### 12.21 Exhibition driving

Exhibition driving (doughnuts, drifting etc.) or any other dangerous driving is strictly forbidden everywhere. All infringements will be penalised with a minimum of a 5-minute time penalty, applied by the Stewards.

### 12.22.1 Promo Activity for selected crews

A promo activity is scheduled for Wednesday 22 April at 18:00 - 19:00 for selected crews.

A COC Communication will be issued before Tuesday 21 April explaining the activity and nominating the attending crews.

### 12.22.2 Crews' Parade

On Thursday 23 April after TC 0A (Holding Area IN – “BP Ultimate - Circuito Islas Canarias”) and before the start of SSS 1 “BP Ultimate - CIRCUITO ISLAS CANARIAS”, P1 crews and other selected crews will go for a lap ride on the special stage on a low loader platform and will be interviewed.

The Clerk of the Course will publish a Communication with the list of the crews and the scheduled time to make the Parade Lap as well as the pick-up and drop-off point.

The parade is mandatory for the selected crews.

## 12.23 Helicopters

### 12.23.1 Registration procedure

According with the FIA Safety Regulations and the Civil Aviation authorities, all helicopters in the rally area be registered with the Organiser. The registration form must be submitted before **6 April 2026**.

The registration fee to the organiser for each helicopter is €3.000 + 7% IGIC.

A compulsory helicopter pilots briefing will be held on **Tuesday 21 April at 18:00 hrs**.

Without prior approval from the organiser, it is strictly forbidden to use any ground-controlled flying devices (drones)

### 12.24 Deceleration area on SS Finish

In accordance with the Art. 5.5.4.1.c) of Appendix H of the 2026 FIA International Sporting Code, a deceleration area will be established between the Flying Finish and the Stop Control in each Special Stage to reduce the arrival speed at the Stop point on each special stage.

Plastic modules will be placed in the 100 m before the Stop Point as indicated in the roadbook and marked during recce.

### 12.25 Environmental policy

The compliance with the environmental and safety prescriptions will be carefully checked by officials. All competitors are required to ensure that all team members are aware of these prescriptions.

Contemporary motorsport means that organiser and participants undertake all efforts to protect the environment – in particular water and soil.

Cleaning of vehicle components: Several facilities (water containers and water connection) will be available in the service park nearby the service park headquarters from Monday 20 April 2026.

The use of high-pressure cleaners or water hoses for cleaning purposes is prohibited at all locations in the area of the service park.

**Washing cars within the Service Park is prohibited at any time.** Any infringement will result in a fine of € 500 per each incidence, notified to the Competitor by the Clerk of the Course.

A sufficiently large plastic ground sheet must be used under the competition car whenever service works are carried out on the car. The ground sheet must be sufficiently strong and tear-resistant, have no damages and be tight, i.e. impervious to oil, fuel, cooling and brake liquids as well as to battery acid. If several sheets are connected, this connection must be made of adhesive tape which is leak-tight, impervious and tear-resistant to the aforementioned substances or an overlap of the sheets of at least 50 cm must be ensured.

Any residues such as water, oil, fuel, any other liquids, dirt and similar must be collected from the ground sheets, the use of wet vacuum cleaners is recommended, and be disposed environmentally-friendly (e.g. into the containers provided by the organiser).

Competitors are required to ensure that no substances hazardous to water pass over the edge of the ground sheet and into the ground, even in the case of rain.

The service crews must be in possession of oil absorbing materials and have available a container for used oil and brake fluid at any time during the event.

Any pollution of the environment must be avoided. Any waste, wrapping material, spare parts, empty oil or colour tins, batteries, etc. must be collected and given to a waste disposal by the competitors themselves. Used oil must be collected and brought to the containers made available in the service park for this purpose.

Containers with substances hazardous to water such as oil, fuel, cooling and brake liquids, chemical substances or cleaning agents must not contain more than 20 liters per unit. No more than 100 liters of the above substances may be stored inside a vehicle if no safety devices such as collecting tray are provided.

Any such empty containers must be disposed at the collection points for hazardous goods inside the service park and/or with Sodifuel for fuel containing devices.

To enable the smooth operation of the rescue teams in case of an accident, all containers with liquid and nonliquid chemicals (e.g. cleaning agents) must carry labels which clearly identify their contents.

Smoking is forbidden at a distance of less than 10 m from containers with inflammable contents (e.g. fuel for generators), even if the containers have been emptied. A solid barrier must be provided between the storage area of any such containers and eventual spectator areas before, during and after their use.

The ban to impair the environment, e.g. water, soil and biotope, is also regulated in the national environmental and criminal law.

All infringements will be reported to the Stewards.

Cars subject to final checks (COC Individual Communication notified to the competitor concerned at the finish TC) must have one representative of the competitor as well as mechanics and proper equipment (in case of dismantling) present at the final checks.

### 15.2 Protest deposit (2026 FIA WRC Sporting Regulations Art. 65.2)

The protest deposit is € 1000.

If a protest requires the dismantling and reassembly of a clearly defined part of the car (engine, transmission, steering, braking system, electrical installation, bodywork, etc.), an additional deposit may be specified by the Stewards in accordance with Art. 13.4.3 of the 2026 FIA International Sporting Code.

The expenses incurred in the work and in the transport of the car shall be borne by the claimant if the protest is unfounded, or by the competitor against whom the protest is lodged if it is upheld.

If the protest is unfounded, and if the expenses incurred by the protest (scrutineering, transport, etc.) are higher than the amount of the (additional) deposit, the difference shall be borne by the claimant. Conversely, if the expenses are less, the difference shall be returned.

### 15.3 Right of review deposit (2026 FIA International Sporting Code, Art. 14.4.3)

The right of review deposit is € 1000.

### 15.4 Appeal deposit (2026 FIA WRC Sporting Regulations, Art. 65.5)

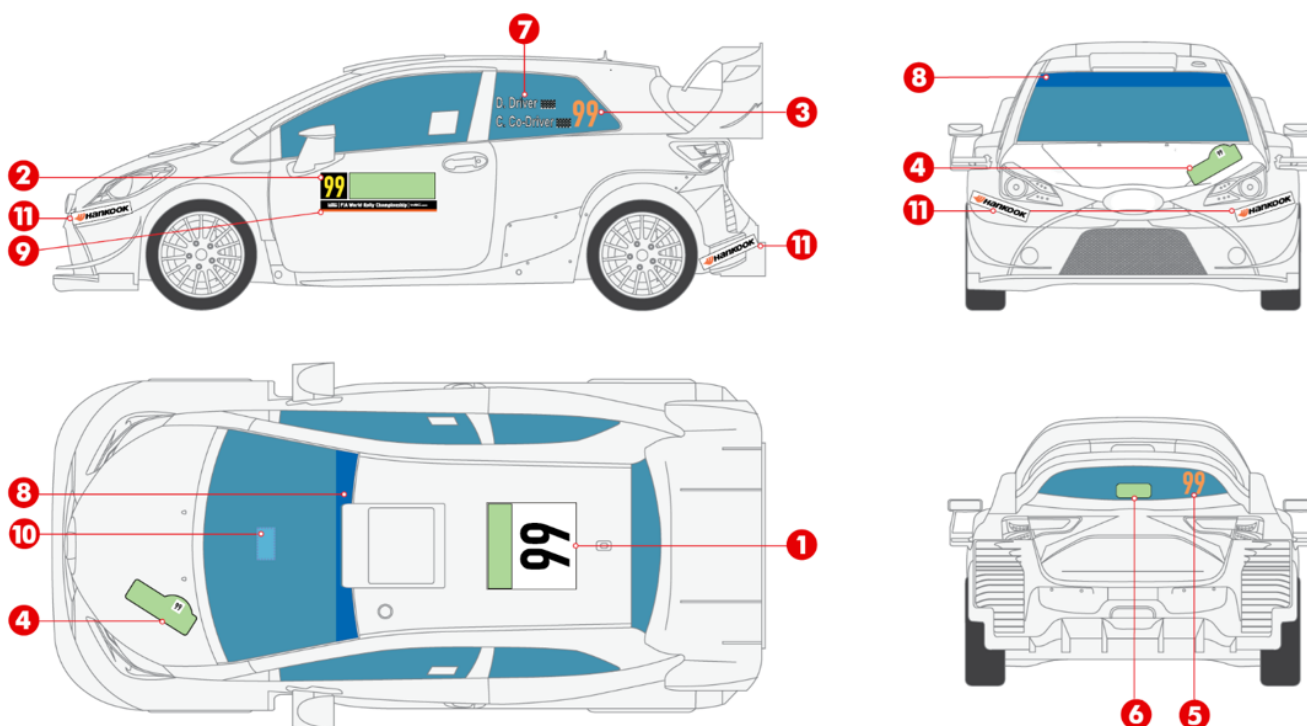

## APPENDIX 5 – DRIVERS' SAFETY EQUIPMENT

All competitors are reminded of Appendix L of the 2026 FIA International Sporting Code (ISC), in particular its Chapter III – Drivers' Equipment. These regulations apply to Shakedown as well.

### Helmets (2026 FIA ISC, Appendix L, Chapter III, Art. 1)

Priority 1 drivers and their co-drivers must wear helmets according to the FIA standard 8860-2018 or 8860-2018-ABP. This also applies to all Priority 2 crews competing with a World Rally Car.

All other crews must wear crash helmets homologated to one of the following FIA standards:

- 8859-2015 (Technical List N° 49),
- 8859-2024 or 8859-2024 ABP (Technical List N° 107),
- 8860-2010 (Technical List N° 33) or
- 8860-2018 or 8860-2018-ABP (Technical List N° 69)
- **see also Technical List N° 25**

Drivers and co-drivers who wear full-face helmets must contact the FIA Medical Delegate [wrc.medicaldelegate@fia.com](mailto:wrc.medicaldelegate@fia.com) or the Chief Medical Officer in order to carry out a test before the start of the event. This test is described in the Appendix L, Chapter III, Art. 1.3.

### Frontal Head Restraint (FHR) (2026 FIA ISC, Appendix L, Chapter III, Art. 3)

All crews must use FIA approved FHR systems homologated to FIA standard 8858. Approved FHRs, anchorages and tethers are listed in Technical List N° 29. See also helmet compatibility chart in Appendix L, Chapter III, Art. 3.3.

### Flame-resistant clothing (2026 FIA ISC, Appendix L, Chapter III, Art. 2)

All drivers and co-drivers must wear overalls as well as gloves (optional for co-drivers), long underwear, a balaclava, socks and shoes homologated to the FIA 8856-2018 standard (Technical List N° 74).

Please pay special attention to the prescriptions of Art. 2 concerning embroidery and printing on flame-resistant clothing (manufacturer certificates etc.) **as well as concerning the correct wearing of the clothing elements! See also the 2026 FIA WRC Sporting Regulations, Article 53.1.**

### Biometric Devices (2026 FIA ISC, Appendix L, Chapter III, Art. 2.1)

Drivers may wear a device to collect biometric data during racing.

- If the biometric device is integrated into a protective garment homologated to FIA Standard 8856, the garment shall be homologated to FIA Standards 8856 and 8868-2018.
- If the biometric device is a stand-alone device, then the device must be homologated to FIA Standard 8868-2018 only. This device must be worn in addition to the garment homologated to FIA Standard 8856.

### Wearing of jewellery (2026 FIA ISC, Appendix L, Chapter III, Art. 5)

The wearing of any type of jewellery, such as but not limited to, neck chains, bracelets or watches is prohibited during the competition. Exceptions to this rule, providing the CMO and/or Medical Delegate do not consider that due to size or location they may delay rescue or hinder emergency care, are:

- i. the wearing of watch(es) by co-drivers, on the condition that the watch(es) is worn over the overall,
- ii. the wearing of a single band-style ring providing it does not restrict the natural range of motion of the hand, and
- iii. the wearing of body piercing(s) providing they are not worn in and/or around the oral cavity.

## APPENDIX 6 – FIA SAFETY DEVICE - INSTALLATION AND OPERATING INSTRUCTIONS

**All priority competitors** are required to purchase a SAS RallySafe WRC-spec fitting kit, which will be permanently installed in the vehicle for all World Rally Championship events. The SAS RallySafe WRC-spec fitting kit comprises all necessary antennas, mounting and wiring components to be pre-installed in the vehicle, prior to the supply of the FIA Safety Tracking Device and Remote LED Display at the event. SAS RallySafe WRC-spec fitting kit can be purchased via the RallySafe shop (<https://statusas.com/wrc-kit>) and shipped to the competitor prior to the event, or collected at the event, or alternatively purchased onsite when collecting the FIA Safety Tracking Device at the event. The price of the kit is €150.00, excluding shipping and handling fees.

**Non-Priority competitors ONLY**, as an alternative to purchasing a SAS RallySafe WRC-spec kit, have an option to rent a kit for the single event for the cost of €50.00, paid and collected at the FIA Safety Tracking Device collection window on the event, and to be returned with the tracker at the completion of the event.
