1. Welcome & Introduction

Finland is known as the spiritual home of rallying, and this is the 57th time that we have to honour of organising a this rally in Jyväskylä.

Over the years Neste Oil Rally Finland has become the biggest annual spectator event in the Nordic Countries. In order to stay successful in this demading business of entertaining we must continually develop our product and carry out customer surveys. After carefully studying the feedback from the rally fans, we have decided to make a great deal of changes to the event this year.

The one area that has undergone the most significant changes is the rally route. When measured in stage kilometres, 46 % of the route is new compared to last year. Some of the new special stages are unfamiliar to the present generation of drivers. Also, we have opted to make use of the possibility allowed for in the regulations to include a remote service in the Saturday leg. That enables us to save nearly 2 hours, during which we can provide the spectators with full-blooded rally action out on the stages.

We are confident that we can cater for all the various interest groups and offer everyone one of the best WRC rounds in the world – a round with a unique atmosphere created by our passionate rally fans.

4. Entry Details

4.1 Titles for which the Rally Counts

Neste Oil Rally Finland is also one of the rallies in the Ford Fiesta Sporting Trophy International.

4.2 Criteria for Acceptance of Entries

Anyone wishing to take part in Neste Oil Rally Finland 2007 must send the entry form published together with the Supplementary Regulations of the rally, duly completed to the Rally Secretariat before Sunday 29 June 2007 at 18.00 Finnish time (17.00 CET). Manufacturers entered in the FIA WRC and competitors of the FIA Junior RC use the entry form supplied by the FIA.

To be accepted, this entry form must be accompanied by proof of payment of the entry fee. Competitors and drivers wishing to enter international competitions organised abroad, may only do so with the approval of their own ASN.

5. Service Park

5.1 Location

The Service Park will be located in the area around the Jyväskylä Paviljonki Rally HQ. Manufacturers entered to the FIA WRC will have their designated areas in the Service Park according to the Appendix VI of FIA WRC regulations. There will be a dedicated area for the auxiliary vehicles, both directly next to the team's service area and in an auxiliary parking area within the Service Park. Due to the restricted room in the Service Park private entries will not be given any auxiliary plates.

The service area surface is mainly gravel or equivalent. A provisional lay-out of the Service Park can be found as appendix 3.

5.2 Access to the Service Park

The Service Park will be opened on Monday, 30 July 2007 at 09.00 for the Priority Drivers and on Wednesday, 1 August 2007 at 12.00 for the other competitors.

All parties are kindly asked to respect these opening times. Teams or tyre manufacturer wishing to bring equipment or sea containers to the Service Park area before the given opening time must inform the organiser thereof. Should the organiser not have received such notification, we cannot guarantee any access to the area. All costs of moving the equipment either within or outside the Service Park to its final position will be borne by the relevant owner of the equipment.

Competitors are kindly asked to remind all their team staff to always carry their Service Passes, as the organiser will be collecting an admission fee into the service park from anyone without a valid pass.

5.3 Facilities in the Service Park

The organiser will be offering the following facilities in the Service Park:

- waste collection for mixed waste, oil, paper etc.
- toilet facilities (these exist both in the outside area as well as inside the HQ building)
- WLAN connection
- general security in the service park area
- water (direct pipelines to manufacturer teams plus common sources for others)
- car wash before the TC IN

The organiser can contract various services for the manufacturers, the ISC and tyre companies. The following can be ordered through the organiser:

- WLAN card hire
- extra security services
- portable toilets to your team area
- portable waste water tanks
- waste water tank and motorhome septic tank emptying
- electricity
- forklift service and sea container handling
- daily dry-cleaner's pick-up service directly from the service park (invoiced by service provider)

As we are still negotiating with some of our suppliers, full list of services with prices will be published on the event website later this spring. A notification will be sent to all registered teams, tyre manufacturers and the ISC(T).

Service Facilities' Order Procedure

The following procedure must be followed by all customers ordering services through the organiser:

- 1. Place your order using the form on the event website on 15 June 2007 at the latest.
- 2. Within 5 working days from receiving your order, the organiser will send you an invoice for the services ordered.
- 3. This invoice must be paid by the 29 June.
- 4. Service prices will be raised by 15% for all orders placed after 29 June.
- 5. All orders made after 29 June must be paid with a credit card supplied together with the order. The same goes for any additional services ordered during the event.
- 6. For all telephone connections a deposit of 300 €/customer will be collected for covering the communication costs. Any difference between the actual costs and the deposit will be regulated after the event.

6. Reconnaissance

Place:

6.1 Registration for Reconnaissance

Reconnaissance registration will take place as follows:

For the priority drivers, materials can be collected by a team member duly designated in writing. Others have to make the registration themselves.

6.2 Regulations and Restrictions

The competitors will be divided into two groups during the reconnaissance: Priority 1 & 2 drivers and Others. More specific information and schedules will be given in the Supplementary Regulations and Rally Guide 2.

6.3 Reconnaissance Accommodation

There are no special arrangements or recommendations for where to stay during reconnaissance, you can make your reservations through the same agency as your rally accommodations.

7. Shakedown

7.1 Who may Participate

Shakedown on Thursday 2 August at 08.00 - 12.00 in Laajavuori is obligatory for all Priority 1 drivers.

Priority 2 an Priority 3 Drivers wishing to participate must send the organiser an entry form for the Shakedown by Wednesday 1 August 2007. This form will be available from the event website.

7.3 Location

Shakedown will take place at Laajavuori, approximately 6 kms from the Rally HQ. The stage is 3.76 kms in length (same stage as in 2006). The service area is the same as in the rally, the Paviljonki Service Park.

FIA fuel will be available in the Service Park during the shakedown.









7.4 General Information

Shakedown will be run like a special stage. Times will be published in the Rally HQ and Media Centre. Competitors must use helmets, overalls, etc., just as on special stages during competition.

- · Respect of the accreditation deadline
- · Compliance with the requested elements of the procedure
- Commitment of coverage devoted to the event
- · Match with circulation and/or quality criteria

Coverage: For a daily news paper, a substantial amount of coverage for the event is required. For example, an introductory article in the Thursday edition, follow-up articles in Friday, Saturday and where applicable, Sunday editions, plus an event report in the Monday edition. For a weekly or monthly publication, a substantial amount of coverage for each event is required.

Circulation and quality: Accreditation decisions are based on the relative 'media market' in the applicant's country. The highest standard of fairness and accuracy are expected as a minimum quality requirement from the printed press.

Photographers: Applications must follow the same criteria, as stated above. In addition publications or agencies applying for single round accreditation must supply evidence of independent coverage of a minimum of **15 pictures** per pass issued at each WRC event they have been accredited for in the previous year's Championship. Please note, FIA regulations state that the number of photographers' media passes issued for Finnish photographers will not exceed the number of 12.

Freelance journalists must apply for credentials via their own agencies. The onus is on the freelance applicant to prove the supply of regular stories to at least five publications corresponding to the FIA accreditation criteria.

Please note that all accredited publications must be on sale to the general public via retail outlets (trade, club or internal company magazines will not be accredited).

8.4 Manufacturers' Room

There are working facilities for the press personnel of Manufacturer Teams entered in the FIA WRC and tyre companies in the Manufacturers' Room. The Manufacturers' Room is located at the Paviljonki HQ. The Service Park is also located in the Paviljonki area, which enables working from the Manufacturers' Room for the whole duration of the event.

At each work station there will be table space, three chairs and a telephone with analog line. Additional WLAN, LAN and telephone connections can be ordered through the organiser. As we are still negotiating with some of our suppliers, full list of services with prices will be published on the event website later this spring.

Facilities' Order Procedure

The following procedure must be followed by all customers ordering services through the organiser:

- 1. Place your order using the form on the event website on 15 June 2007 at the latest.
- 2. Within 5 working days from receiving your order, the organiser will send you an invoice for the services ordered.
- 3. This invoice must be paid by 29 June 2007.
- 4. Service prices will be raised by 15% for all orders placed after 29 June 2007.
- 5. All orders made after 29 June must be paid with a credit card supplied together with the order. The same goes for any additional services ordered during the event.
- 6. For all telephone connections a deposit of 300 €/customer will be collected for covering the communication costs. Any difference between the actual costs and the deposit will be regulated after the event.

9. Two-way Radio

GSM and UMTS mobile stations, LA (CB), PR 27 and PMR 446 (analog and digital) telephones are exempted from licensing, provided they fulfil the requirements of relevant equipment standards and specifications. The use of all other kinds of radio transmitters is subject to a licence issued by the Finnish Communications Regulatory Authority (FICORA). FICORA shall be notified of the frequencies in the equipment in question, upon which it will decide on







assigning the customer a suitable frequency and will issue a licence for the radio transmitter.

Throughout the rally, the use of frequencies for amateur radio is prohibited.

At the pre-event scrutineering, the radio transmitters and licences will be inspected. Radio transmitters in aircrafts will be inspected, too.

The use of radio transmitters will be monitored throughout the rally. Unlicensed use, or use outside the terms of a licence, of a radio transmitter, may lead, in case of serious interference, to prohibition of the use of the radio transmitter, in accordance with the Act on Radio Frequencies and Telecommunications Equipment in Finland.

10. Fuel

10.1 FIA Fuel and Fast Couplings

Refuelling will be located at the Service Park Paviljonki (Leg 1, 2 and 3) or in Jämsä (Leg 2). The competitors need to pay special attention to the various refuel locations when making their service plans.

All cars of the priority drivers must be fitted with FIA fuel sample couplings for taking fuel samples and with fast couplings for refuelling. All competitors must comply with WRC regulations Art. 8 and 9.

The use of FIA fuel is obligatory for all priority drivers. No later than 3 weeks prior to the event, the competitors must notify their fuel requirements to the sole supplier Shell and CEVA using the form given by CEVA (see appendix 9).

10.2 Dispensing of FIA Fuel

For sporting, environmental and safety reasons, during the rally the fuel must be dispensed from a single source. Thus all cars must use this centralised refuel service. The total price of the fuel will be 5.39 € per litre, including the refuel services at the site of the event.

10.3 Dispensing of 98E Pump Fuel

For the non-priority drivers, the use of FIA fuel is not obligatory and normal pump fuel may be used from petrol stations directed in the Road Book of the rally. As last year, the organiser has managed to find suitable petrol stations along the route of the rally to be used for non-priority drivers' refuelling, which means considerable savings in their event budgets.

However, these drivers' attention is drawn to the fact that the list of available petrol stations for the 98E pump fuel will be published later as a separate document (these will also be shown in the Road Book), i.e. the locations are not given in the itinerary of the rally (as Appendix 1) and the distances from one refuel to the next are different from the ones given in the aforementioned itinerary. More details of the refuel process at the petrol stations will be given in Rally Guide 2.

10.4 Fuel Tank Capacity

As the competitors in the FIA Junior RC may not have adequate fuel tanks to be able to drive the required distances from one refuel to the next, the organiser may apply from the FIA a waiver for supplementary refuel points for all Priority 3 and non-priority drivers. The exact locations will be given later.









11. Hospitality and PR-Activities

11.1 Hospitality

Our Super Special Stage with its hugely popular corporate hospitality units will be located at the local trotting track in Jyväskylä, as our regular visitors will remember. This year Killeri will be driven on Thursday and Friday. Killeri Village offers our guests a ringside view to the Super Special Stage. On both nights, top drivers will appear for interviews in the village before attacking the Super Special.

The Super Special Stage itself is 2.06 km long with two cars on track at the same time, driving through tunnels and over bridges and jumps. We are once again providing teams and competitors a possibility to join the hospitality Village at the Super Special Stage. The Village is situated at an ideal trackside location with a superb view to the whole stage.

At Killeri VIP Village your guests can be catered in their own private suite (available for groups over 50 persons) or if you wish to bring only a few guests, you can join the buzz at our VIP Club with guests from several companies.

This means all pilots using the helipads provided by the organiser must attend the pilots' briefing and must acquire the organiser's pilots' pack, including all GPS coordinates, aviation / rally maps, list of helicopters and pilots and the necessary ID plates for the helicopter. Price for this package will be announced at June.

The pilots' briefing will be at 07.00 on 3 August 2007 in the Jyväskylä Airport (EFJY), more details in Rally Guide 2.

13. Import of Vehicles and Spare Parts

13.1 Competitors from the European Union

Competitors coming from the European Union do not need to make any special customs clearance. They may use any vehicle in Finland for up to 6 months without clearing it, provided that the vehicle is not brought to Finland with the intention of selling it. All vehicles need to have a valid traffic insurance. Tyres and reserve parts can also be imported without clearance. It is always good to have a list of tools and equipment you bring into the country, in case you will be asked to prove what you had with you on the way in.

13.2 Competitors from outside the European Union

Competitors coming from outside the European Union will have to report at the customs on their way in. Please prepare a list of all the tools and equipment you are bringing with you. This list will be stamped at the customs and they may collect a security (the amount is negotiable). Tyres are under customs as they are non-durable goods. The customs payment will be returned if the used tyres are exported from the country on the way out, as well as the security, if all equipment is exported.

14.1 Accommodation

15. Useful Facts and Information

15.1 Medical Information

At the administrative checks before the rally all drivers must present their Medical Certificate of Aptitude in accordance with the FIA medical standards, and as given to them by their own ASN.

A decision in accordance with Finnish law has been taken by the Health Care District Central Finland that an individual living elsewhere than in Finland must pay the total cost of treatment received unless other provision has been made in international agreements.

Residents of EU/EEA/Nordic Countries, Australia, Canada, Chile, Israel, Switzerland and the USA

Finland has made agreements concerning patient charges for individuals living abroad with the above mentioned countries. If you are a resident of one of the above countries, you must demonstrate by means of documentation (e.g. form E111, passport to prove your nationality) that you are covered by the social insurance system of your home country. In such cases the patient charge is the same as for those living in Finland. Otherwise the charge will be the total cost of treatment plus the patient charge for an individual living in Finland.

Residents of other countries

If you are a resident of a country other than those mentioned above, the patient charge will be the equivalent of the total cost of treatment plus the patient charge for an individual living in Finland.

Payment of the patient charge

If you require first aid, collection of the patient charge will be made as you leave hospital. Collection of the charge will take place in advance in cases where you have agreed with the hospital on treatment that is not urgent.

Should an insurance institution be responsible for your patient charges, acceptable evidence of this must be presented to the hospital.

All competitors living in the European Community should bring the E111-form with them to be able to get free medical services at the communal health care centres and hospitals. This can be obtained from your local social services.







15.2 General Facts about Finland Population

5.2 million, giving an average density of only 15.5 per sq. kilometre; annual growth rate 0.18%. Life expectancy 78.2 years. The demographic pyramid resembles that of most other industrial countries, with the middle-aged groups predominating. Average household sizes 2.1 persons. 54% of the population live in single-family houses, 46% in apartment blocks; room area per person 36 sq. metres. 74% are urban-dwellers, with 1 million in Helsinki and the adjacent cities of Espoo and Vantaa. Other major cities include Tampere, Turku, Oulu and Lahti.

Area

338,145 sq. kilometres, of which 10% is water. There are more than 60,000 lakes in Finland. 7% of the land is under cultivation, barley and oats being the main crops. Forests (mainly pine and spruce) cover 76% of the country.

Climate

The Finnish climate is considerably milder than one might expect from the country's northerly location. There are major variations in the seasons. During the rally, it is late summer/early autumn and the weather may vary quite a lot, although it is predominantly warm. It can be sunny and warm, over 20 degrees Celsius or it can rain and be only about 10 degrees Celsius.

Time zone

Finnish time is two hours ahead of Greenwich Mean Time (UTC +2 hours). Daylight saving time is used from the last Sunday of March to the last Sunday of September.

Language

Finnish 91.6% of the population Swedish 5.5% of the population

English is spoken by almost everybody, German and French by some.

Sauna

In Finland, there are 5.3 million inhabitants and 2 million saunas. Finnish people take to sauna the way a fish takes to water! Sauna is a time for relaxing with friends and family, a time for physical and spiritual refuelling of one's body and mind. You have to experience it to truly savour one superb Finnish tradition. An old Finnish proverb states to the effect that "if sauna, liquor or tar don't help...the disease must be fatal".

Currency and Banking

The Finnish currency unit is euro (€ or EUR), devided into 100 cents. The denominations in circulation are: Notes - 500, 200, 100, 50, 20, 10 and 5 euros

Coins - 2 and 1 euros; 50, 20, 10 and 5 cents (2 and 1 cent coins not in active use in Finland).

Foreign currency may be exchanged in banks Monday to Friday at 9.30-16.30. Most banks display exchange rates on their windows.

Automatic Teller Machines

All these banks have several cash dispensers all over the city. They usually operate on Visa/Eurocard. From the ATMs you can withdraw notes in denominations of 20 and 50 €. The closest cash dispenser to the Rally HQ is in Matkakeskus (the railway station). You can recognise the ATMs from an orange sign "OTTO".

Credit Cards

All major credit cards are very widely accepted in hotels, car rental offices, department stores, restaurants, shops and most taxis. Foreign credit cards can be used to withdraw cash from almost all ATMs.

Medical Services

Medicines are sold at pharmacies (APTEEKKI). Usually pharmacies are open until 17.00 or 18.00. There is one pharmacy (Yliopiston Apteekki) at Kauppakatu 39, which is open daily 08.00 – 23.00.

All hospitals have doctors on duty around the clock. In emergencies, patients should be directed to a health care centre or hospital emergency unit. Dental care is mainly provided by private practitioners.

Vaccinations

There are no regulations requiring visitors to Finland to have vaccinations.

Water

The tap water is safe to drink.

Electricity

The electric current in Finland is 230 Volts. Plugs and sockets are the same as in the continental countries of the European Union.

Telephones

There are pre-paid SIM cards available for your GSM mobile phones at 'R-Kioski' in various values.

15.3 Jyväskylä and Other Rally Cities Impacts of Neste Oil Rally Finland to the Rally Area

A comprehensive survey was carried out in Neste Rally Finland 2003 to explore the economical and social impacts of the event in the rally area. The benefits from the rally are indisputable. It brings in visitors who together with the competitors spend a minimum of 11 million euros during their stay. Of this sum over 9 million euros come from outside the rally region. The visiting foreigners' contribution is at least 1.3 million. Businesses in the area report a periodical growth of almost 50 % in sales.

Nearly all (90 %) of the region's inhabitants feel Neste Oil Rally Finland has a positive impact on the image of the area. The survey reveals that Neste Oil Rally Finland generates a lot of social activity. 138 clubs participate in the event's organisation with a total contribution of 250 man-years. On top of remuneration, three out of four clubs say they particularly value the experience gained in organisational duties plus the various aspects involved in people sharing a common goal. Great significance is also placed on the fact that the gravel roads used in the rally are afterwards fully re-graded courtesy of AKK Sports Ltd.

15.3.1 Jyväskylä

Neste Oil Rally Finland has been hosted by the City of Jyväskylä since the very beginning of the event, for over 50 years. The role of the city has grown to be a more central one over the years, as the event has grown from a modest concentration run for a handful of enthusiasts to a full-blown world level event.







General Information

The city of Jyväskylä was inaugurated as a town in 1837 and is located in the lake district of Central Finland. It is easily reached by road, air and water. Today Jyväskylä is a bustling centre for business, education, sports and culture and has nearly 85 000 inhabitants. It is the fastest growing city in Finland and one of the most popular places to move to. The Jyväskylä region – comprising of the city of Jyväskylä and eight municipalities surrounding it – has 170 000 inhabitants.

Jyväskylä is a school and university town with 40 000 students during the academic year, providing a diversity of educational offerings for people of all ages. The multi-disciplinary University of Jyväskylä and the Jyväskylä Vocational Institute are among Finland's leading research and educational institutions with an increasing number of international students

Bustling Centre of Innovation

Jyväskylä is one of Finland's five centres of growth. Special expertise can be found in the fields of paper manufacturing and paper machinery as well as energy production, environmental, information, welfare and nanotechnology. In recent years, Jyväskylä has gained reputation as organiser of many national and international congresses and fairs in the Jyväskylä Paviljonki Fair and Congress Centre.

Quality of Life

The landscape of Jyväskylä is varied with lakes, forests and hills within a walking distance of the city centre. The Laajavuori skiing centre and recreation area with its new outdoor theatre facility provides excellent opportunities for sports and other activities, and that is where the shakedown of the rally also takes place. Lively pedestrian precinct and beautiful university campus right in the city centre are central places for different events. The trail around Lake Jyväsjärvi is a great recreational area for both residents and visitors alike.

The Jyväskylä region is easily reached by land and air: the distance of 270 kilometres from Helsinki takes only 35 minutes by plane and some 3 hours by car or by rail. 15.3.2 Jämsä and Jämsänkoski

Jämsä (founded in 1866) is a thriving provincial town beside Lake Päijänne with a population of 15 282 (in 2004). It offers the benefits of high quality services and a beautiful and varied rural environment. In the Middle Ages Jämsä and the neighbouring districts formed an administrative parish where hunting and fishing were the main sources of livelihood. On a bank of the River Jämsä an old Viking settlement has been discovered. Today the centre of Jämsä, together with the Kaipola sub-centre and UPM-Kymmene Industrial Park, form a continuous ribbon of built-up area along the banks of the River Jämsä up to Jämsänkoski (founded in 1926, population 7525 in 2004).

Jämsä is nowadays noted for its modern pulp and paper industry and high-tech aviation industry. Jämsä and the surrounding countryside offer great opportunities for recreation and tourism, both in winter and summer. A network of hiking and skiing tracks is available for everyone to use. There are also marked routes for guided or unaccompanied canoeing, cycling, hiking and riding tours. The ski slopes at Himos Ski Centre are kept open until May Day.

Many of the stages in Neste Oil Rally Finland go through these towns' territories. On Leg 2 of the rally, they are in fact the focal point of the whole event with Remote Service Zone in Jämsä and most stages running in the area.

15.3.3 Other Cities and Municipalities

Notably the rally visits many other cities and municipalities in Central Finland. These include such familiar names as Keuruu, Konnevesi, Korpilahti, Kuhmoinen, Laukaa, Längelmäki, Multia, Muurame, Petäjävesi, Toivakka and Uurainen.
