1. INTRODUCTION – WELCOME

Dear guests, dear participants,

It is our pleasure to welcome you to the 10th round of the 2007 World Rally Championship, the ADAC Rallye Deutschland and we are happy to announce a few important changes for this year.

The single service park will be moved back to Messepark Trier which was for the last time used as one of the two service parks in 2002. We then spent four great years at the service park Bostalsee where we enjoyed an excellent support by the local government whom we wish to thank very much indeed.

The move of the service park back to Trier is associated with the organisation of a Super Special Stage around the UNESCO World Heritage Site of the Porta Nigra Trier, in the city centre of Germany's oldest town Trier. We are convinced that this new format of a Super Special, with four cars on the circuit at about 15 seconds' intervals, will be an exciting show both for spectators and drivers.

The main Media Centre, too, will come back to Trier and be accommodated in the Trier Arena, same location as in 2003. A subsidiary press room will be available inside the service park.

All these changes will give the ADAC Rallye Deutschland a now format of more compactness and finally all the main fields of organisation - rally headquarters, media centre and service park - will be more centralised and at short distances.

The layout of the itinerary finally has also been adapted to this new format. This year, all of the available special stages in the Mosel area will be used and not on a basis of rotation like in the past years. This means that Legs 1 and 3 will be based around Trier, whereas on Leg 2 the itinerary leads to two of the well-known special stages in the Saarland and of course to the military land of Baumholder, with a slightly modified itinerary to offer spectators even more excitement and show.

With the central location of the rally in Europe, ADAC, one of the greatest motorist associations worldwide, and the organising team are again expecting a huge number of spectators to attend our event and we will continue in developing our spectator management and our safety provisions both for spectators and drivers.

The rally has become an integral part of life in our region and also quite an important economic factor. We are also very happy about the great support which we receive by regional and supra-regional government and institutions. Without their help it would not be possible to organise such a huge event.

To stand still is to go backwards! So the ADAC Rallye Deutschland organisation will also carry on developing the training systems for our marshals and team leaders coming from all over Germany and from neighbouring countries. Detailed debriefings with all parties concerned and consideration of all comments received also helps in the improvement and advancement of our rally.

The ADAC and its partners invite you to attend the starting ceremony which will take place on 16th August 2007 at 8 p.m. in front of the magnificent scenery of the Porta Nigra in Trier.

We are looking forward to see you at the ADAC Rallye Deutschland 2007!

Cheques are not accepted. Any bank charges incurred must be paid by the entrants in addition to the entry fee. Please ensure that the entrant's name is included as reference on all bank transfers. It is compulsory to mention the account holder "FW GmbH" on your bank transfer documents.

No political, religious or social material. Publicity on tobacco is forbidden. This is a restriction self-imposed by the German tobacco industry.

There will be one service park during the 2007 ADAC Rallye Deutschland, located at Trier Messepark. The service park will be available for the teams from Monday, 13 August 2007, 7 a.m., or upon special agreement.

The teams may bring their auxiliary vehicles into the service park, as long as they can park them within their designated area. Otherwise these vehicles must be taken to the auxiliary parking adjacent to the service park. Any parking of team vehicles outside their designated service area in the service park is strictly prohibited!

Competitors wishing to use a joint service area with another competitor must inform the organiser until **Thursday, 19 July 2007,** at the latest. The organiser can however not guarantee that all requests can be considered.

5.2 FACILITES AT SERVICE PARK

5.4 ADDITIONAL CAR WASH POINT

A car wash point will be installed at Trier city entrance before the podium finish procedure (exact location is indicated in the Road-Book). One team member per competing car may be present at the car wash point area without being actively involved in the procedure (subject to confirmation in a Bulletin).

5.5 RECOVERY OF RETIRED CARS

Generally, all retired cars must be recovered by their team personnel.

The organiser has defined "access/meeting points" for each special stage where team personnel wishing to recover their car can gain access and/or be picked up by a special stage marshal to be escorted to the retired car. The definition of the most suitable meeting point and time will be agreed when asking the permission from the clerk of the course to transport the retired car to the Parc fermé (see Article 4.6.1 WRC Regulations !).

This procedure should help in getting the retired cars back to the Parc fermé / service park as quickly as possible. The clerk of the course has nominated Mr. Uwe Schmidt and Ms. Waltraud Wünsch to coordinate any such agreements, both will be in Rally Control. Phone contact: Will be given in a later Communication by the Clerk of the Course.

According to circumstances, individual arrangements such as transport of a retired car by the organiser can also be agreed.

The crews of non priority drivers should also liaise with the organiser to make arrangements about the recovery of their retired car.

The access/meeting points of each special stage with numbering system will be shown in Rally Guide 2.

5.6 PARC FERME FOR RETIRED CARS WISHING TO RE-START (subject to confirmation in the Supplementary Rally Regulations)

FIA Priority Drivers:

The retired vehicles of FIA priority drivers wishing to restart must be returned to the Parc Fermé/Regrouping Area Messepark Trier, same area as between TC "A" and TC "B". From this Parc fermé to the service park and vice-versa the car may be driven by an authorised representative of the team, respecting all the formalities of time card presentation and all other applicable regulations. All these cars will re-start the next Leg from TC 6F resp. 14F (Service IN) where they must report at their scheduled time, calculated from the published re-start time plus the target time of 10 minutes to Service IN.

Drivers without FIA Priority:

The retired vehicles of drivers without FIA priority must be returned to the overnight Parc Fermé Viehmarktplatz Trier in accordance with the deadline given in Article 4.6 of the 2007 WRC Sporting Regulations.

6. **RECONNAISSANCE**

6.1 **REGISTRATION**

Date and time: Monday, 13 August 2007, 14:00 – 20:00 at the Rally HQ Trier.

6.2 REGISTRATION PROCEDURE

Prior to reconnaissance, all crews must complete a recce registration form and collect a reconnaissance pass and a recce vehicle identification at the Rally Headquarter Trier (see above). The material will be given to the drivers personally or to a representative duly certified in writing at the Rally Secretariat.

The recce control card issued by the organiser must be submitted at each control post along the route for registration and be returned at the Rally HQ Trier of at the service park HQ (office truck) until Thursday, 16 August 2007, 10 a.m., at the latest. The identification numbers must be affixed to the upper side of the windscreen and of the rear window, in the centre, and be kept visible for the whole duration of the recce period.

6.3 SUMMARY OF SPECIFIC REGULATIONS AND INSTRUCTIONS FOR RECCE

Each driver must **not** cover each of the 10 different special stage **more than two** times, but **only in the same direction as the rally,** unless permitted to drive in opposite direction for very short sections as per Rally Guide 2. All Road Traffic Laws must be strictly observed and the safety and rights of other road users must be respected during reconnaissance. All crews must drive in a manner that does not endanger or inconvenience other traffic or people living near the stages. Competitors must bear in mind that the special stages are not yet closed to public or residential traffic during recce. Any offence will be reported to the Stewards.

For given reasons, all competitors are reminded of the following traffic laws applicable in Germany:

- Safety belts must always be worn.

- Right has right-of-way.

The instructions given in the Road-Books only for recce are to be respected, in particular when joining or crossing main roads.

A system for controlling the speed in reconnaissance by means of a GPS may be made compulsory.

All cars used for reconnaissance must comply with the prescriptions of Article 14.2 of the 2007 FIA World Rally Championship Regulations.

Any competitor wishing to test in Germany must advise the Organisers in advance and specify the names of the drivers who will be testing.

All infringements will be penalised in compliance with the FIA General Rally Prescriptions and the FIA World Rally Championship Regulations.

6.4 OTHER POINTS

- Intervention cars equipped with fire-fighting and recovery material will be on stand-by during recce. They can also provide assistance in case of medical problems and give first aid. Their positions and mobile phone numbers will be published in Rally Guide 2.
- A list of recommended, suitable service points during recce will also be published in Rally Guide 2.
- Fuel stations along the recce route will be marked on the recce maps issued with Rally Guide 2 and a summary will also be published in Rally Guide 2.

All FIA Priority drivers are required to use FIA fuel. The supplier appointed by the FIA for 2007 is SHELL.

Non-priority drivers may either use FIA fuel, following the same conditions and rules as the priority drivers, or may use commercially available pump fuel, dispensed **only from pumps**, at filling stations, nominated in the Road Book.
