8. **GENERAL OBLIGATIONS:**

8.1 CONTROL OF DRIVERS HELMETS AND EQUIPMENT.

These will be checked at scrutineering for compliance with safety standards.

8.2 SERVICE VEHICLES

Servicing of competing cars may only be carried out by service vehicles displaying the Event's service Decals as well as the Car number and only in service parks as designated in the road book. Refers SSR 193 (12)

Only 2 service vehicles plus the competing vehicle will be allowed into the service park.

RUNNING OF THE RALLY

9. **START:**

9.1 OFFICIAL TIME THROUGHOUT THE ENTIRE RALLY

Official time will be GPS Time and a master clock will be available at the administration Check - in.

9.2 Competitors to be at the start 5 minutes before their start time as per starting list.

(A) PENALTIES:

As per SSR'S 161 to 193.1 of the current MSA handbook. The penalty for arriving late in holding area at the start will be R500.

(B)

A PENALTY OF A R1000.00 WILL BE IMPOSED ON ANY CREW FOUND LITTERING OR LEAVING LITTER IN THE SERVICE PARKS. THE SERVICE PARKS WILL BE MONITORED AT ALL TIMES ARTICLE 13.1.5 OF THE ENVIRONMENTAL CODE IN THE CURRENT MSA HANDBOOK REFERS.

(C) IMPOSSIBLE TIMES:

The Clerk of the Course may at his sole discretion adjust any Special Stage time that is deemed to be impossible. The offending crew will be accorded a time 10 seconds per kilometer or part thereof slower than the fastest car in the same class.

14. MSA FLAG:

The MSA flag will be displayed in a prominent position throughout the event.

15. NOTES TO THE COMPETITORS:

- 15.1 You are reminded to enter timeously, failing which after 18h00 15th October the **LATE ENTRY FEE** will be charged, this also includes entries received without proof of payment.
- 15.2 Only one service panel will be supplied extras **MUST** be ordered beforehand.
- 15.3 Competitors are urged to ensure that they are familiar with the Current MSA Handbook non circuit racing pages 1 31.
- 15.4 Competitors are requested to complete the entry form in full before submitting in order to expedite the issuing of documentation at the Administrative checks.
- 15.5 Car 0 will run ahead of the field as a non scoring competitor.

16. SERVICE PARKS

Service parks will be operated as indicated in the road book and the Rally Itinerary. Penalty for late departure from Service Park will have a penalty imposed of 10 Seconds per minute for lateness to be added to the overall time. Exceeding 30minutes – exclusion

17. REFUELLING

Competitors may only refuel in the refuel zone designated by the Organisers in the Road book.

Their entry/exit shall be marked by a blue fuel can symbol.

Any action inside a refuelling zone not directly involved in the refuelling of the competing vehicle is prohibited.

In the refuelling zone a 5kph speed limit will apply.

The responsibility for refuelling is incumbent on the competitor alone.

Engines must be switched off throughout the refuelling operation.

It is recommended that the crew remains outside the car during refuelling; however, should they remain inside, the safety belts must be unfastened.

A car may be pushed out of the zone by the crew, officials and/or the two team members without incurring a penalty.

Solely for the purpose of assisting with the refuelling procedure on their car, two team members of each crew may access this zone.

Please note. When necessary as part of service (i.g. changing a fuel tank or pump), emptying and/or refilling is permitted in a service park provided that:

- 1) the work is carried out under supervision of a marshal.
- 2) no other work is carried out on the car during the emptying and/or refilling operation.
- 3) a suitable safety perimeter is established around the car.
- 4) two fire marshals are present with fire extinguishers suitable for use on flammable liquids.
- 5) Only sufficient fuel is added to reach the refuel zone.
