3.5 Refunds of the Entry fee

Entry fees will be refunded according MNASZ Prescriptions 2009.

4. INSURANCES

Compulsory car insurance for rally: **12 000,- HUF**

This sum must be paid at Administrative check to the MNASZ representative.

Only cars which are in compliance with Hungarian law can take part on rally, with active insurance covers civil liability (foreign competitors with active green card) and additional insurance for civil liability will conclude the organiser. This insurance will come into force from the start of the rally and will cease at the end of the rally or at the moment of the retirement or exclusion. Additional insurance for civil liability is established by contract No.: 190/2004 (VI.8) between MNASZ and OTP-Garancia Biztosító Rt. insurance company (contact is available on the MNASZ secretariat).

Insurance company will not stand the loss arised during the rally on rally car or property inside the car, for loss of the other competitors, co-drivers or passangers in rally cars on the closed routes or roads closed for traffic or loss on the road surface without crash of the car.

5. ADVERTISING AND IDENTIFICATION

According MNASZ 2009 Prescriptions, Chapter II, Art. 6.9.3.

Identification:

Competitors will get two rally plates according FIA Prescriptions (MNASZ Prescriptions Chapter I., Art. 15) during administrative check. These plates shall be affixed on the rally car according Appendix 4 of this Supplementary regulations and must rest on the car during whole rally. If it is found at any time during the rally that one rally plate is missing, a cash penalty 3000,- HUF will be imposed. In case, that both rally plates are missing, the crew will be excluded.

Competitors will get competing numbers (according Chapter I., Art. 15 of the FIA Prescriptions and Chapter II., Art. 6.9.2 of the MNASZ Prescriptions) during Administrative check. These numbers shall be affixed on the rally car during whole rally. If it is found at any time during the rally that one competing number is missing a cash penalty 4000,- Ft will be imposed. In case that two numbers are missing, the crew will be excluded.

8. RECONNAISSANCE

8.1 Procedure for registration

During Road book issuing, crews must fill-in registration form and submit it. Every crew will receive an identification sticker from organiser, which must be affixed in right upper part of the windscreen during reconnaissance at all times. Missing sticker will mean failure of the reconnaissance prescriptions. In the case, that sticker is damaged or in case of the recce car changing, the crew must ask organiser for new sticker. Competitors will also get identification card (A5 format) and they must submit 1-1 pc of photos. This card must be placed in the recce car during whole reconnaissance. The crew must show this card everytime on marshals demand.

Prologue: only 27. – 28.06, daily 18:00 – 20:00

Maximum of 4 passages of the SS at scheduled time are allowed to the competitors entered on rally.

Organiser will check the passage through the SS. Competitors are compulsory to stop at the control points and admit the recce time card (from Road book) to the marshals for record.

During recce is forbidden to leave the SS route and to u-turn on the SS route.

Only one person (except the driver) is permitted in the recce car during recce on the SS routes. Any infringement of these rules will be presented as infringement of the recce prescriptions.

Organiser will define time limits for reconnaissance of the SS, which can not be exceeded. Any excess of the time limits will be considered as infringement of the recce prescriptions. Time limits will be published during Road book issuing.

After the date of publication of the Supplementary Regulations, attendance on the any SS route will be considered as forbidden reconnaissance and as infringement of the recce prescriptions.

8.3 Specific / national prescriptions

8.3.1 Prescriptions for the recce vehicles

- series vehicles
- the exhaust shall be a series production exhaust with a maximum noise level within the permitted Hungarian noise level
- the safety rollbar is permitted in accordance with Art. 253.8.1 – 8.4 Appendix J of ISC
- 2 additional road-homologated headlamps are authorised
- the crew may use a "light" intercommunication system (without helmets)
- tyres restrictions – see Art. 8.5

8.3.2 Restriction of the direction and number of the passages

Passage through the SS is permitted only in the direction described in the Road book. Every infringement will be penalised by the organiser.

8.3.3 Throughout the reconnaissance the crews must observe Hungarian traffic rules and also every restrictions on the private roads.

SS routes during the recce are not closed for traffic and it is important to keep in mind, that roads will be used also by other participants – walkers, buses, forest and agro-cultural machines.

Reconnaissance schedule had to be follow.

Every infringement of the recce rules will be penalised from the cash penalty to the start refusal. The organiser will inform RSB (MNASZ) about penalisations. Maximum cash penalty is 250 000,- HUF.

Upon the information provided by the organiser Stewards can also decide about time penalty for the crew which infringed recce rules. In this case the cash penalty can will not be granted.

If the accident or loss of property occurred on the rally route or serious infringement of the traffic rules occurred during the reconnaissance, organiser is compulsory to refuse the start without refund of the entry fee and inform MNASZ about it.

RSB (MNASZ) can also monitor the performance of the recce rules and decide about penalties.

8.4 Speed checks

Organiser will check the speed during recce by Stalker PRO III. Kustom Pro Life radar (No.: 200-2072-00). In the case of the speeding, organiser will decide about cash penalties. Stewards according Organiser's report will decide about time penalties.

The maximum speed on the SS routes (where are no other traffic restrictions) is 70 km/h!

Fines for speeding:	up to 20 %	5 000,- HUF
	21– 35 %	40 000,- HUF
	36 – 50 %	80 000,- HUF
	51 % and more	start refusal

8.5 Tyres regulations during reconnaissance

Organiser permits using of the tyres as follows:
 - using of winter or M+S marked tires is forbidden

- using of gravel tires is forbidden (using of tyre marked with „E” or if they are worn-out is also forbidden)
- cutted slick, intermedia or wet tyres are permitted.

11. RUNNING OF THE RALLY

Official time during rally - Magyar Rádó Kossuth (AM 540)

11.1 Ceremonial start, start of the rally

11.1.1 Ceremonial start: Veszprém, Óváros tér Square, 03.07.2009 from 19:23
in the opposite start order, in 1-minute interval

Arrival to the ceremonial start (podium) is along the route described in the Road book.

Early check-in or lateness will be penalised by the time penalty.

Competitors are compulsory to wear overalls !

11.1.2 Competing numbers will be allocated in following order:

1. group – drivers FIA A Priority
2. group – drivers FIA B Priority
3. group – drivers with ASN Priority and with gold licences
4. group – other competitors
5. group – competitors of group H

11.2 Changing of the time cards during the rally

Organiser will issue the time cards for both days during the Administrative check. Time cards will be collected in the TC regrouping/IN and in the Day's last TC (Park fermé IN).

According to MNASZ 2009 Prescriptions there will be 1 page in every time card section book for remarks of the Scrutineers.

11.3 Starting system of the special stage

The crew are compulsory under the penalty of the exclusion to have safety equipments during SS (from the start to the STOP) according to FIA and national prescriptions (Appendix 5, Art.17). The crew must be prepared for start in the moment of arrival to the start line.

SS starts will be given by an electronic countdown system. Timekeepers will notify 30s, 15s and 10s and then show on digital starting equipment. The starting procedure continues according to time on the start equipment and according to red and green lights.

Green light means the moment of the start. Photocell will record any start made before the signal has been given.

Starting interval during the rally will be 2 minutes, except Prologue and SuperSS.

11.4 Early check-in at the end of the Day

Early check-in is allowed to the TC 2E (Day 1) and TC 8E (Day 2).

11.5 Identification of the officials

Officials will wear passes with their names and duties and will be identified as follows:

Control Chiefs:	red tabbards
Marshals:	white tabards
Safety Officers:	yellow tabards

11.6 Prologue and Super SS

11.6.1 Running of the Prologue

Prologue will be running on 03.07.2009 from 15:00 in Kiralyszentistván next to the road No. 7216. Prologue is a regular part of the event and its results will count for the rally classification. Drawing of the Prologue route will be published in the Road book. Two rally cars will start together. They will drive on different routes first half of the round after the start and then they will change them. Every crew is compulsory to drive 2 complete rounds (one round means, that car returns to the same place as it started).

Crews will start in pairs in reverse order – from the highest competing number.

Reconnaissance of the Prologue will be 27. – 28.06.2009 from 18:00 till 20:00.

11.6.2 Running of the Super SS

Immediately after the Prologue (03.07.2009) will start the Super SS, which is also a regular part of the event and its results will count for the rally classification. Drawing of the Super SS route will be published in the Road book and it is the same as the route of the Prologue!

After the finish of the Prologue competitors drive again their start positions for Super SS. These positions will be on the other side as start positions of the Prologue (who started from the left side will now starts from the right side and vice-versa). Two rally cars will start together on the Super SS. They will drive on different routes first half of the round after the start and then they will change them. Every crew is compulsory to drive 2 complete rounds!

Crews will start in pairs in reverse order – from the highest competing number.

There is no possibility for reconnaissance of the Super SS.

11.7 Special regulations

11.7.1 Traffic

Competitors are compulsory to follow Hungarian traffic rules during the whole rally. Infringements will be penalised:

- first traffic infringement: a fine (maximum 20 000,- HUF)
- second traffic infringement: a 5 minute time penalty
- third traffic infringement: exclusion

Clerk of the Course can apply also higher penalties as described above.

11.7.2 Rules for the case of incident

If a crew is involved in an accident in which a member of the public sustains physical injury, the driver or co-driver concerned must report this to the next radio point as specified in the road book and signed on the route.

If the accident happened on the place with spectators, the driver is compulsory immediately stop and be sure if anybody was not injured or if anybody get into the risk. If so, drivers are compulsory to help.

In the case, that any person obtain injury, the nearest marshal and SS Chief must be informed.

The crew may leave the place of the accident only with Police approval.

Any infringement of this regulations will be penalised by The Stewards, penalty may go as far as exclusion. The laws of the country in which the event is run must also be complied with in relation to procedures at accidents

11.7.3 Service parks

Place: 1. Day: Jutapuszta
2. Day: Jutapuszta

Time for entry of the service cars: 1. Day: 03.07.2009 06:00 – 14:00
2. Day: 04.07.2009 06:00 – 08:00

Service cars, which entered the service park, can leave it anytime, but re-entry is forbidden.

Service cars may stay in the service park during the night. Organiser will establish the patrol, but organiser do not have any responsibility for the values left in the cars.

Other regulations for the service park

FIA Prescriptions are valid for service park.

Service park is defined in the Road Book. There are any repairs allowed in it.

Time controls will be established for rally cars on the entrant and exit from the service park.

Except the rally car only one service car (marked with „service“ plate) can entry into the service park (2 service cars for gold licences holders).

In the case that service car without service plate or with illegal service plate enters to the service park relevant competitor will be penalised by the Stewards by fine of maximum of 50 000,- HUF. In the case that service car enters the service park out of defined times, Stewards will penalised relevant competitor by fine of 10 000,- HUF.

All team members are compulsory to respect rally prescriptions and marshals directions. Competitor is responsible for all team members during the whole rally.

Service cars are not official participants of the rally although they have service plate. The event insurance is not valid for them.

In the whole service park area:

- **Car washing is strictly forbidden due to the enviromental reasons!**
- **It is compulsory to put the sheet with dimensions 5 x 3 m, which is impermeable for petrol and oils under the rally car during the repairs.**
- **Minimum of 150 l bag for waste is compulsory in each team´s service.**
- **Minimum of 5-kg fire extinguisher must be placed visibly and easily available for team members. Judges of the facts will check observance of these regulations. Every infridgements will be penalised by the Stewards.**
- **Catering is permitted in the team service places but open fire is strongly forbidden.**
- **Organiser will establish the refuelling zone behind service park (behind TC Regrouping OUT). Refuelling of the rally cars in the refueling zone can be realised exclusively by using of the canned refuelling equipment!**
- **Competitor himself is responsible for the refuelling.**
- **Organiser will establish the tyres marking zone in the service park behind the refuelling zone.**
- **Maximum speed in the service park is 30 kms/h and 5 kms/h in refuelling zone. Speeding will be penalised by the Stewards.**
- **Auxiliary „segítő“ and Team Chef „csapat vezető“ cars are not allowed to enter the service park. Organiser will establish the parking area for them beside the service park.**

Presriptions for Auxiliary „segítő“ cars

It is possible to buy Auxiliary „segítő“ plates during Administrative check (10 000,- HUF / pc).

Auxiliary „segítő“ cars may enter the park area, which will be established next to the service park or to park areas near by SS at the road closing places.

Auxiliary „segítő“ cars may enter service park on Friday 03.07.2009 (06:00 – 14:00) and Saturday 04.07.2009 (06:00 – 08:00). **They may not be inside the service park in other time!** Any infringement of this prescriptions will be penalised by the Stewards with fine of maximum of 300 000,- HUF.

Service park, prescriptions for service

Only relevant cars are eligible to enter the places reserved for the gold licence holders. It is forbidden for service cars and trailers to enter the places and roads in front of the Administrative checks and Scrutineering areas. Any infringement of this prescriptions will be penalised by fine of maximum of 100 000,- HUF.

All service activities are strictly forbidden during 03. - 04.07.2009 on public areas. Observance of this rule will be checked by organiser in co-operation with Police and local authorities. Any infringement of this prescriptions will be penalised by the Stewards according Art. 152 and 153 FIA ISC.

Service cars (with „service“ plate) can, within the service park area, stay in places assigned for the relevant competition numbers.

Any commercial activities are strictly forbidden in the restricted service areas! Promotional, sales and/or advertising cars are eligible to enter the restricted areas only with approval of the organiser.

Promotional actions of the competing teams in their service places are allowed without fee. Other commercial activities, entry of others cars and larger places in service park are possible only after commercial agreement with the organiser.

12. TEAMS´ SAFETY CARS

Teams´ safety cars are forbidden.

14. FINAL CONTROL AND PROTESTS

14.1 Final control

Place: Automodern Kft., Veszprém, Házgyári Street 24/1

Only following persons can take part on the final control:

- representative of the competitor – he must show the competitors´ licence or authorisation
- particular crew
- maximum 2 mechanics

If the crew is not able to prove datas about parts in the homologation form after finish of the final control, the dismantling of the car must follow and Steward will decide about cash penalty 10 000,- HUF. Result of the infringement of this rule will be exclusion.

14.2 Protest fees

Technical protest fee 150 000,- HUF.

Protest fee (general) 100 000,- HUF.

In the case of the technical protest, if the protest requires the dismantling and the re-assembly of different parts of car, the claimant must pay an additional deposit according the decision of the Stewards.

Deposit must be paid by the claimant. Protest will be refused if the deposit is not be paid.

The expenses incurred in the work and in the transport of the car shall be borne by the claimant if the protest is unfounded, or by the competitor against whom the protest is lodged if it is upheld.

If the protest is unfounded, and if the expenses incurred by the protest (scrutineering, transport, etc.) are higher than the amount of the deposit, the difference shall be borne by the claimant. Conversely, if the expenses are less, the difference shall be returned.

In the case of the technical protest these persons can take part on the final control:

- persons who perform the control,
- Clerk of the Course,
- Stewards,
- Scrutineer,
- Competitor against whom the protest is lodged and his mechanics,
- Representative of the competitor against whom the protest is lodged (must show the competitors' licence or authorisation)

14.3 Appeal fees:

Sum for a national appeal fee is 100 000,- HUF.

Sum for secondary appeal fee is 250 000,- HUF.

15. OTHER REGULATIONS

15.1 Procedure in the case of the accident

If the accident happened on the place with spectators, the driver is compulsory to stop immediately and assure himself if anybody was not injured or if anybody get not into the risk. If so, the crew is compulsory to help.

In the case, that any person obtain injury, the nearest marshal and SS Chief must be informed.

In this case the crew may leave the place of the accident only with Police approval.

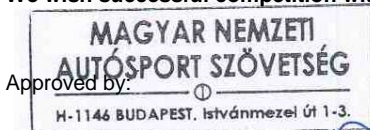
Any infringement of this regulations will be penalised by the Stewards and penalty may go as far as exclusion.

Requirements in the case of accident, safety requirements

- 1) All participants must thoroughly know Art. 37 of the FIA Prescriptions.
- 2) When a red "SOS" sign is displayed, crews are mandatory to stop immediately to render assistance. Crews are compulsory to help to injured persons and make sure that safety services are mobilised as soon as possible.
- 3) The first competing car which arrives at the scene of an accident must stop and inform next car about all the details.
- 4) Next car must take the following information to next radio point (it can be also SS finish) and submit there following information:
 - competing number of the involved crew

- number of injured persons – members of crew or spectators and sort of their injury
 - if any crew member or spectator is trapped in or outside the car
 - location of the accident, i.e. the closest road book junction or kilometre post
 - any other vital information, i.e. fire, water ..
- 5) The following cars must stop if the red "SOS" is displayed.
 - 6) All competitors stopped in the SS must place their red triangle at least 50 m before where the car is stopped even if the car is clear of the road.
 - 7) Organiser First aid: +36 30 896 5785
 - 8) In the case of the retirement, the crew must report it to:
 - organiser: +36 30 579 2313
 - competitors' relations officer: +36 30 944 2323
 - 9) Competitors, who retired from the rally are compulsory submit their time cards in the next TC as soon as possible.
- 15.2 Organiser forbid to the crews to perform doughnuts with car after the finish and in the Park fermé area!
 - 15.3 Organiser allow to buy Road books in addition by competitors. The price is 5 000,- Ft (including tax). This price must be send together with the entry fee.
 - 15.4 Chief of the teams (according „Chief team pass“ or competitor licence) could assume „Csapatvezető“ table during administrative check. Everybody must show his/her pass or licence. Entry to the TC and SS controls is allowed only with this table. This table must be affixed in right upper part of the windscreen. Organiser will reserve restricted area in the service park for these cars.
 - 15.5 Organiser permitt to use leaflets on the rally car's windows during the whole rally. Silver or color leaflets are allowed on the side, rear and roof windows if there are sights in that leaflets so the drivers and car interior are visible.
 - 15.6 Damages on the rally cars caused by the impact of wild animals are exluded according Civil Code from 1959 year, No.: 345.
 - 15.7 Organisers of the BFGoodrich-Veszprém Rallye '2009 retain the right for edition of various publications (printed or electronic). Any publication can be made without written permission from Laroco Kft.
 - 15.8 Laroco Kft. Owns all property rights (commercial, hostessy, advertising, etc.) on BFGoodrich-Veszprém Rallye '2009 and makes decisions about their utilizations.
 - 15.9 Media acreditations will be run according MNASZ rules during BFGoodrich-Veszprém Rallye '2009.
 - 15.10 Organiser of the BFGoodrich-Veszprém Rallye '2009 informs by this way, that he is not responsible for any claims which occur to the participants of the rallye. Everybody is responsible for himself.

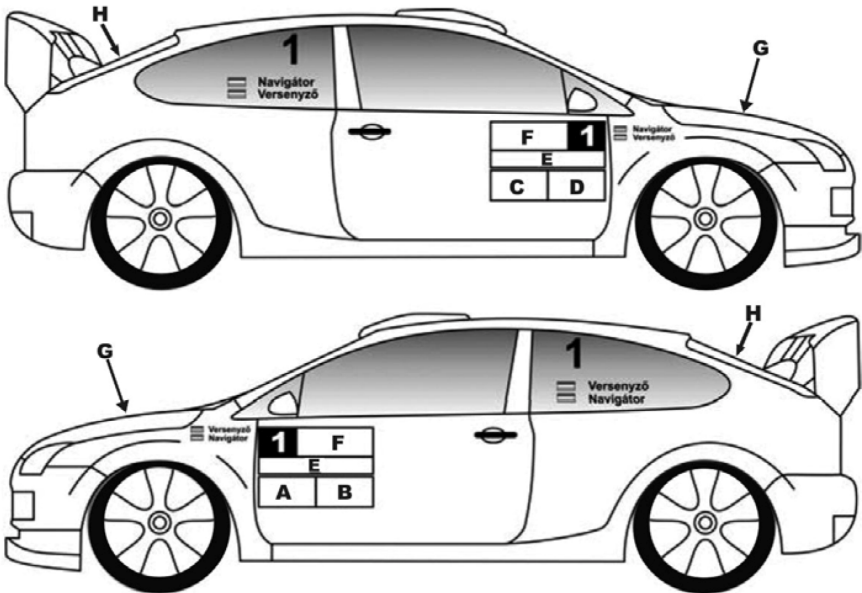
