# 4. Entries

#### 4.1 Closing date for entries

Date: 29.5.2010 Time: 24:00

#### 4.2 Entry procedure

**4.2.1** The entry forms must be sent to the address specified in art. 2.3 SR before the closing date. The decisive feature is the stamp of the post office or time data provided by the fax or e-mail. In case of a electronic registration, the original copy must be delivered to the organiser in maximally one week after the closing. Details on co-drivers may be added up to the moment of administrative check start.

**4.2.2** The application will be accepted only in case of enclosing a copy of the document of payment for the whole sum of the deposit. Any later payment is possible only on the basis of an agreement with the organiser and it always means the deposit increase in 25%.

Foreign participants must prove contents of their ASN (art. 70 ISC).

#### 4.3 Number of entrants accepted and classes

**4.3.1** Maximal number of entrants: 120

**4.3.2** Participation in rally is allowed only to cars complying with regulations of Appendix J ISC FIA and Technical Regulations of national sporting relegations (see art. 11.3 up to11.6 ZU).

# Additional provision:

- Use of head retaining system approved by FIA is obligatory for all the drivers and co-drivers.
- Cars of the R group will be included in classes of the group A and N according to art. 4.2 FIA Regional Regulations.
- Cars homologation as "Kit car", with volumes from 1400 to 1600 cm<sup>3</sup> can be accepted if they also comply with article 255.6.2 "Weights" of the Appendix J.
- Cars with two driven wheels and forced induction engine Diesel, with nominal volume not exceeding 2000 cm<sup>3</sup> are allowed in group A and in group N.
- For cars approved as S 1600 may be expired errata used without any penalisation.

# 4.6 Refunds

- 4.6.1 Full fee will be refunded:
- to candidates whose entry has not been accepted
- in case of the rally not taking place
- to competitors who cancelled their entries before the final date for submitting entries

**4.6.2** Part fee will be refunded:

- organiser will refund 80 % of the entry fee to them who excused till start of reconnaissance
- organiser will refund 50 % of the entry fee to them who excused till start of administrative check.

# 5. Insurance

# 5.1 Insurance coverage of the organiser

The Autoklub CR concluded with Česká podnikatelská pojišťovna, a. s., Vienna Insurance Group, through the company RENOMIA, a. s., the frame insurance contract No. 00 1394 3081 on insurance of liability of the organiser for damage caused to the others in connection with a sport enterprise up to the sum of CZK 5.000.000 with co-participation in the sum of CZK 10.000.

# 5.2 Insurance of competitors and crews

**5.2.1** The frame insurance contract No. 00 1394 3081 concluded by and between the Česká podnikatelská pojišťovna a. s. – Vienna Insurance Group and Autoklub CR includes insurance of cars of the participants against damages caused to third persons up to the sum of CZK 5.000.000 per one insurance event with coparticipation of CZK 10.000. Any damage below CZK 10.000 will be paid by the driver who caused the damage; damages above CZK 10.000 will be paid by the insurance company without any co-participation of the insured.

However the insurance does not cover liability for the damages caused by event participant that the competitors cause each other in the course of sport event.

The organiser undertakes to arrange such insurance for all the participants, except for those who will prove at the administrative take over that they concluded their liability insurance through the company All Risk with Česká pojišťovna.

5.2.2 At the moment of administrative take over all the crews must present valid international green card of the car. The crew will not be allowed to start without that document.

5.2.3 Each driver and co-driver is obliged to conclude his/her personal injury insurance and to present a proof on request the administrative checking. The insurance of foreign crews must include coverage of costs for possible medical treatment in the CR.

#### 5.3 Damage Announcement

By the end of the competition at the latest, the crews are obliged to announce the organizer any damage caused by their cars on the route of the rally. Non-fulfilment of this obligation means invitation of the competitor and relevant crew to the disciplinary committee.

#### 5.4 Exclusion from Insurance Coverage

Service cars, cars for introduction rides and other cars marked with special tables are not covered by the insurance of the rally (with the exception of insured organisation cars).

#### 6.3 Starting numbers

Specified marking supplied by the organiser (including advertisings) must be fixed to the cars before the Scrutineering.

#### 6.4 Missing advertising or marking

6.4.1 In case of missing or intentionally changed or replaced any part of an advertising supplied by the organiser (art. 6.1, 6.2 SR), the Clerk of the Course will charge to the crew a financial penalty in the sum proportional to the sum of the entry fee, at least 20% of the entry fee.

6.4.2 If it is established that there is missing on the car:

- one starting number or front table the Clerk of the Course will charge a financial penalty to the crew in the sum of CZK 3.000
- both starting numbers on front doors the crew will be reported to the Stewards
- name of the driver and/or co-driver the Clerk of the Course will charge a financial penalty to the crew in the sum of CZK 1.000.

#### 7. Tyres

7.1 At all times during the event in the Czech Republic, the tread depth of the tyres fitted on the car must not be less than 1,6 mm. Only tyres in conformity with Appendix IV of the FIA Regional regulations must be used.

7.2 For introduction rides there must be used the tyres approved for public operation (see art. 7.1).

7.3 Measuring of tyres temperature in the area of 100 m behind the STOP area is not considered to be external help if it is performed by authorised representatives of tyre-producing companies registered by the organiser.

7.4 Failure to observe the tyre regulations will be reported to the Stewards.

# 8. Fuel

Only unleaded fuel is allowed with a maximum lead amount of 0.013 g/l.

#### 9. Reconnaissance

#### 9.1 Procedure for registration

When taking over the itinerary each crew announces the organiser the make, type and registration number of the car they will use for the reconnaissance. The crew receives an identification sign for the car that must be stuck in the right-hand upper corner of the reconnaissance car windscreen. After expiration of that term it must be removed from the car. The cars for reconnaissance must be insured in compliance with requirements of law.

Any change of the announced car must be reported by the crew to the Clerk of the Course in advance (mobile 776 866 809).

The crew will hand over the list of reconnaissance in the course of the administrative checking.

#### 9.2 National restrictions

- 9.2.1 The program of Reconnaissance is stated in Appendix No. II to this SR. The crews are obliged to follow all the stipulations of Regional regulations FIA and these SR referring reconnaissance. There must be used exclusively the cars specified in art. 22.1 of the Regional Regulations FIA.
- 9.2.2 For the period before the competition there applies the art. 2.12 of Regional regulation FIA. The organisation committee will refuse the registration of crews performing the introduction rides before the closing of registrations. The Clerk of the Course will refuse the start of crews performing the introduction rides after the closing of registrations, but out of official time - the entry fee will not be refunded to such crews.

- **9.2.3** In the period of 4 week before the start of the competition, all and any rides of the competition or any other cars of the team are prohibited on the route of the SS (except for the reconnaissance car at the time of reconnaissance). Any non-compliance shall be brought to the attention of the stewards.
- **9.2.4** There are allowed <u>maximally 3 passes through the same SS</u>. Driving in opposite direction of the SS is prohibited, except for sections marked in Appendix No.II SR.
- **9.2.5** The course of introduction drives will be checked by the commissars at the start and at each Stop point of each SS. Their points will be marked with standard panels with red base of the mark. Other checks may be also within the SS. The crews are obliged to stop at the panels, to present a report for confirmation and to follow the instructions of Marshals. The Clerk of the Course authorised the following Judges of the fact to perform random control of reconnaissance: Petr Vlašín, Zdeněk Vrátníček, Milan Chalupa.
- **9.2.6** Non-following of traffic regulations, <u>mainly speeding</u>, will be controlled and punished by the Police of the CR in a standard way. This does not exclude further sanctions from the side of the organiser see art. 17.2 of the Regional regulations of FIA.
- **9.2.7** The competitor who will breach stipulations of the Regional regulations of FIA or SR during the reconnaissance may be charged by the Clerk of the Course with a fine up to the sum of 5000 CZK. In serious cases, the offenders will be reported to stewards.

# **10. Administrative Checks**

# 10.1 Documents to be presented

Within the administrative checking the crews shall produce:

- confirmations (technical card) of their entries
- licences of drivers and the competitor, approval for start from ASN (only foreign crews), health cards of the driver and co-driver (only competitors from the CR)
- driving licences of the driver and co-driver, passports or identity cards of the driver and co-driver, documents related to personal injury insurance of the crew
- registration documents of the car, green card
- the card of reconnaissance

# 11. Scrutineering, Sealing and Marking

# 11.1 Place and time schedule:

Date: 11.6.2010

- Time: from 08:30 to 12:00
- Place: Hustopeče, premises of Agrotec a. s., Brněnská 74
- **11.1.1** The exact time of scrutineering of each individual car will be stated in the registration confirmation (in the technical card). The registered car may be supplied for scrutineering by the team representative.
- **11.1.2** The arrival will be checked by the time control placed at the entry to the premises in front of the scrutineering location. In case of a delayed arrival to that control, the Clerk of the Course will charge to the crew a fine of CZK 1.000 for each completed 5 minutes of delay. In case of a delay exceeding 30 minutes, the crew will be reported to stewards.
- **11.1.3** Operations according to art. 11.6.4. SR will be performed in the outdoor area in front of the entry to the scrutineering premises.

# **11.2 Documents for control**

At the moment of scrutineering, each competitor will present:

- homologation certificate for the car, car passport of the car
- technical card and filled in cards of safety equipment of the driver and co-driver
- other documents required by technical regulations

#### 11.3 Tinted window

On the basis of art. 253.11 Appendix J ISC FIA it is allowed to use smoke or silver-covered foils on side windows, rear window and on the opening roof glass under condition that the transparency of the foil allows view of the driver and the car interior from the outside.

#### 11.4 Safety equipment of drivers

Each competitor must present a complete dress he/she is going to use including helmets and the HANS system and filled in forms of safety equipment. There will be checked compliance with chapter III of the Appendix L ISC.

#### **11.5 National regulations**

All the competition cars must comply with act No. 56/2001 Coll. with appropriate exceptions for sport cars.

#### 11.5.1 Noise levels of cars

All the cars must be equipped with an appropriate stable exhaust damper. The external noise level – measured by the static method – is not allowed to exceed 96 dB (A) for group N and A with allowed tolerance of +2 dB for the measuring mistake. The measurement is taken at 3500 rpm for petrol engines and 2500 rpm for diesel engines according to regulation EHK 51.02. The noise measurement will be taken within the scrutineering and possibly also during the rally. Exceeding the noise limit within the scrutineering is punished by withdrawing the start approval. Exceeding the noise limit within measurements taken during the rally will be reported to the stewards.

#### 11.5.2 Catalytic converters

All the cars must be obligatorily equipped with an efficient approved catalytic converter meeting the following criteria:

- 40% reduction of CO content in the exhaust fumes in the catalytic converter
- maximally 2% of CO in the exhaust fumes at the end of exhaust pipe.

In case of missing or incomplete catalytic converter in the course of the takeover, the crew will be refused to start. In case of missing or incomplete catalytic converter to be established in the course of the rally, it will be reported to Stewards.

#### 11.5.3 Car lighting

It is forbidden to drive with additional searchlights without homologation E switched on in the connecting sections.

Non-compliance established by the judges in fact will be reported to stewards.

#### 11.6 Obligatory monitoring device ONI<sup>®</sup>.

11.6.1 Details are specified in Appendix No.IV thereof.

**11.6.2** Each car in the competition must be equipped with functional holder of the monitoring unit, including two antennas, control elements and accessories.

**11.6.3** The competitors will receive the holders from administrator of ONI<sup>®</sup> devices well in advance of the event start and they must install them in their cars in compliance with the installation manual before the scrutineering.

**11.6.4** At the moment of takeover, the device administrator checks the holder assemblage, and equips the device with the monitoring unit and tests the monitoring system.

**11.6.5** Competition cars not equipped with the monitoring device ONI<sup>®</sup> will not be allowed to start.

# 12. Other procedures

#### 12.1 Starting order

12.1.1 Order at the rally start: priority drivers of FIA, priority drivers of ASN, other drivers

#### 12.1.2 Start to the Rally

The crews with cars will arrive in compliance with the itinerary and in time, set in the starting list directly to the start ramp (11. 6. 2010, according to published starting times, Hustopeče, Dukelské náměstí).

The start to the rally will be performed using a flag on the starting ramp as follows:

• 5 seconds before the start, the flag man lifts to horizontal position and lifts it up at the moment of start. **12.1.3** <u>Re-Start after retirement</u>

The competition car that does not finish the Day 1 of the rally may start for the next Day. For the new start it is necessary to meet conditions of art. 41.4 of Regional regulations of FIA.

Scrutineering after any repair will be held in the PF before start to Day 2 on 12.6.2010 at 7:00.

#### 12.1.4 Procedure of the Start to SS

Start will be performed using the electronic digital starting clock connected with a photo-cell for detection of jump start. The start is fixed and the car must be placed there in such a way so as its front part is on the starting line level.

In the course of the last minute before start, the crew is obliged to switch the ONI<sup>®</sup> (GPS) system to SS mode. The timekeeper returns the time card to the crew in the starting procedure minute and reminds of switching ONI<sup>®</sup> (GPS) to the SS mode.

#### Procedure of the start marshal:

- there will be used light signalling with current digital time count down
- 39 seconds the red light switches on
- 30 seconds the starting man points at the starting lock
- 15 seconds the red light switches on
- 10 seconds the red light blinks
- 5 seconds the yellow light switches on
- START the green light switches on,
- 20 seconds the green light switches off and the red light switches on and there will be applied art. 33.4.3 Regional Regulations FIA – exclusion and putting aside the car

#### 12.2 Finish procedure

The competition route finishes in TC at the entry to the parking plot in front of the finish ramp. The podium will be prepared for the first three crews in general classification. The other prizes according to art. 14.2 will be handed on the ramp. Immediately after the ceremonial, the crews are obliged to leave for the finish PF.

### 12.3 Preliminary arrival to the finish of the stage / rally

Early arrival to the finish of Day 1 (TC 8C) is allowed.

Early arrival to the finish of the rally (TC14C) is allowed.


#### 12.4 Retarders

Retarders will be installed on the track due to safety reasons. Judges of the fact will be published on the official notice board.

Incorrect retarders passing will be penalised by the Clerk of the Course as follow: - 5 seconds

- moving of 1 part of retarder
  - moving of more parts of retarder
- overturn or breaking of parts of retarder
- 10 seconds - 30 seconds
- not passing thought retarder
- 1 minute

#### 12.5 Service car park organisation

- **12.5.1** The service parking lot will be open from 10.6.2010 16:00 to 12.6.2010 19:00.
- 12.5.2 An area of 100 m<sup>2</sup> will be reserved for priority drivers of FIA and ASN, an area of 80 m<sup>2</sup> will be reserved for the other crews. The crews will be informed about the assigned place at the moment of the itinerary release. Special requirements - for example referring location - must be supplied to organisers in written form before the registrations closing.
- 12.5.3 The entry to the service car park is allowed only to one service car with appropriately fixed marking "SERVIS" and one car with the marking "DOPROVOD". For maximally two other team cars, the competitors may purchase other marking during the administrative take over for CZK 500. Such marking authorises for parking in a reserved spot in the vicinity of the service car park.

#### 12.5.4 Service regulations

Maximal speed of 30 km/hour is set for the whole service premises.

The crew will pay a deposit in the sum of CZK 1,000 for cleaning services - it will be paid in cash during the takeover. The sum will be reimbursed at the rally office based on presentation of a confirmation on cleaning of the spot (it will be issued by the SA chief)

The plan of arrival and departure of service cars to/from the premises will be published on web sites of the organiser.

**12.5.5** In case of breach of conditions for the service parking lot, the Clerk of the Course will charge the competitor with fine of CZK 5.000. Any serious offences will be reported to Stewards.

# **APPENDIX No. IV**

# UNIFIED MONITORING SYSTEM ONI®

#### 1. General Stipulations

All the competing cars must be obligatorily equipped with the monitoring system ONI<sup>®</sup>.

The monitoring device ONI<sup>®</sup> is the property of the Autoklub CR and it is lent to competing participants free of charge. The return is guaranteed by the driver's licence that is taken over by the device administrator at the moment of providing the monitoring unit and he returns it after the unit return. Any possible destruction, non-returning or damage of the device, the competitor must pay to the administrator the price according to approved price list, otherwise the license will not be returned to him.

#### 2. Distribution of the ONI® Device

1.1 The monitoring system ONI<sup>®</sup> requires for the complete holder of the monitoring device to be fixed to the monitored car before the take over. The holder consists of the following parts:

• holder of the monitoring unit with cables and assemblage accessories

- 2 antennas (roof and indoor)
  - control elements:
  - ST / transfer switch
  - push button for alarm cancelling / calling for help
  - indication LED diode

The above stated parts will be supplied by the administrator of the ONI<sup>®</sup> device to all the stable participants of the rally in the CR for permanent installation in cars.

Foreign participants and other rarely participating cars will be provided with the complete holder just before the event and the device will be adjusted to a single use within the rally. Information will be received during presentation.

After arrival to the area in front of the technical take over, the device administrator checks the holder assembly, provides the monitoring unit and makes a test of the monitoring system.

In the end of the rally or in case of preliminary finishing of the rally, the participant must return the monitoring units (or the complete monitoring device according to article 2.3) to the device administrator in compliance with art. 1.3. handover of units is usually performed at the service park lot in front of the rally post.

#### 3. Installation of complete holder in the car

3.1 When assembling the holder of the monitoring unit, the roof and indoor antennas and individual control elements, the competitor must proceed in strict compliance with Instruction manual of the manufacturer (NAM system, a.s.) and to keep the device permanently in good conditions and to protect it from any damage or pollution (mainly the connecting connectors).

3.2 For foreign and one-off participants of the rally (art. 2.3): the adjusted device will be equipped with magnetic roof antenna and control elements placed in one common box. The competitor must select a suitable location for the control box, accessible for to members of the team and to prepare a possibility for fixation.

#### 4. Unit servicing during the rally

While servicing the unit, the teams are obliged to follow all and any instructions, specified in the User Manual issued by the manufacturer (NAM system, a.s.).

Procedure in the course of the rally (after the unit installation):

Before take off set the switch to position "Přejezd / Transfer"

At the beginning of a ST switch to position "RZ"

At STOP location return the switch to position "Přejezd / Transfer"

Procedure for individual events at ST:

All the functions are possible only when the switch is set to the "RZ" position.

- <u>Accident</u> (crash detection)
  - The alarm develops immediately, a siren hoots in the car
  - If no help is needed, the alarm and siren can be cancelled by short push of the button (1sec)
  - Non-cancellation of the alarm is considered to be a call for help

- <u>Unplanned stop</u> (above 30 sec) - The siren starts to hoot after 30 sec.
- If no help is needed, the alarm and siren can be cancelled by short push of the button (1sec)
- Non-cancellation of the alarm is considered to be a call for help
  - Calling for help
- In cases when any immediate help is needed at the ST (e.g. in case of any risk for health, impossibility to pass the track, etc.)

You can call for help by long push of the button (3 sec) – call ending will be simultaneously confirmed by siren hooting

Warning: non-cancelling the alarm is considered to be a request for help!!!

#### Drive and its termination


In the course of your drive, red LED diode permanently lights (except for locations with no signal). After two minutes of stopping, the drive mode finishes (LED goes off) and it automatically switches on after the drive re-start.
